**7. WEATHER FORECAST FOR OPERATIONAL PERIOD**  
Warmer and drier conditions can be expected through the operational period. Typical diurnal winds can be expected across the valleys, while ridge top winds remain generally northwesterly.

**8. GENERAL SAFETY MESSAGE**  
Fatigue may compromise safety. Be on the lookout for signs of fatigue and take mitigation measures. Lookout for topography driven fire conditions, loose rocks and boulders. Watch for snags.



## OUTPUTS

### FIRE BEHAVIOR

#### GENERAL

The fire continues to consume timber understory with some isolated tree torching. Rollout and slope reversal still continue to cause active runs and may challenge control lines. The fire area has no fire history in the last 50 years and no known thinning or fuel modification. Nighttime firing operations have been successfully consuming fuel under high relative humidity. Larger diameter fuels are contributing to increased fire spread and intensity in all fuel types. Clear skies will allow the **Thermal Belt** to re-form and cause the fire to remain active through the night.

#### SPECIFIC

##### Branch I

Torching trees will send broadcast embers up to **1/3** of a mile. The fire has been relatively quiet but with warmer temperatures and lower RH we can prepare for increased activity toward the afternoon hours when the solar radiation will heat fuels.

##### Branch II

As the fire progresses north, fuels get heavier in taller timber. Rolling material and slope reversal continued to aid in moderate runs that may compromise crews and control lines. Look for the rates of spread up to **14 ch/h** and flame lengths up to **9 ft** in timber and litter fuels. Spotting from torching trees could send embers out to **1/3 of mile**. Crews working on indirect line need keep a lookout toward the main fire to ensure they have enough reaction time to travel to safety zone. Any night firing operations can expect max relative humidity up to 75% between 2300 and 0400 this may not allow for complete consumption and potential for re-burn will be possible.

##### Branch IV

Established spot fires on the east side of the Eel River they may push toward crews working on indirect line on Division P,W and Y. The entire branch has west aspects that will heat up the fuels after 1400 hours. Rates of spread can be up to **14ch/h** and have **9 ft** flame lengths in timber and litter fuels. The fire has mostly been burning in a timber understory but there is a moderate amount of brush in Branch IV. An active run in the brush fields with an upslope wind of 15 mph could spread at over **1 mph** (Dangerous), reaching the indirect line in 1-2 hours. Safety zone size for expected fire behavior should be no less than 0.5 to 1 acre in diameter (200'x200'). Any night firing operations can expect max relative humidity up to 70% between 2300 and 0400 this may not allow for complete consumption and potential for re-burn will be possible.

### AIR OPERATIONS:

- Heavy canopy will cover may obstruct crews working under trees.
- Inversion may not lift making visibility poor and may restrict air operations.

### SAFETY

- **Active and Passive Crown fires are unpredictable as to initiation and spread rate. Fire activity will be in increments, increasing through the day. Monitor the progress and tie fir behavior changes to a weather observation.**
- **Fire weakened timber can fall without warning.**
- **Rollout and slope reversal have challenged suppression efforts each operational period, identify the potential for changing fire spread**
- **Make sure you can reach your safety zone before the fire reaches you. Time your travel.**

# Fuels and Fire Behavior Advisory

## Northern California

August 6, 2014



**Subject:** Long term drought conditions along with hot and dry weather have led to critically low live and dead fuel moistures. Weather and fuels conditions are contributing to very active to extreme fire behavior in Northern California.

**Discussion:** The extremely dry and warm conditions of April through July combined with the extreme to exceptional drought conditions have led to critically low live and dead fuel moistures. Numerous large fires experienced extreme fire behavior and rapid growth during the first 4 days of August. Areas receiving precipitation on August 4<sup>th</sup> and 5<sup>th</sup> are expected to rebound quickly to extreme conditions.

**Difference from normal conditions:** Live and dead fuel moistures are approximately 6 weeks ahead of normal and typical of early to mid-September. Extreme to exceptional drought, the highest levels on the Drought Monitor system now cover nearly the entire North state. Live fuel moistures never reached typical seasonal maximums and are approaching or have already reached critical levels. All timelag classes of dead fuels are at moisture levels that allow for easy ignition and rapid spread.

### Concerns to Firefighters:

- **Expect fires to ignite easier and spread faster due to low live and dead fuel moistures.** Recent fires have shown almost complete consumption of large dead fuels. **Expect higher probability of ignition and increased spotting** due to increased amount of receptive and available surface and aerial fuels.
- **Current Energy Release Component (ERC) values are reaching maximum seasonal values or setting record highs** for almost all Predictive Service Areas (PSA). ERC is a good indicator of seasonal drying trends. **Anticipate increased spread rates and active night time burning.**
- Anticipate higher resistance to control in all fuel types. **When critical fire weather conditions exist expect very active to extreme fire behavior.**

### Mitigation Measures:

- Firefighters should acknowledge and prepare for fire growth and fire behavior that may exceed anything they have experienced before due to the extreme drought. **Normal strategies and tactics may need to be adjusted to account for the drought factor. Suppression actions need to be based on good anchor points, lookouts, communications, escape routes, and safety zones.**
- Local and incoming fire personnel need to be aware that fire behavior is exceeding normal expectations for this time of the year. **Local briefings need to highlight specific fire environment conditions including local weather forecasts, Pocket Cards, ERC's, live and dead fuel moistures, and special fuel conditions such as mortality, Sudden Oak Death and frost killed brush, etc.**
- Base all actions on current and expected behavior of the fire. **Augment initial attack resources as incident activity dictates.**

- Post lookouts and monitor changes in fire behavior.
- Watch out in areas with steep slopes and watch your footing.
- Listen for rolling rocks and boulders and ‘yell out’ to others around you.


**The fire has had a significant impact to the health and stability of trees**

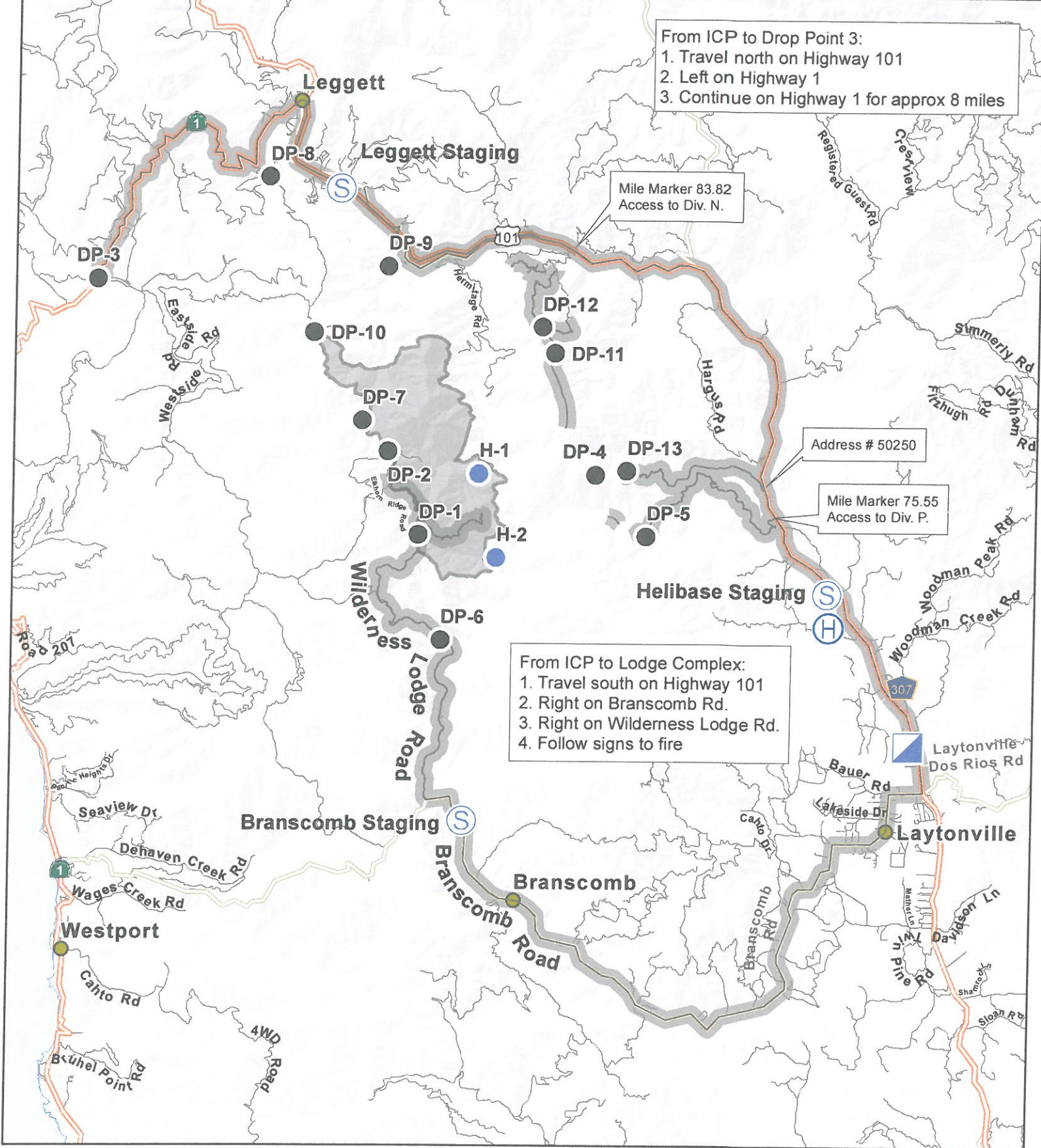

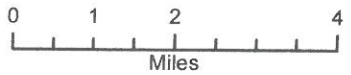

# CAL FIRE

## WATER USAGE PLAN

### *California Drought Emergency*

The following shall be considered and implemented by all fire resources as a means to provide maximum efficiencies when utilizing water resources, while minimizing the impacts to private and public water supplies. Accountability shall be maintained for all water supplies that are utilized and care should be applied to ensure proper replacement and/or reimbursement to the supplier/owner.

#### **Fireline personnel-** (During mop up operations)

- Use Pencil Hose and Garden Nozzles with Shut-Offs.
- Use Back pumps.
- Use Dry Mop-up and consolidation of heavy fuels to areas where they can burn out safely.
- Locate/Relocate Firelines to lighter fuels or natural barriers when safe.
- Set up and use portable tanks in anticipation of longer transport times for Water Tenders.
- Use of foams, gels and other water enhancers.
- Evaluate need to mop up in excess of 200 feet from fireline.

#### **Road Maintenance and Repair-**

- Monitor and water roads only when and where needed.
- Water when most effective (evening and nights).
- Use chemical treatments when available (Magchloride, Omni bind etc.).
- Consider use of tertiary or treated water.

#### **Aviation Operations-**

- Consider use of Gels, Foams and Retardants. Set up portable plants.
- Consider using Blivits and Pencil Hose for interior mop up operations as opposed to numerous bucket drops.
- Establish and use pre-use agreements for existing and known water sources.
- Use large watershed dip sites when able. Minimize use of small, static ponds and lakes.
- Maintain accountability of water used and locations of dip sites.
- Evaluate need for interior bucket drops.

#### **Private Water Supplies-**

- Notify property owner as early as possible.
- Minimize usage and develop alternative water supplies when and where appropriate.
- Track usage (meter, ICS-214 Water Usage Reports) and develop a plan to replace water.
- Make arrangements for reimbursement and damage claims if needed.

#### **Public/Municipal Water Supplies-**

- Notify Agency as soon as possible and request a representative to the incident.
- Identify fill areas and request metering devices. Note locations on incident map.
- Use alternative or reclaimed water sources when available. Note locations on incident map.
- Make arrangements for reimbursement and damage claims if needed.

#### **Management and Supervision-**

- Use leaders intent and establish Water Conservation as a Management Objective.
- Consider complexity of water use on incidents. Establish a Water Supply Group Supervisor to coordinate additional resources to support the incident needs.
- Complete the Water Usage Report daily and turn in to Finance.
- Review this check list and brief daily.
