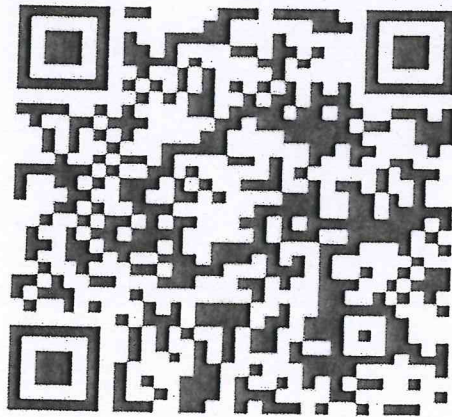

# Northern California Weather Synopsis



## \*\*\*RED FLAG WARNING\*\*\*

\*\*\* HIGH RISK for Lingering Thunderstorms Today but Getting Wetter \*\*\*

\*\*\* HIGH RISK for Increasing SW Winds Early Next Week \*\*\*

Low pressure moved onshore across Central CA last night, with a few hundred lightning strikes, with some light showers. Today's lightning will focus more on the Sierra/Cascades and parts of the Northern Mountains. These storms, especially in the Sierra, will be getting progressively wetter by late this afternoon. Over the weekend, a low will drop south along the Canadian coast and continue to move south along our West Coast the first half of next week. This will produce a strengthening SW flow with drier conditions over North Ops. Given number of fires ongoing and possible new lightning starts, these winds...in the 15-30 mph range are enough of a concern to warrant High Risk for early next week. In addition, by midweek but there may be just enough moisture associated with the low for some isolated thunderstorms over the Northern Mountains. Temperatures will remain seasonable, even a little cooler than normal. Onshore flow along the immediate coast should produce significant cooling there, but a deep marine layer is not expected due to the proximity of low pressure.

- ✓ Monitor all drivers for fatigue,
  - Switch drivers regularly if possible
  - If not find a safe place to stop, exit the vehicle and stretch a little
  - If all else fails, stop and take a short rest to revitalize.
- ✓ Obey Posted Speed Limits
- ✓ Ensure Personnel have adequate nutrition and hydration for the trip
- ✓ Be prepared to go to the next incident

DIV	HAZARDOUS ACTIONS / CONDITIONS	MITIGATIONS/WARNINGS/REMEDIES
CAMP	FATIGUE	<ul style="list-style-type: none"> <li>• Be alert for signs of fatigue in yourself and your crew, get adequate rest at Camp.</li> <li>• Monitor incoming/outgoing resources for level of fatigue.</li> <li>• Maintain 2:1 work/rest ratio.</li> </ul>
CAMP	HYDRATION	<ul style="list-style-type: none"> <li>• Stay hydrated while in camp, replenish bottled water supply.</li> <li>• Be alert for signs of heat stress in yourself and others.</li> </ul>
CAMP	DRIVING HAZARDS	<ul style="list-style-type: none"> <li>• Drive defensively! Expect the unexpected. Slow Down on Highway 273!</li> <li>• Reduce distractions (phones, radios, eating) while driving.</li> <li>• Increase following distances. Maintain Situational Awareness.</li> <li>• Drive with headlights on.</li> </ul>
CAMP	HEAT ILLNESS PREVENTION	<ul style="list-style-type: none"> <li>• Follow CAL FIRE Heat Illness Prevention Plan-Available at ICP</li> <li>• All line personnel should be acclimated to work environment</li> <li>• Monitor employee hydration/nutrition and insure adequate supplies are available</li> <li>• Utilize cooling measures to assist with lowering core temperature</li> <li>• IRPG Page 103</li> </ul>

CAMP	COMPLACENCY	<ul style="list-style-type: none"> <li>• Stay alert. Be prepared to respond when dispatched.</li> <li>• Maintain situational awareness</li> <li>• Refer to IRPG Page x.</li> </ul>



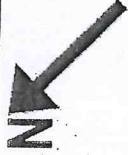
