WEATHER DISCUSSION: Partly cloudy conditions are expected through the operational period. There is a slight chance of thunderstorms through this evening. Any thunderstorms that develop in the morning will be dry (with gusty and erratic winds the biggest threat)...but will potentially become wetter in the afternoon and evening. Afternoon temperatures will be a bit cooler with an associated slight increase in humidity. Typical diurnal winds will prevail.

On Saturday and Sunday...dry conditions are expected along with a gradual cooling trend. For early next week...the cooling trend will continue and there may be the possibility of some precipitation.

SAFETY MESSAGE

August 7, 2015

10 & 18's Lookouts- Communications- Escape Routes -Safety Zones

Major Hazards and Risks:

TOPOGRAPHY!!! Many areas of the fires are in very steep terrain. Watch your footing be aware when working above other crews. ALWAYS watch for compromised trees and snags, Look up and Live.

WEATHER!!!! Carefully review and be familiar with the weather forecast. Be aware of changing conditions, lightning, wind shifts, increasing temperature, and decreasing humidity.

FATIGUE, DEHYDRATION AND HEAT EXHAUSTION!!! Get plenty of rest, watch for fatigue and mitigate, follow proper hydration procedures. Watch for heat illnesses make sure you pace yourself, good nutrition are also keys to wellness on the fire line.

Fire Behavior Know what your fire is doing at all times, observe personally and use scouts.

Driving Safety: Watch speeds on roads, there are tight turns, narrow roads and potentially unstable shoulders. We have had a few close calls with civilian drivers. Be careful moving your equipment to and from the incident and in tight spaces.

Chipper Safety: Brief your crews on the chipper safety sheet when using a chipper on the fire line.

Base Camp Safety: Watch out for tripping hazards in the base camp, Practice safe parking awareness use backing person when applicable.

Remember Fire activity sees the most injury on incidents Conduct & Performance is essential to your fire line safety; document your tailgate safety briefing.

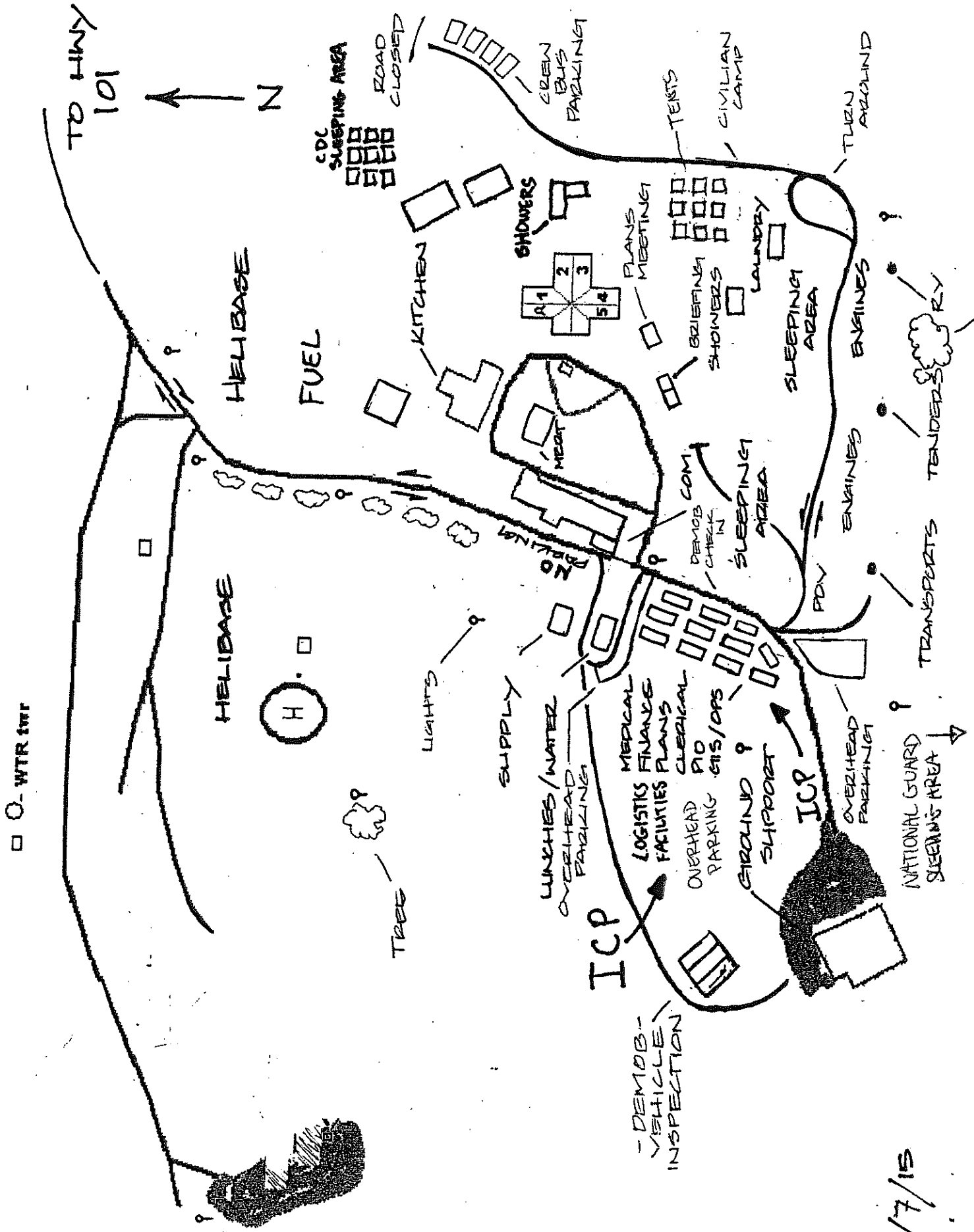
