WEATHER DISCUSSION: High temperatures should be almost as warm as Sunday with high pressure remaining the dominant weather feature. Ridgetop winds will be from the west most of the day with a shift to the northwest and an increase in speed after 1800. Cooler air will start to move in on Tuesday which will decrease temperatures and raise humidity levels. This will also allow higher nighttime humidity and temperature recoveries.

GENERAL:

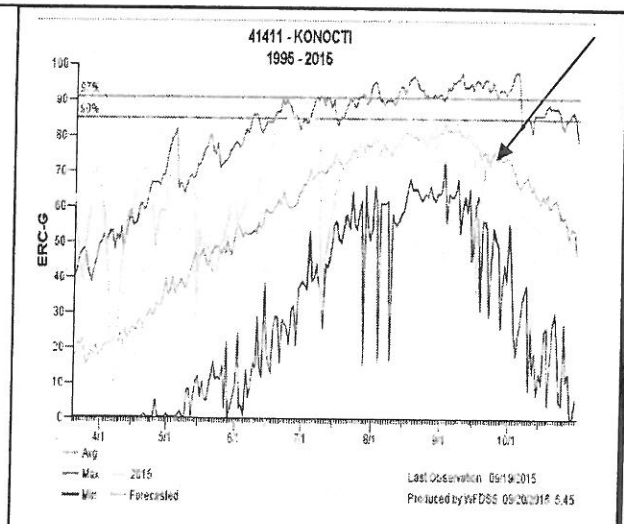
Heat sources continue to be limited to the downed heavy fuels, snags and the base of larger trees. Those areas that have active ground fuels near heat sources continue to be consumed which should make fuels for new ignitions scarce.

FUELS IN OPTIMAL ALIGNMENT

Shrub group FWD Rate of Spread 20 – 55 Ft/Min,
Flame Lengths 10 – 16 Ft,
Timber Understory FWD Rate of Spread 5 – 12 Ft/Min,
Flame Lengths 6 – 8 Ft/Min.

Probability of Ignition is 91%

ERC levels have rebounded from the mid-week rain. Current levels are at seasonal averages but expect numbers to begin to climb by early next week.



SPECIFIC:

Branch XIII (Geysers) - XV - I

Expect continued low intensity burning in the downed heavy fuels and within snags. Smoke production from these heat sources should dissipate unlike earlier in the week when conditions would become socked in limiting visibility. If these fires align with slope, even at the lower wind threshold expect fires to transition into the canopy. Individual and group torching is within the realm of opportunity.

Branch XI – IX – VII

There are still islands and some indirect line that have potential to become active with the higher P(i)G. Maintain awareness as late afternoon heat and sun could activate areas that were inactive during the morning hours.

Branch V – III

Interior heat is still being observed, but lower level of activity is expected.

AIR OPERATIONS:

Air operations should not experience any lasting impacts.

SAFETY

Post wildland fire environment with aggressive suppression efforts. Weakened trees, snags and overhead hazards should be considered when working in the areas with overhead trees.

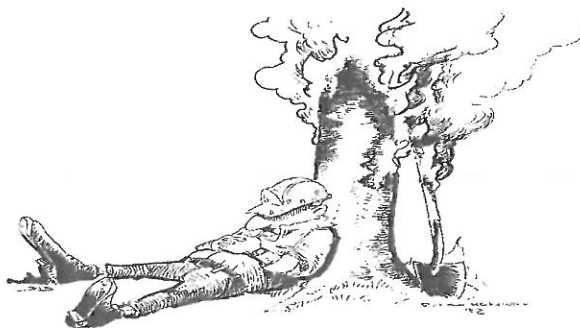



- ALL PPE must be worn when working on the fireline.
- Utilize fallers for hazard trees, NO SPORT FALLING.
- Drive Defensively and slow down. Ensure headlights are on, utilize spotters and back up guides.
- Ensure radios are properly programmed for today's IAP and all crewmembers are familiar with use.
- Use caution when working around burned or damaged structures. Unmarked hazards such as damaged LPG tanks, hidden basement/cellars, and downed powerlines still exist.
- Treat all powerlines as energized. DO NOT CUT powerlines, utilize appropriate utility represenatives.
- Anticipate an increase in civillian presence and traffic due to re-population.
- Beware of environmental hazards such as stump-holes, steep slopes, trip hazards, poison oak, bee hives, and loose footing. Flag off hazards and communicate them to others.
- Maintain hydration and proper nutrition. Monitor each other for fatigue and take breaks as necessary.

GEYSERS

SAFETY MESSAGE

This Safety Message applies to any resource assigned to the Geysers, in addition to the Valley Incident Safety Message.

- ⇒ The Geysers is a power distribution area, assume all power lines are energized. DO NOT CUT ANY DOWN POWERLINES.
- ⇒ Steep winding UNMARKED roads are throughout the Geysers. Drive defensively with headlights on anticipating the unexpected.
- ⇒ The Geysers area contain vertical and horizontal mines shafts, look down for vertical mines and stay away from horizontal mine openings.
- ⇒ Earthquakes are prevalent throughout the Geysers, LOOK OUT for rolling rocks and take earthquake precautions if earthquakes are felt.
- ⇒ Hydrogen Sulfide (H₂S) in parts per million can be hazardous, if available utilize air monitoring equipment to detect for this hazard.
- ⇒ Natural steam vents exist in many areas. DO NOT mistake steam for smoke you may be BURNED.
- ⇒ Reclaimed hydrants are painted PURPLE do not drink water from the hydrant system in the Geysers.
- ⇒ Stay upwind of cooling towers, the steam may contain hazardous materials. Use DEFENSIVE tactics on cooling tower fires.

Natural Occurring Asbestos Facts

What is Natural Occurring Asbestos?

- Natural Occurring Asbestos (NOA) can be found in 53 of the 58 counties in California.
- Serpentine rock is a distinctive shiny greenish-gray color which may contain NOA.
- Serpentine rock is commonly mantled by topsoil.
- Serpentine rocks may contain white streaks of minerals known as asbestos.

Potential exposure

- Serpentine rock has been mapped within portions of the Valley incident.
- Serpentine rock that is crushed or pulverized may release asbestos fibers into the air.
- Asbestos is an inhalation hazard only. Exposure risk is based on concentration, intensity and duration.

How can you reduce your exposure to Natural Occurring Asbestos on the Valley Incident?

- Pre-soak dry ground before activity. (Dust abatement)
- Utilize helicopter assets.
- Approach assignments from undisturbed soil.
- Utilize all PPE; N-95 mask will help minimize inhalation of dust. (These are available from Branch Directors & Division Supervisors).
- Washing your hands after activity and before meals.
- Utilizing damp cloths to clean equipment instead of compressed air.
- Laundering all PPE after each shift.
- Showering after each shift to rinse any possible fibers from the body and hair.
- Rinse apparatus and equipment with tank water from fire engines after use in areas known or believed to contain Natural Occurring Asbestos.

Documentation

- During the demobilization process, exposure forms and information will be provided to all fire personnel.

MEDIA

California State Penal Code Section 409.5(d) allows the news media to enter scenes of disaster, riot, or civil disturbance. Properly identified members of the news media should not be restricted from entering the locations specified within the code, even if the area presents a danger to them. Media members should be advised of the nature of possible danger. Members of the media do not have the right to access crime scenes or any area where their presence may interfere with incident operations, mitigation or evidence collection.

- The media may only access private property with the property owner's permission. Fire personnel cannot provide members of the media with authorization to enter private property.
- If approached and questioned by the media and/or the public, talk about your assignment or task at hand. If need be, direct the questioning party to the incident PIO.
- Do not speculate or give opinions.
- There is no such thing as an "off the record" comment.

CAL FIRE SOCIAL MEDIA POLICY (Social Media 0691)

Social Media is increasingly being used by public agencies, the media and the public. This form of communication continues to grow rapidly in order to supply the public's desire for instant information gratification. All personnel assigned to a CAL FIRE incident will adhere to the CAL FIRE Social Media Policy. Further information about the CAL FIRE Social Media Policy can be obtained from the Information Officer. If you are uncertain, please ask. **Do not post:**

- Inappropriate information, pictures or videos
- Opinions regarding the incident or policy
- Endorsements of any kind

PICTURES AND VIDEO OF INCIDENT

We are in a new era of media. Media no longer means the news/broadcast industry but now refers to anyone that has the capability to shoot video and or photographs and post them onto social media in a matter of minutes. Unfortunately we have seen some instances of video or photographs that have depicted unsafe, unprofessional or embarrassing circumstances which are a serious breach of ethics. When this happens it reflects poorly on all that are attached to this incident. Posting an inappropriate video, photo or blog comment could have unwanted effects. It may be unsafe to shoot photos or video and a firefighter who is concentrating on a camera can't be looking up, down and all around.

LOST AND FOUND

The Information staff will manage *Lost and Found* items for the incident. If you have lost an item, leave your contact information and what you have lost at the Information trailer. If you have found an item on the incident, bring the item to the Information trailer.

How do Trainees Get Qualified?

1. Stop by Training in the Plans Building (Firtch Hall) next to Documentation: 0630 to 2000 hours. TNSP Lynn Webb's cell phone number is 707-391-6754.
2. Training can check on your trainee status and task book.
3. While on assignment, work with your Evaluator to complete items in your task book.
4. Wrap up with a performance evaluation then return to Training. We will review your documentation and provide it to your home unit.
5. Your home unit follows specific review policies before certifying recommended trainees as qualified.

Before you demob, critical steps must happen at Training!

**Archaeological and Historic Properties:
General Fire-line Guidance for the BLM Ukiah Field Office.**

**Do not compromise safety for the protection and preservation of archaeological and historic properties.
When possible and prudent:**

1. Be on the lookout for prehistoric and historic archaeological sites. These sites typically occur adjacent to streams and springs, confluences are often especially sensitive. However, sites can occur in other areas too. The most common indicators of prehistoric sites in this area (North Coast Ranges) are scatters of shiny black obsidian flakes from tool making activities and dark midden soils. Historic-era sites include homesteads that contain foundations, rock chimneys, and stone / brick-lined wells. Historic-era mining sites are possible as well.
2. Note, that much of the area has never been surveyed for archaeological resources and many sites out there have yet to be discovered.
3. If you observe archaeological resources, flagged or unflagged, attempt to avoid with ground disturbing activities altogether.
4. If avoidance is not possible, minimize ground disturbance. Use a hand crew rather than a dozer to remove fuels from control lines that must cross site areas if possible.
5. Leave all artifacts in place as some may have been intentionally placed for religious or ceremonial reasons.
6. Note locations of discovered resources on a map, better yet, take site coordinates with a GPS. Leave information for the archaeologist so that the sites can be relocated and protected during Fire Suppression Repair. Flag the site in red if possible.
7. If you encounter a burial or other human remains, cease work in that area and contact the archaeologist immediately.

FIRE SUPPRESSION REPAIR PLAN: VALLEY INCIDENT

Fire suppression repair is the repair of damage caused directly from fire suppression activities. It is not the repair of infrastructure or rehabilitation of burned areas that happened as a result of the fire itself.

Damaged facilities will be upgraded to their pre-fire condition. Projects too large or complex to be completed by the Fire Suppression Repair Group shall be transferred to the Comp/Claims Unit or the local Unit. Repair work shall only occur in locations authorized by the operations Division and where fire suppression activities are complete. Fire Suppression Repair Group resources shall evaluate all Divisions for appropriate repair needs. This includes areas inside and outside the fire perimeter provided the damage was caused by official fire suppression activities.

Examples of items that may be repaired include, but are not limited to:

Infrastructure Damage	Natural Resource Damage
Fences and Gates	Temporary watercourse crossings
Culverts and bridge damage	Erosion potential from completed dozer line
Water sources	Slash and other woody debris piles generated from line construction
Utility lines (above or below ground)	Adverse impacts to protected plant and animal species
Road barriers removed for fire access	Adverse impacts to air (dust) water quality
Trash, debris, and supplies left by fire suppression resources	
Miscellaneous damage to residential property	

Dozer Line Repair

Dozers construct both fire and contingency line. Dozer line width varies greatly. The following measures shall be implemented for constructed dozer line:

- Berms and push-piles will be spread out to the extent feasible. This may be accomplished by back-blading and/or using ripper shanks or grapples. Debris piled against trees or perched above watercourses is especially important to remove or disperse.
- Waterbreaks shall be constructed at 45 degree angle (approximate) and shall be a minimum depth of 12 inches from the bottom of the cut to the top of the berm. Where feasible, the discharge from waterbreaks shall be directed into vegetated areas.
- Where slopes exceed the range at which a tractor can effectively work, waterbreaks shall be constructed with hand tools.
- Roads used in fire suppression activities shall be left in the same condition they were found or better. Gravel and soil-surfaced roads shall be watered to prevent excessive dust. Where fire suppression activities have damaged or rendered road drainage facilities non-functional, water breaks or drivable drainage dips shall be installed for drainage.
- Where fire suppression activities have filled in or damaged inside ditches, the ditches shall be cleaned and left unobstructed.
- Spacing of waterbreaks shall be as follows:

Prevailing gradient	Maximum waterbreak spacing
0-10%	200 feet
11-25%	150 feet
26-50%	100 feet
>50%	75 feet

Spacing criteria is a general guide. Actual location of waterbreaks should be tailored to the topography and placement suited to the best dispersal of water flow.

DEMOBILIZATION PLAN - SUMMARY Valley Incident CA-LNU-008670

The Demobilization Plan is developed to facilitate the orderly removal and checkout of resources on the incident. By definition, surplus personnel are available for release if they have rested for a minimum of 8 hours, are outfitted, and have a safe vehicle ready to depart to their next destination.

GENERAL GUIDELINES

- **NO RESOURCES WILL LEAVE THE INCIDENT UNTIL AUTHORIZED TO DO SO BY THE DEMOBILIZATION UNIT.**
- Efforts will be made to ensure that all released personnel arrive at their destination prior to 2200 hrs.
- All government vehicles leaving the incident will have a safety inspection.
- All trainees are to report to the Training Specialist with their task book and evaluations prior to the completion of the demobilization process.

RESPONSIBILITIES

Unit Leaders will declare resources excess to their Section Chief. Section Chiefs will declare excess resources to the Planning Section Chief through the Resource Unit Leader. This should be done 36 hours in advance of anticipated release. **Use the Declaration of Excess Resources sheet or General Message Form (ICS-213) to list all surplus resources.** Include the resource name, request number, name of person, date and time of declared excess, and time in which the resource will be eligible to leave. Send to the RESOURCE UNIT where the resource will be determined to be surplus to the incident. Surplus resources will then be able to report to the DEMOB UNIT, receive a Demobilization Checkout Form (ICS-221), get the appropriate ICS-221 signatures, and then return the completed ICS-221 to the DEMOB UNIT prior to final release of reassignment.

RELEASE PRIORITIES

The following Release Priorities have been established by the Per CAL FIRE Policy 7772-3.

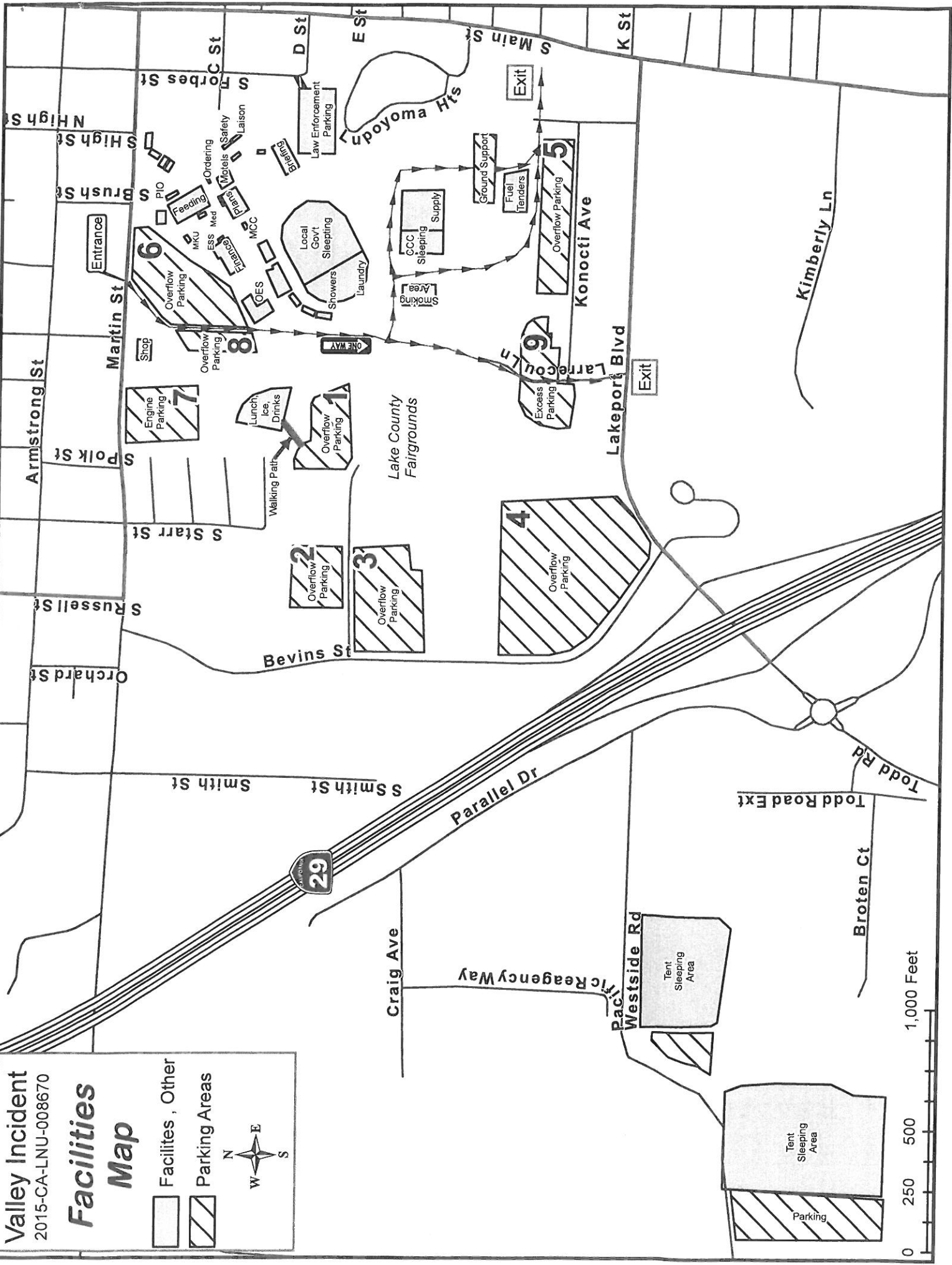
1. Organized fire departments
2. OES engines
3. State and Federal Military forces
4. Hired personnel and equipment
5. Other agencies (USFS, BLM, etc.)
6. Out of region CAL FIRE forces
7. Within Region CAL Fire forces
8. Unit CAL Fire forces

Local conditions, economics, life and property protection responsibilities of sending agencies, etc. may justify deviation from these guidelines. The incident commander is responsible for approving these deviations when they occur.

FC-315 INSTRUCTIONS FOR USE

INITIAL AND EXTENDED ATTACK INCIDENTS:

The Incident Commander approves replacement request based on Engine Accountability sheets or other fire equipment inventory documents approved by the requesting resource's home unit.

- If equipment and supplies are available at the incident for replacement, the request is filled at the incident host unit.
- If equipment and supplies are unavailable at the incident for replacement AND the requesting resource is not being immediately demobilized, the hosting unit will place a resource order for needed items through appropriate channels to the servicing fire cache or vendor. The order will be shipped to the incident and replacement will take place at the host unit.
- If equipment and supplies are unavailable at the incident for replacement, AND the requesting resource is being demobilized, an FC-315 will be completed by the host unit, 'S' number issued, signed by the authorizing official and given to the requesting resource.
- On an Initial or Extended Attack incident, where a Supply Unit has not been established, approvals are limited to the Incident Commander or Agency Representative.

LARGE INCIDENTS WHERE A BASE HAS BEEN ESTABLISHED:

The incident Supply Unit Leader (SPUL) will be responsible for handling incident replacement requisitions when an incident base is established. The SPUL approves replacement request based on Engine Accountability sheets or other fire equipment inventory documents approved by the requesting resource's home unit.

- If equipment and supplies are NOT available at the incident for replacement, AND the requesting resource is not being immediately demobilized, The Supply Unit will place a resource order for needed items through appropriate channels to the servicing fire cache or vendor. The order will be shipped to the incident and replacement will take place at the Supply Unit.
- If equipment and supplies are unavailable at the incident for replacement, AND the requesting resource is being demobilized, an Incident Replacement Requisition (FC-315) will be completed by the Supply Unit, a 'S' number issued, signed by the authorizing official and given to the requesting resource.
- Authorized approvals and signatures MUST be included on the FC-315. For large incidents where a Base has been established, these approvals are limited to Incident Supply Unit Leader, Logistics Section Chief, Incident Commander or Agency Representative.

Replacement orders will be based on approved OF-315's and must be processed within 30 days of control of incident. A copy of the FC-315 will be attached to all pay documents charged against an incident number.

Instructions for Use of CDF 101 Property Certification of Location or Damage

Document Number: for use as a local number system or when attached to a FC-40 document.

Location / Incident Name: Enter the CDF facility property is assigned to. If submitting to an incident base, enter the Incident Name.

Incident Number: Enter the appropriate incident number

Unit: Enter the Unit the property is assigned to. If submitting to an incident base, enter the request number of the person certifying damage example E-320, C-14 or O-355.

Region: Enter the CDF Region where the property was assigned. If submitting to an incident base, enter the CDF Region responsible for the incident.

Date: Enter the date the P.L. or D. was completed.

The following items were: Enter either 'Broken', 'Left on Line', 'Damaged' or other status of the property.

Reminder, this form cannot be used in place of the STD-152 to certify Lost, Stolen, Worn Out or Damaged beyond repair property.

Date of Occurrence: Enter the date the property was broken, left on line or damaged.

Quantity: Enter the quantity for the line item.

Unit of Measure: Enter the unit of measure for the line item (example ea = each).

CDF Stock Number: Enter the PIN or stock number.

Description: Enter the description of the line item, indicate size, make, model and type. Clearly describe the item and provide adequate data to effectively identify equipment or property.

Property Number: Enter the CDF property number assigned to the line item, Capitalized or sensitive property must have their property number entered here.

Location of Items: Where is the property now (example, left on Division B night shift 8/1/04, Drop Point 2). A GPS coordinate, Station 22 or Unit Service Center may also be used to describe Location.

Remarks: Enter specific remarks here, how was the property damaged, what specifically is wrong with it.

Signature of Person Certifying Occurrence as Described:

Signature: The CDF Employee certifying the occurrence must sign.

Printed Name: Enter the printed name of the signature.

Title: Enter the title of the signature.

Date: Enter the date of the signature.

Unit Supervisors Approval:

If submitted on an incident this section must be completed by the supervisor of the property custodian. This may be the Strike Team Leader, Division Supervisor, Receiving and Distribution Manager, Supply Unit Leader, Logistics Section Chief, Agency Representative or Incident Commander.

If submitted at the home Unit this section must also be completed by the supervisor of the property custodian. This may be a Battalion or Division Chief.

Comments: Supervisors may enter comments of approval or disapproval.

Signature of Unit Administrator: Signature of Unit Supervisor reviewing the certification described.

Title: Title of the signature.

Date: Date of the signature.

Notes:

This document is NOT required if exchanging property at an incident base with the exception of capitalized or sensitive property assigned a CDF property number.

This document is required as certification when submitting an MRT to your local Service Center for replacement of property.

An OF-315 (Incident Replacement Requisition) is required as authorization to purchase fire replacement items at your local Unit. This document is required when submitting an MRT to your local Service Center for fire replacement items. A CDF-101 and/or A STD-152 are required for the certification of the status of property being requisitioned for replacement.

WATER USAGE PLAN

California Drought Emergency

The following shall be considered and implemented by all fire resources as a means to provide maximum efficiencies when utilizing water resources, while minimizing the impacts to private and public water supplies. Accountability shall be maintained for all water supplies that are utilized and care should be applied to ensure proper replacement and/or reimbursement to the supplier/owner.

Fireline personnel- (During mop up operations)

- Use Pencil Hose and Garden Nozzles with Shut-Offs.
- Use Back pumps.
- Use Dry Mop-up and consolidation of heavy fuels to areas where they can burn out safely.
- Locate/Relocate Firelines to lighter fuels or natural barriers when safe.
- Set up and use portable tanks in anticipation of longer transport times for Water Tenders.
- Use of foams, gels and other water enhancers.
- Evaluate need to mop up in excess of 200 feet from fireline.

Road Maintenance and Repair-

- Monitor and water roads only when and where needed.
- Water when most effective (evening and nights).
- Use chemical treatments when available (Magchloride, Omni bind etc.).
- Consider use of tertiary or treated water.

Aviation Operations-

- Consider use of Gels, Foams and Retardants. Set up portable plants.
- Consider using Blivits and Pencil Hose for interior mop up operations as opposed to numerous bucket drops.
- Establish and use pre-use agreements for existing and known water sources.
- Use large watershed dip sites when able. Minimize use of small, static ponds and lakes.
- Maintain accountability of water used and locations of dip sites.
- Evaluate need for interior bucket drops.

Private Water Supplies-

- Notify property owner as early as possible.
- Minimize usage and develop alternative water supplies when and where appropriate.
- Track usage (meter, ICS-214, IMT3 Water Usage Reports) and develop a plan to replace water.
- Make arrangements for reimbursement and damage claims if needed.

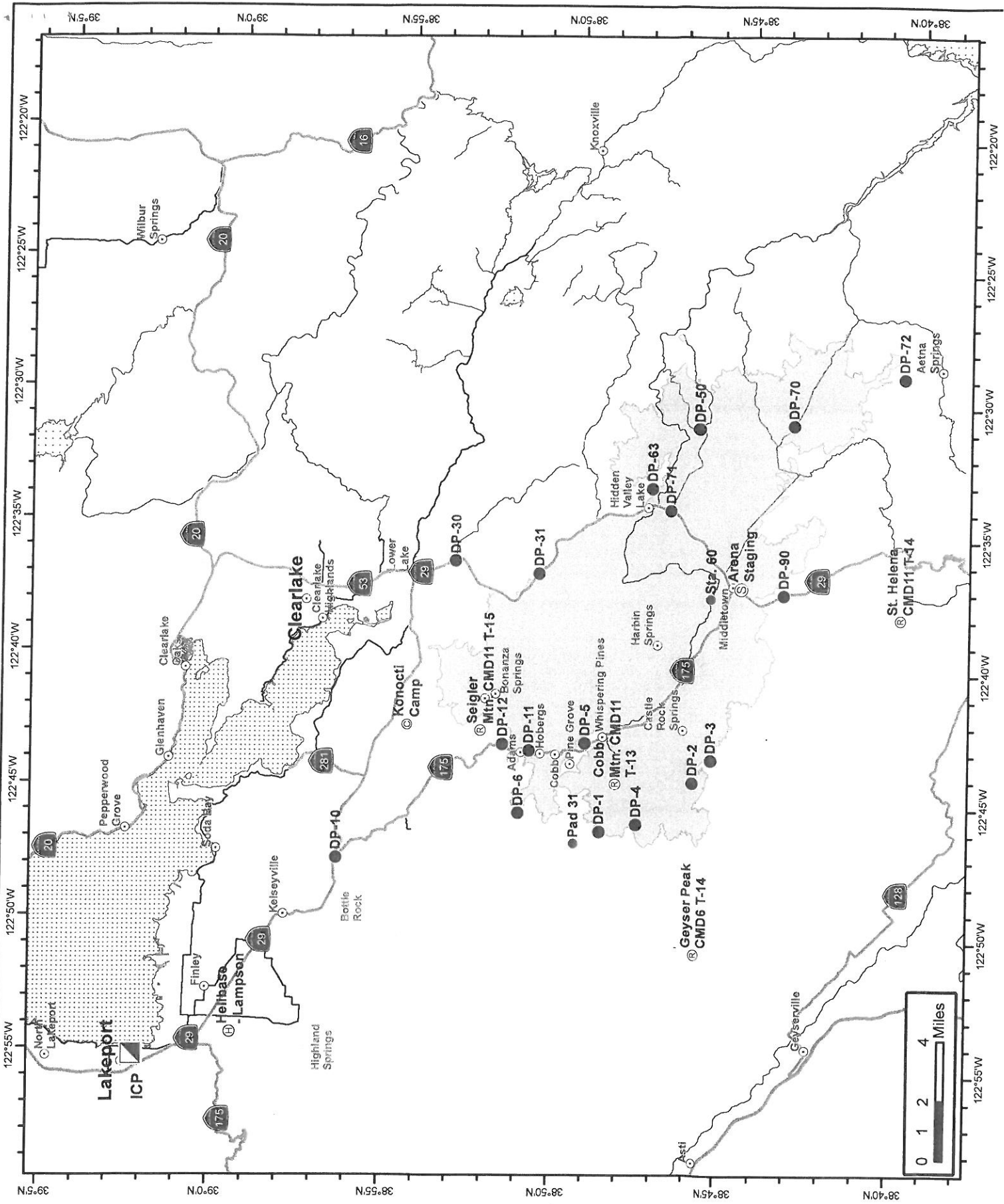
Public/Municipal Water Supplies-

- Notify Agency as soon as possible and request a representative to the incident.
- Identify fill areas and request metering devices. Note locations on incident map.
- Use alternative or reclaimed water sources when available. Note locations on incident map.
- Make arrangements for reimbursement and damage claims if needed.

Management and Supervision-

- Use leaders intent and establish Water Conservation as a Management Objective.
- Consider complexity of water use on incidents. Establish a Water Supply Group Supervisor to coordinate additional resources to support the incident needs.
- Complete the Water Usage Report daily and turn in to Situation Unit.
- Review this check list and brief daily.
