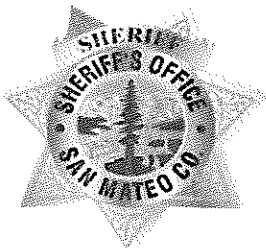



WEATHER DISCUSSION:

The marine layer is deepening as we continue to see good onshore flow into the CZU fire area. Breezy west to southwest winds are expected again this afternoon with little change in the temperatures and humidity from what we saw yesterday. Expect to see good recovery at all elevations tonight. This onshore flow pattern will continue through at least mid-week, with warming and drying trend as we go into the weekend.

WEATHER FORECAST TUESDAY:

WEATHER: Mostly sunny with smoke. Coastal fog possible in the morning.

TEMPERATURES: Highs 74-84.... 64 along the coast. **LITTLE CHANGE**

HUMIDITY: 45-55%... except below 1500ft 55-70%. **LITTLE CHANGE**

20 FT WINDS:

ABOVE 1500ft – West and Southwest 5-10 mph with **gusts up to 15 mph.**

BELOW 1500ft – West and Southwest 5-10 mph.

STABILITY: Marine layer up to 800ft along the coast. **HAINES:** 4 above 2000ft level....2 below.

TUESDAY NIGHT: **...DRIER RECOVERY TONIGHT ALONG RIDGES...**

WEATHER: Smoky skies. Coastal fog developing overnight.

TEMPERATURES: Overnight lows 60s above 1500ft... upper 50s below 1500ft. **LITTLE CHANGE**

HUMIDITY: above 1500ft near 35-50%... except 80-100% below 1500ft. **20% WETTER**

20 FT WINDS:

ABOVE 1500ft – West and Southwest 4-8 mph with **gusts up to 12 mph.**

BELOW 1500ft – West and southwest 3-6 mph.

EXTENDED FORECAST: **...THERMAL BELTS DEVELOPING BY THE END OF THE WEEK...**

INPUTS

WEATHER SUMMARY

Marine influence has occurred over most of the fire and is having an increasing affect on fuels and burning conditions.

Review the IMET forecast for specific details

OUTPUTS

FIRE BEHAVIOR

GENERAL: The fire is burning in heavy timber mix of Hardwoods and Coastal Redwoods along with thick litter and some intermixed grass and brush. The region is experiencing moderate to severe drought due to rainfall for the area at about 50% of average with the last recorded wetting rain occurring more than 90 days ago. The fire continues to resist control efforts due to the prolonged drying and depth of fuel beds. Fuel moistures in the brush are at critical levels, and the 100-hour fuels are around 10% and 1000-hour fuels moistures are around 7%. Heavy dead down fuels will be consumed near 100% leaving deep seated heat in ash pits.

Despite the marine influence, the heaviest fuels are still very dry and will continue to burn with intensity.

SPECIFIC:

Below 1500 foot elevation: The marine layer will be over the fire for these areas for the entire shift. This marine layer has begun to affect the 1 and 10 hour fuels, especially along the coast. This moisture has had some effect on the heavier 100 and 1000 hour fuels and thick duff layer, but they continue to burn due to persist dry pattern the region has experienced. Probability of ignition is 20%

Above 1500 foot elevation: The upper elevations of the fire have remained dry for the past 8 days but have had good humidity recovery yesterday for the first time during the fire. These areas will continue to burn with active flanking, backing and roll out, but should have less opportunity for increasing significant fire spread. Occasional single tree torching is still possible due to heavy fuel loading and the spotting potential is 200 to 500 feet. Expect humidity to recover much more at night than previous shifts, moderating fire behavior. Probability of ignition is 40%

AIR OPERATIONS: Smoke and marine layer in the morning will prevent air operations until the air starts clearing after 1100.

Sunset: 19:46 Sunrise: 06:33

SAFETY

- Mop up should be more extensive in areas that could generate wind blown embers across the line.
- Limited visibility may give you a false sense of security. Use LCES to ensure you know what the fires are doing around you.
- Snags/trees can burn in the upper portions. Look up! Just because there is no fire in the lower trunk doesn't mean it's safe

SAFETY MESSAGE

Marathon: A long-lasting or difficult task or operation of a specified kind.

- Multiple hazards in the WUI: Steep narrow roads, heavy fuel loading, wells, wooden septic tanks, long escape routes, public presence and power lines.
- Look Up, Down, and Around: Overhead, surface and under ground hazards.
- Understand the plan for the day and your individual role within the plan.
- Mop up: Stay engaged on task assigned.
- Increase your hydration, electrolytes and nutrition with fruits and vegetables.
- Drive defensively and expect the unexpected (SLOW DOWN).
- Heavy equipment and falling modules working on opening narrow roads.
- STOP COVID-19! (*Distance 6 Feet, Cover Nose and Mouth, Wash Hands*).

Ash Pit Awareness

- Observe the remnants of the vegetation model.
- Look for depressions in the ground.
- Use your hand tool to sound your way into the burn.
- White ash may be an indicator of an ash pit.
- Ensure that PPE is worn and properly fitted.



BRANCH	HAZARDOUS ACTIONS/ CONDITIONS	MITIGATIONS/WARNINGS/REMEDIES
ALL	COVID-19	<ul style="list-style-type: none"> Complete daily COVID-19 screening process. Wear mask over nose and mouth/wash and sanitize hands often. Maintain social distancing when applicable.
ALL	FIRE BEHAVIOR / RE-BURN	<ul style="list-style-type: none"> Prepare for slope reversal and wind shifts. Be aware of preheated canopy and potential for re-burn.
ALL	WILDLAND URBAN INTERFACE	<ul style="list-style-type: none"> Steep narrow access and egress. Old redwood septic tanks, deep wells and LPG tanks. Be aware that civilians continue to be present in the fire area.
ALL	DRIVING HAZARDS	<ul style="list-style-type: none"> Watch your speeds. "PLEASE SLOW DOWN". Drive defensively! Expect the unexpected. Watch for road degradation and dusty conditions. Be aware of falling/rolling trees and debris in the roadways from fire activity, wind and suppression operations.
ALL	WEATHER	<ul style="list-style-type: none"> Be aware of changing wind and other weather conditions.
ALL	FIRING OPERATIONS	<ul style="list-style-type: none"> Ensure plan is in place and communicated. Follow the Fire Operations Checklist. Utilize Risk Management Process IRPG (p. 1).
ALL	POWER LINES	<ul style="list-style-type: none"> Be cautious of down lines. Make appropriate notifications if found.
ALL	HYDRATION/NUTRITION	<ul style="list-style-type: none"> Drink water before, during and after each shift. Be alert for signs of heat stress in yourself and others. Maintain proper caloric and nutritional consumption.
ALL	FIRE AND DROUGHT WEAKENED TREES/SNAG HAZARDS	<ul style="list-style-type: none"> Situational awareness for falling trees and limbs while working, driving, and parking. Follow Hazard Tree Safety Guidelines (IRPG p. 22). Flag off cat faced trees and deep stump holes.
ALL	CIVILIAN PRESENCE	<ul style="list-style-type: none"> Watch for civilian traffic. If approached please defer them to your chain of command.
ALL	COMMUNICATIONS	<ul style="list-style-type: none"> Check the communication plan for frequency assignments. Be clear and concise when talking on the radio. Use human repeaters as needed.
ALL	BRIEFINGS	<ul style="list-style-type: none"> Make sure everyone gets a briefing on the plan for the day. Document this on your ICS 214.
ALL	LCES	<ul style="list-style-type: none"> Ensure that LCES is being utilized. Identify Escape Routes, Safety Zones and TRA's.
ALL	AIRCRAFT AWARENESS	<ul style="list-style-type: none"> Be aware of rotor wash and change in fire behavior. Understand that hazardous trees may react to rotor wash. Monitor assigned aircraft frequencies. Stay clear of water drops.
ALL	HEAVY EQUIPMENT	<ul style="list-style-type: none"> Be watchful around heavy equipment, they may not see you.

Fire and COVID-19 Briefing Checklist

Self-Awareness / Screening

- Immediately separate yourself from others.
- Notify supervisor if you or others experience:
 - Cough, more than expected
 - Shortness of breath or difficulty breathing
 - New loss of taste or smell
 - Fever
 - Sore throat
 - Chills
 - Muscle pain
- Review and follow crew and division plans to isolate, triage, and transport symptomatic personnel.

Hygiene on the Fireline

- Properly wash or sanitize your hands often, especially before and after eating or entering a public place, and after coughing or sneezing.
- Avoid handshakes and communal use items.
- Maintain a supply of hand sanitizer and hand wipes. Inform supervisor of needed resupply.
- Disinfect high touch surfaces often:
 - Radios, phones, doors, pumps, fuel cans, etc.

Social Distancing and Protective Equipment

- Initiate, practice, and remind others of social distancing.
- Conduct briefings and conversations outdoors and at least 6 feet apart.
- Utilize face coverings as a tool when practical.
- Clean or replace dirty face coverings, equipment, and PPE.

Communications

- Face coverings and social distancing complicate communications. Ensure effective sender/receiver messaging.

CZU LIGHTNING FACILITIES MAP



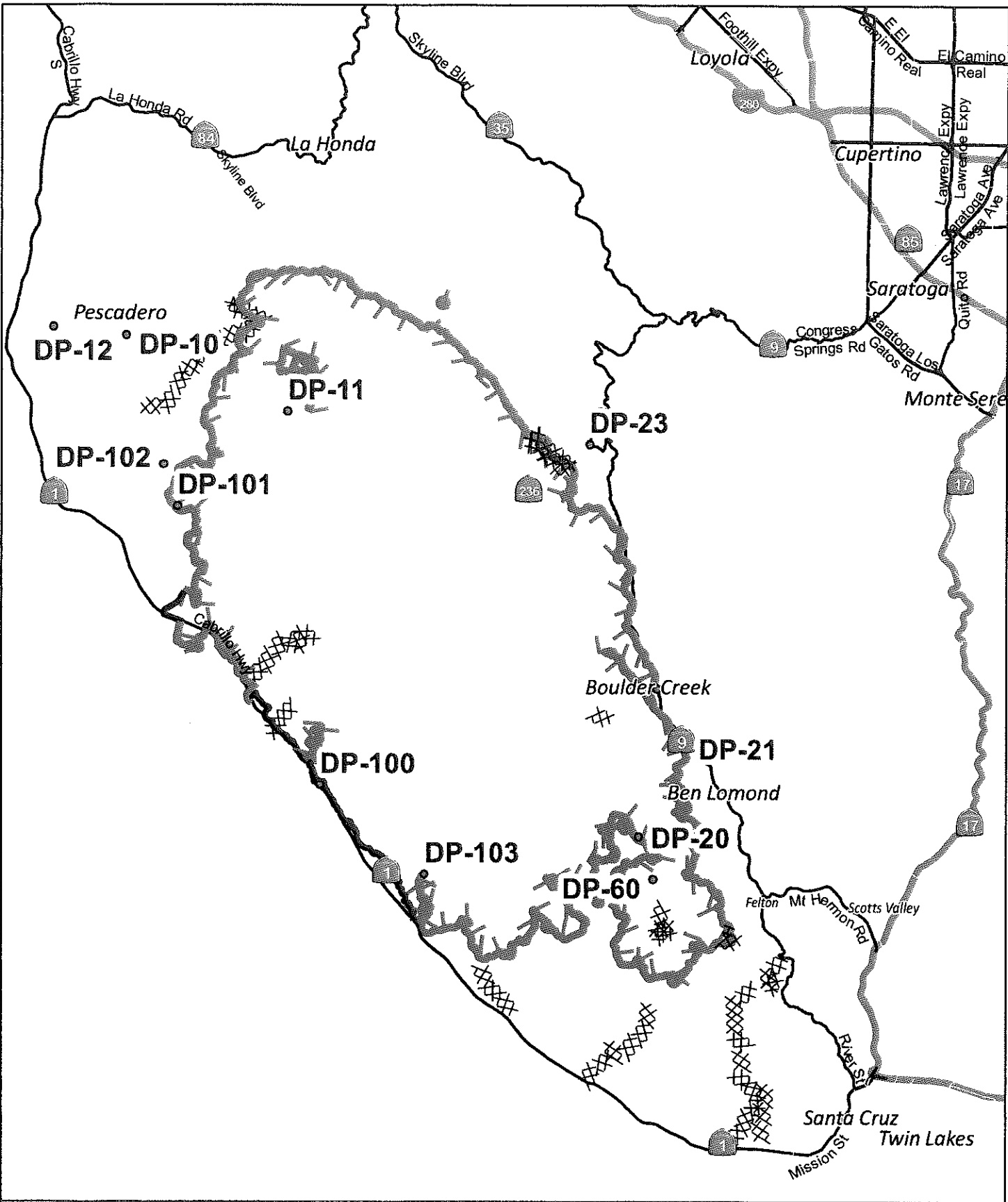
