Strategic Objectives

A full suppression strategy is to be implemented on the CZU Lightning Incident. Values at risk associated to the incident include human safety, private property and associated improvements, electrical power infrastructure, and cultural values. Minimize acres burned on all lands by utilizing effective and efficient strategies and tactics while maintaining safety first.

Leaders Intent

Work effectively with cooperative partners in a unified command structure towards a common goal of protecting values in a safe and efficient manner. All incident assigned personnel should be prepared to take the appropriate actions regarding:

- Professional behavior, conduct, and timely / effective communications
- Personal safety and safety of others, including driving slowly, safely and defensively
- Implementation of tactics that offer a high probability of success
- Manage fatigue by taking breaks and maintaining work rest cycles
- All line supervision personnel including crew and striketeam leaders must attend the morning Operational Briefing

Management Objectives

- Fight fire aggressively while maintaining safe work practices to minimize threats to the public and emergency responders, all actions and efforts will focus on safe guarding the citizens and resources of Santa Cruz and San Mateo counties
- Ensure evacuation and repopulation occurs in safe, efficient, and effective manner
- Ensure COVID-19 precautions and best practices are met always
- Minimize damage to structures, private property and other improvements in the fire area
- Protect natural, cultural, and heritage resources
- Continue to foster and maintain positive relationships with all local cooperators and stakeholders
- Provide timely and accurate incident information
- Maintain fiscal accountability keeping costs commensurate with values at risk

Control Objectives

- Keep the fire North of Highway 17
- Keep the fire South of Highway 92
- Keep the fire East of Highway 1
- Keep the fire West of Interstate 280

General Situational Awareness:

Steep and rugged terrain, critically dry and receptive fuel beds, active area for fire history and drought stressed trees.

Stop, Think, Organize, Proceed

INPUTS

WEATHER SUMMARY

Marine influence remains over much of the fire but is having only a moderate affect on fuels and burning conditions. A drying trend is beginning today through the rest of the week and into the weekend. Winds will increase slightly especially along the coast and shift more to the West and NorthWest

OUTPUTS

FIRE BEHAVIOR

GENERAL: The fire is burning in heavy timber mix of Hardwoods and Coastal Redwoods along with thick litter and some intermixed grass and brush. The region is experiencing moderate to severe drought due to rainfall for the area at about 50% of average with the last recorded wetting rain occurring more than 90 days ago. The fire continues to burn actively in all fuels due to the prolonged drying and depth of fuel beds. Fuel moistures in the brush are at critical levels, and the 100-hour fuels are around 10% with the 1000-hour fuels moistures around 7%. Heavy dead down fuels will be consumed near 100% leaving deep seated heat in ash pits and large burned out stump holes

SPECIFIC:

Below 1500 foot elevation: The marine layer will be over the fire for these areas for the first part of the shift, burning off mid-morning. This marine layer has had limited affect, transferring very little moisture to the fuels. The heavier 100- and 1000-hour fuels and thick duff layer continue to burn due to the persistent dry pattern the region is experiencing. Fire spread is mainly active backing, flanking and rollout, causing slopovers and short range spotting. Probability of ignition is 30%

Above 1500 foot elevation: The upper elevations of the fire have had some moisture recovery overnight but continue to present resistance to control. Expect humidity recovering to be less than previous shifts, allowing active burning longer into the evening. The fire will continue to burn with active flanking, backing and roll out along with occasional single tree torching due to heavy fuel loading and steep topography. Spotting potential is 400 to 600 feet. Probability of ignition is 45%

AIR OPERATIONS: Smoke and marine layer will prevent air operations until the air starts clearing around midmorning.

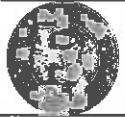

SAFETY

- Mop up should be more extensive in areas that could generate wind blown embers across the line.
- Fire weakened trees and branches continue to release, falling with little warning and can easily block roadways.

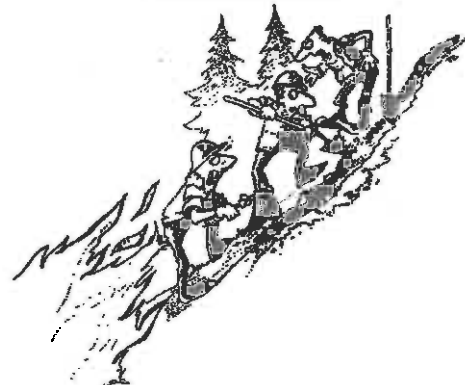
Servant Leadership: A good objective of leadership is to help those who are doing poorly to do well and to help those who are doing well to do even better. — Jim Rohn

ALL	COVID-19	<ul style="list-style-type: none"> Complete daily COVID-19 screening process. Wear mask over nose and mouth/wash and sanitize hands often. Maintain social distancing.
ALL	FIRE BEHAVIOR / RE-BURN	<ul style="list-style-type: none"> Prepare for slope reversal and wind shifts. Be aware of preheated canopy and potential for re-burn.
ALL	WILDLAND URBAN INTERFACE	<ul style="list-style-type: none"> Steep narrow access and egress. Old redwood septic tanks, deep wells and LPG tanks. Be aware that civilians continue to be present in the fire area.
ALL	DRIVING HAZARDS	<ul style="list-style-type: none"> Watch your speeds. "PLEASE SLOW DOWN". Drive defensively! Expect the unexpected. Watch for road degradation and dusty conditions. Be aware of falling/rolling trees and debris in the roadways from fire activity, wind and suppression operations.
ALL	WEATHER	<ul style="list-style-type: none"> Be aware of changing wind and other weather conditions.
ALL	FIRING OPERATIONS	<ul style="list-style-type: none"> Ensure plan is in place and communicated. Follow the Fire Operations Checklist. Utilize Risk Management Process IRPG (p. 1).
ALL	POWER LINES	<ul style="list-style-type: none"> Be cautious of down lines. Make appropriate notifications if found.
ALL	HYDRATION/NUTRITION	<ul style="list-style-type: none"> Drink water before, during and after each shift. Be alert for signs of heat stress in yourself and others. Maintain proper caloric and nutritional consumption.
ALL	FIRE AND DROUGHT WEAKENED TREES/SNAG HAZARDS	<ul style="list-style-type: none"> Situational awareness for falling trees and limbs while working, driving, and parking. Follow Hazard Tree Safety Guidelines (IRPG p. 22). Flag off cat faced trees and deep stump holes.
ALL	CIVILIAN PRESENCE	<ul style="list-style-type: none"> Watch for civilian traffic. If approached, please defer them to your chain of command.
ALL	COMMUNICATIONS	<ul style="list-style-type: none"> Check the communication plan for frequency assignments. Use human repeaters as needed.
ALL	BRIEFINGS	<ul style="list-style-type: none"> Make sure everyone gets a briefing on the plan for the day. Document this on your ICS 214.
ALL	MOP UP AND PATROL OPERATIONS	<ul style="list-style-type: none"> Ensure that LCES in place. Stay focused on assignment given.

Fire and COVID-19 Briefing Checklist

Self-Awareness / Screening

- Immediately separate yourself from others.
- Notify supervisor if you or others experience:
 - Cough, more than expected
 - Shortness of breath or difficulty breathing
 - New loss of taste or smell
 - Fever ○ Sore throat
 - Chills ○ Muscle pain
- Review and follow crew and division plans to isolate, triage, and transport symptomatic personnel.

Hygiene on the Fireline

- Properly wash or sanitize your hands often, especially before and after eating or entering a public place, and after coughing or sneezing.
- Avoid handshakes and communal use items.
- Maintain a supply of hand sanitizer and hand wipes. Inform supervisor of needed resupply.
- Disinfect high touch surfaces often:
 - Radios, phones, doors, pumps, fuel cans, etc.

Social Distancing and Protective Equipment

- Initiate, practice, and remind others of social distancing.
- Conduct briefings and conversations outdoors and at least 6 feet apart.
- Utilize face coverings as a tool when practical.
- Clean or replace dirty face coverings, equipment, and PPE.

Communications

- Face coverings and social distancing complicate communications. Ensure effective sender/receiver messaging.

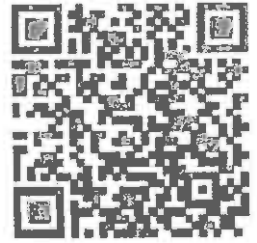

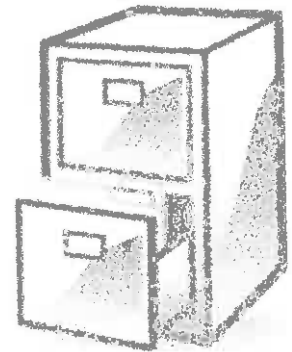
Strike Team Leaders only submit one 214 for your resource and not multiple Unit Logs for each engine.

FIRING PLAN AND GO / NO GO CHECKLIST

Test Firing Plan

The size and location of the test burn will be large enough and representative of the fuels of the proposed burn area.

Communications:

A radio net announcement at the incident will be made prior to firing operations. This will be communicated on tactical and command nets and will identify general location of geographic area to be burned. Special frequencies may or may not be used.

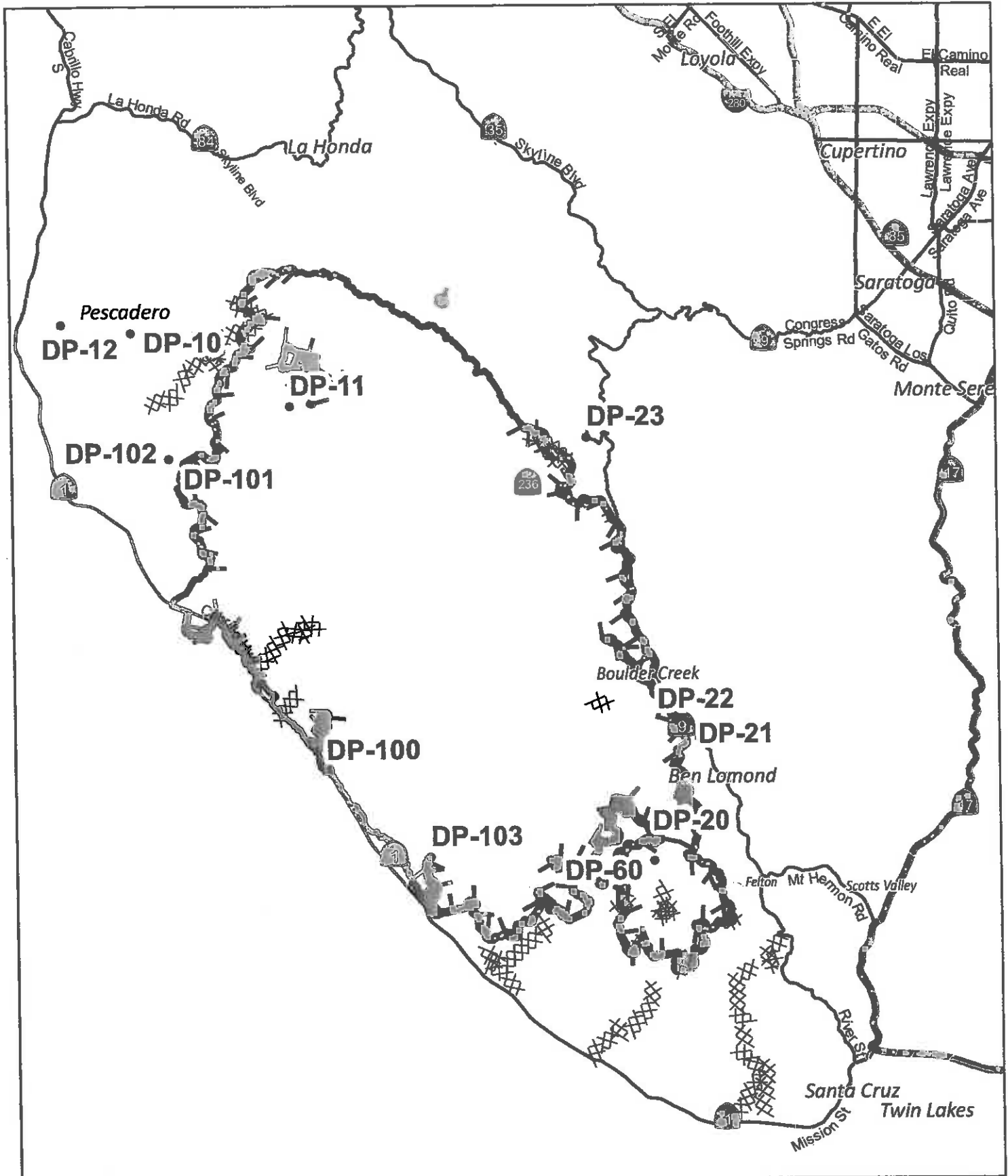
