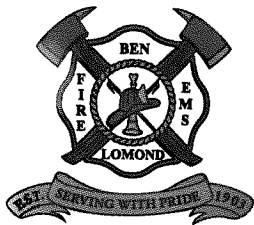

3. Objective(s):

Strategic Objectives

A full suppression strategy is to be implemented on the CZU Lightning Incident. Values at risk associated to the incident include human safety, private property and associated improvements, electrical power infrastructure, and cultural values. Minimize acres burned on all lands by utilizing effective and efficient strategies and tactics while maintaining safety first.

Leaders Intent

Work effectively with cooperative partners in a unified command structure towards a common goal of protecting values in a safe and efficient manner. All incident assigned personnel should be prepared to take the appropriate actions regarding:

- Professional behavior, conduct, and timely / effective communications
- Personal safety and safety of others, including driving slowly, safely and defensively
- Implementation of tactics that offer a high probability of success
- Manage fatigue by taking breaks and maintaining work rest cycles
- All line supervision personnel including crew and striketeam leaders must attend the morning Operational Briefing

Management Objectives

- Fight fire aggressively while maintaining safe work practices to minimize threats to the public and emergency responders, all actions and efforts will focus on safe guarding the citizens and resources of Santa Cruz and San Mateo counties
- Ensure evacuation and repopulation occurs in safe, efficient, and effective manner
- Ensure COVID-19 precautions and best practices are met always
- Minimize damage to structures, private property and other improvements in the fire area
- Protect natural, cultural, and heritage resources
- Continue to foster and maintain positive relationships with all local cooperators and stakeholders
- Provide timely and accurate incident information
- Maintain fiscal accountability keeping costs commensurate with values at risk

Control Objectives

- Keep the fire North of Highway 17
- Keep the fire South of Highway 92
- Keep the fire East of Highway 1
- Keep the fire West of Interstate 280

General Situational Awareness:

Steep and rugged terrain, critically dry and receptive fuel beds, active area for fire history and drought stressed trees.

Stop, Think, Organize, Proceed

In the COVID-19 environment, high density populations or large groups are particularly at risk. To help protect yourself, your family and to ensure all employees return home safely, make sure to practice social distancing.



WEATHER DISCUSSION:

...INCREASING NORTHWEST WINDS TODAY...

The deep marine layer this morning will keep coastal fog around the coast and San Lorenzo Valley area this morning, then burning off by mid-day. Northwest winds will bring smoke from the north zone down over the south zone of the fire. Temperatures and humidity will continue their warming and drying trend through the rest of the week. Tonight, expect to see drier conditions in the higher elevations above 1500ft, but good recovery for the lower elevations and along the coast. Conditions will become hot and very dry by the weekend and into next week.

WEATHER FORECAST THURSDAY:

...WARMING AND DRYING TREND...

WEATHER: Mostly sunny with smoke. Coastal fog in the morning.

TEMPERATURES: Highs 75-85.... 65 along the coast. **LITTLE CHANGE**

HUMIDITY: 35-45%... except below 1500ft 45-65%. **10% DRIER**

20 FT WINDS:

ABOVE 1500ft – West and Northwest 5-10 mph with **gusts up to 15 mph.**

BELOW 1500ft – West and Northwest 5-10 mph. **Gusts up to 20 mph right along the coast.**

STABILITY: Marine layer up to 1500ft along the coast. **HAINES:** 4 above 2000ft level...2 below.

THURSDAY NIGHT:

...DRIER TONIGHT ALONG RIDGES...

WEATHER: Smoky skies. Coastal fog developing overnight.

TEMPERATURES: Overnight lows 60s above 1500ft... upper 50s below 1500ft. **LITTLE CHANGE**

HUMIDITY: above 1500ft around 30-50%... except 70-100% below 1500ft. **10% DRIER**

20 FT WINDS:

ABOVE 1500ft – West 4-8 mph with **gusts up to 12 mph.**

BELOW 1500ft – West 3-6 mph.

EXTENDED FORECAST:

...THERMAL BELTS DRIER BY THE END OF THE WEEK...

FRIDAY THROUGH FRIDAY NIGHT: Mostly sunny with smoke. Coastal Fog. Max temps...80-90. Day RH 25-35%. West winds 4-8 mph. Gusts to 12 mph. Min Temps... 60-70. Night RH... 25-35%...except near 90% along the coast.

SATURDAY THROUGH SUNDAY NIGHT: Mostly sunny with smoke. Coastal Fog. Max temps...82-92. Day RH 20-33%. West winds 4-8 mph. Gusts to 12 mph. Min Temps... 65-75. Night RH... 20-30%...except near 80% along the coast.

INPUTS

WEATHER SUMMARY

Marine influence remains over much of the fire but is having only a moderate affect on fuels and burning conditions. A warming and drying trend continues today through the rest of the week and into next week. Winds will be slightly less, still out of the West and NorthWest

OUTPUTS

FIRE BEHAVIOR

GENERAL: The fire is burning in heavy timber mix of Hardwoods and Coastal Redwoods along with thick litter and some intermixed grass and brush. The region is experiencing moderate to severe drought due to rainfall for the area at about 50% of average with the last recorded wetting rain occurring more than 90 days ago. The fire continues to burn actively in all fuels due to the prolonged drying and depth of fuel beds. Fuel moistures in the brush are at critical levels, and the 100-hour fuels are around 10% with the 1000-hour fuels moistures around 7%. Heavy dead down fuels will be consumed near 100% leaving deep seated heat in ash pits and large burned out stump holes

SPECIFIC:

Below 1500 foot elevation: The marine layer and smoke will be over the fire for these areas for the first part of the shift, burning off mid-morning. This marine layer has had limited affect, transferring very little moisture to the fuels. The heavier 100- and 1000-hour fuels and thick duff layer continue to burn due to the persistent dry pattern the region is experiencing. Fire spread is mainly active backing, flanking and rollout, causing slopovers and short range spotting. Probability of ignition is 35%

Above 1500 foot elevation: The upper elevations will have less moisture recovery overnight and the fire will remain active further into the overnight hours. Once the air clears, expect an increase in activity and potential spotting. The fire will continue to burn with active flanking, backing and roll out along with occasional single tree torching due to heavy fuel loading and steep topography. Spotting potential is 400 to 600 feet. Probability of ignition is 45%

AIR OPERATIONS: Smoke and marine layer may remain over the fire for much of the day.

Sunset: 19:43 Sunrise: 06:35

SAFETY

- Weather is getting hotter and drier. Watch for poor overnight humidity recovery at the upper elevations
- Fire weakened trees and branches continue to release, falling with little warning and can easily block roadways.

ALL	COVID-19	<ul style="list-style-type: none"> Complete daily COVID-19 screening process. Wear mask over nose and mouth/wash and sanitize hands often. Maintain social distancing. 	
ALL	FIRE BEHAVIOR / RE-BURN	<ul style="list-style-type: none"> Prepare for slope reversal and wind shifts. Be aware of preheated canopy and potential for re-burn. 	
ALL	WILDLAND URBAN INTERFACE	<ul style="list-style-type: none"> Steep narrow access and egress. Old redwood septic tanks, deep wells and LPG tanks. Be aware that civilians continue to be present in the fire area. 	
ALL	DRIVING HAZARDS	<ul style="list-style-type: none"> Watch your speeds. "PLEASE SLOW DOWN". Drive defensively! Expect the unexpected. Watch for road degradation and dusty conditions. Be aware of falling/rolling trees and debris in the roadways from fire activity, wind and suppression operations. 	
ALL	WEATHER	<ul style="list-style-type: none"> Be aware of changing wind and other weather conditions. 	
ALL	FIRING OPERATIONS	<ul style="list-style-type: none"> Ensure plan is in place and communicated. Follow the Fire Operations Checklist. Utilize Risk Management Process IRPG (p. 1). 	
ALL	POWER LINES	<ul style="list-style-type: none"> Be cautious of down lines. Make appropriate notifications if found. 	
ALL	HYDRATION/NUTRITION	<ul style="list-style-type: none"> Drink water before, during and after each shift. Be alert for signs of heat stress in yourself and others. Maintain proper caloric and nutritional consumption. 	
ALL	FIRE AND DROUGHT WEAKENED TREES/SNAG HAZARDS	<ul style="list-style-type: none"> Situational awareness for falling trees and limbs while working, driving, and parking. Follow Hazard Tree Safety Guidelines (IRPG p. 22). Flag off cat faced trees and deep stump holes. 	
ALL	CIVILIAN PRESENCE	<ul style="list-style-type: none"> Watch for civilian traffic. If approached, please defer them to your chain of command. 	
ALL	COMMUNICATIONS	<ul style="list-style-type: none"> Check the communication plan for frequency assignments. Use human repeaters as needed. 	
ALL	BRIEFINGS	<ul style="list-style-type: none"> Make sure everyone gets a briefing on the plan for the day. Document this on your ICS 214.

ALL	HEAVY EQUIPMENT/TREE FELLING	<ul style="list-style-type: none"> Be watchful around heavy equipment, they may not see you. LCES, size up and mitigate concerns, work within your limits.

Fire and COVID-19 Briefing Checklist

Self-Awareness / Screening

- Immediately separate yourself from others.
- Notify supervisor if you or others experience:
 - Cough, more than expected
 - Shortness of breath or difficulty breathing
 - New loss of taste or smell
 - Fever ○ Sore throat
 - Chills ○ Muscle pain
- Review and follow crew and division plans to isolate, triage, and transport symptomatic personnel.

Hygiene on the Fireline

- Properly wash or sanitize your hands often, especially before and after eating or entering a public place, and after coughing or sneezing.
- Avoid handshakes and communal use items.
- Maintain a supply of hand sanitizer and hand wipes. Inform supervisor of needed resupply.
- Disinfect high touch surfaces often:
 - Radios, phones, doors, pumps, fuel cans, etc.

Social Distancing and Protective Equipment

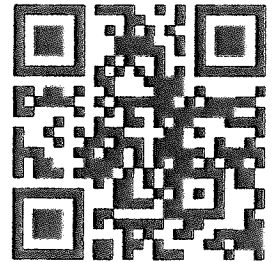
- Initiate, practice, and remind others of social distancing.
- Conduct briefings and conversations outdoors and at least 6 feet apart.
- Utilize face coverings as a tool when practical.
- Clean or replace dirty face coverings, equipment, and PPE.

Communications

- Inspection (if one was done)
- Shift Tickets (signed by you and your incident supervisor) / CTRs (signed by your incident supervisor)

Federal Employees:

As of right now, we are not planning to create OF-288s for Federal “regular” employees. Each of you can utilize your CTRs as your backup documentation for submitting your time sheets.

IF, however you require an OF-288, we will do our best to accommodate your needs. If you are claiming Hazard Pay, just like always, you must provide a justification for the claim (“H=Hazard”) is NOT enough. Use “action verbs” to explain what/why you are claiming the hazard.

WHEN YOU ARE CLOSE TO DEMOB:

- Give Finance a “Courtesy Email” 1-2 days prior to make sure all your documents have been received.
- Submit all time documentation (including travel home) ahead of demob.
- Send an email the morning of your demob to the Support email so the demob process can be started from the virtual finance group.

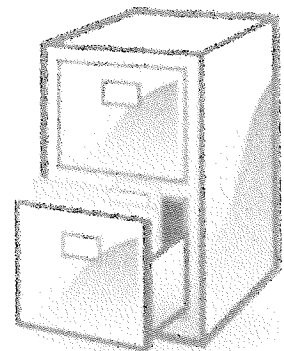
Strike Team Leaders only submit one 214 for your resource and not multiple Unit Logs for each engine.

FIRING PLAN AND GO / NO GO CHECKLIST

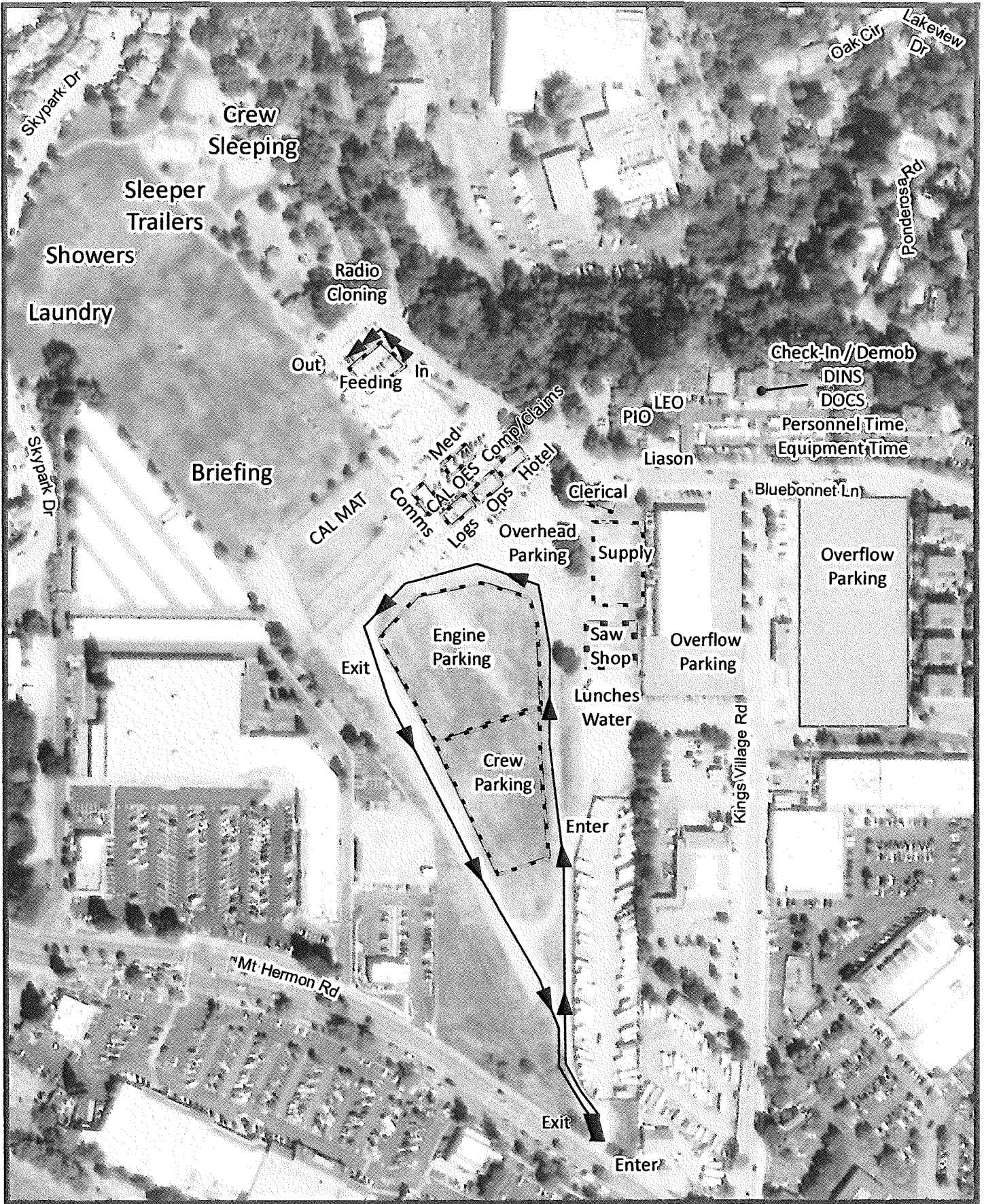

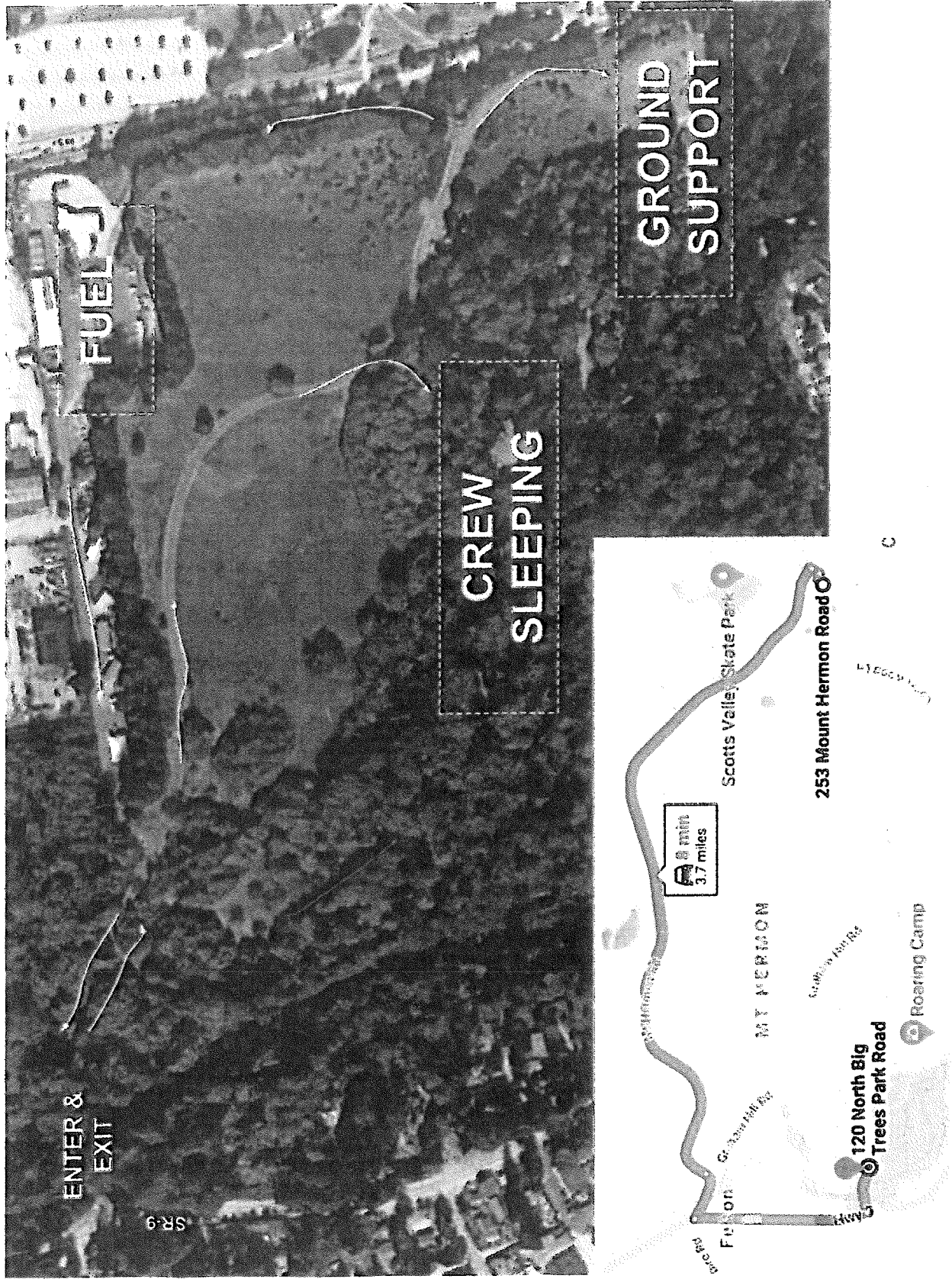


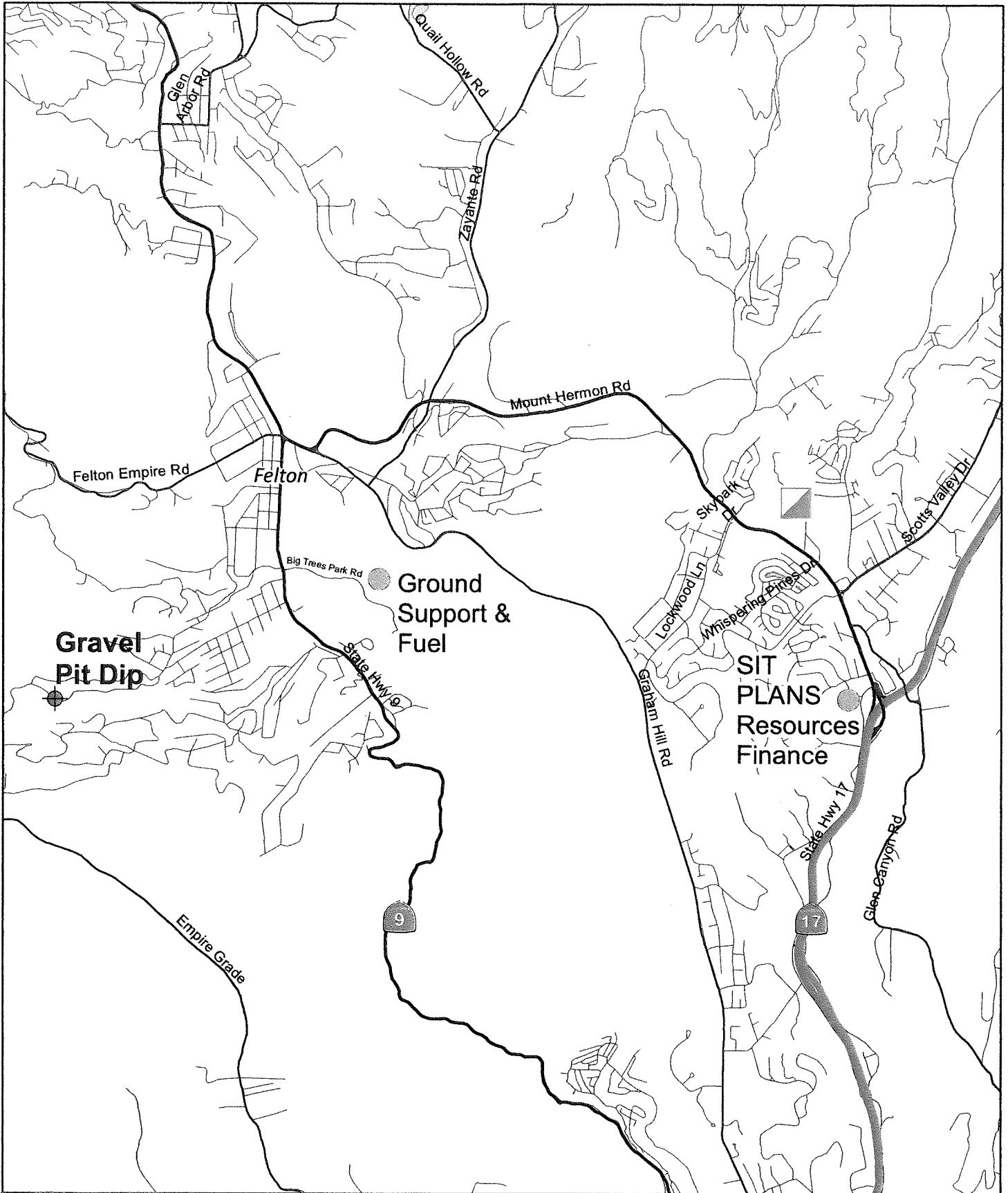
CZU LIGHTNING COMPLEX

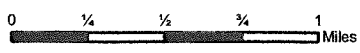


CZU Lightning – Crew Sleeping Area Directions



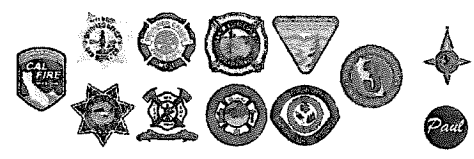


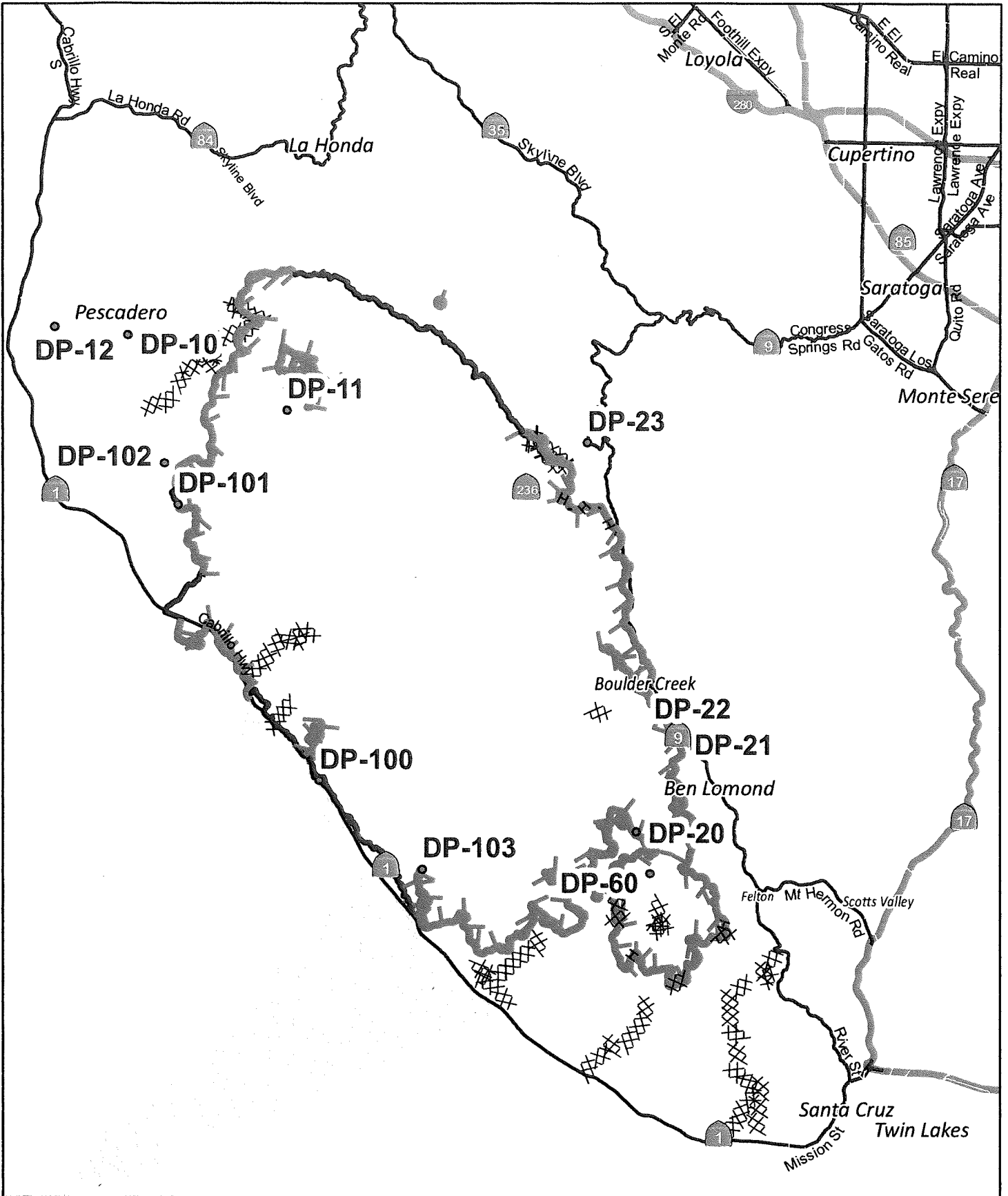
