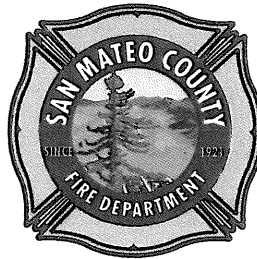
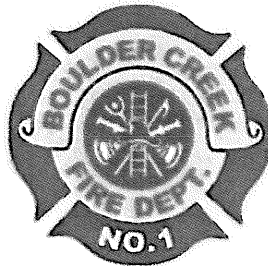

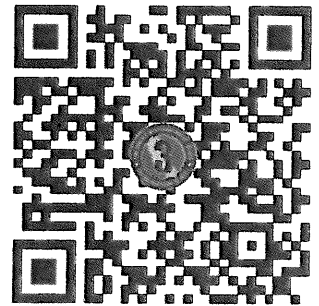

**3. Objective(s):**

**Strategic Objectives**

A full suppression strategy is to be implemented on the CZU Lightning Incident. Values at risk associated to the incident include human safety, private property and associated improvements, electrical power infrastructure, and cultural values. Minimize acres burned on all lands by utilizing effective and efficient strategies and tactics while maintaining safety first.

**Leaders Intent**

Work effectively with cooperative partners in a unified command structure towards a common goal of protecting values in a safe and efficient manner. All incident assigned personnel should be prepared to take the appropriate actions regarding:

- Professional behavior, conduct, and timely / effective communications
- Personal safety and safety of others, including driving slowly, safely and defensively
- Implementation of tactics that offer a high probability of success
- Manage fatigue by taking breaks and maintaining work rest cycles
- All line supervision personnel including crew and striketeam leaders must attend the morning Operational Briefing

**Management Objectives**

- Fight fire aggressively while maintaining safe work practices to minimize threats to the public and emergency responders, all actions and efforts will focus on safe-guarding the citizens and resources of Santa Cruz and San Mateo counties
- Ensure evacuation and repopulation occurs in safe, efficient, and effective manner
- Ensure COVID-19 precautions and best practices are met always
- Minimize damage to structures, private property and other improvements in the fire area
- Protect natural, cultural, and heritage resources
- Continue to foster and maintain positive relationships with all local cooperators and stakeholders
- Provide timely and accurate incident information
- Maintain fiscal accountability keeping costs commensurate with values at risk

**Control Objectives**

- Keep the fire North of Highway 17
- Keep the fire South of Highway 92
- Keep the fire East of Highway 1
- Keep the fire West of Interstate 280

**General Situational Awareness:**

Steep and rugged terrain, critically dry and receptive fuel beds, active area for fire history and drought stressed trees.

Stop, Think, Organize, Proceed

In the COVID-19 environment, high density populations or large groups are particularly at risk. To help protect yourself, your family and to ensure all employees return home safely, make sure to practice social distancing.



## CZU Lightning Fire Weather Forecast

### WEATHER DISCUSSION:

A deep marine layer continues to affect the coast and San Lorenzo Valley this morning with fog and stratus, burning off around mid-day in the San Lorenzo Valley. Stratus will hang along the coast through the day. We will continue to see warming and drying over the next few days as high pressure strengthens over California. Thermal belts will continue to dry out each night with good recovery below the marine layer. The marine layer will push in again tonight up to 1500ft with coastal fog pushing into the San Lorenzo Valley once again. Temperatures will become above normal by the second half of the week with very dry conditions, increasing northwest winds, and a shallower marine layer.

### WEATHER FORECAST SUNDAY:     ...WARMER AND DRIER IN THE UPPER ELEVATIONS...

**WEATHER:** Valley fog burning off by mid-day. Mostly sunny with smoke. Coastal fog through the day.

**TEMPERATURES:** Highs 60-75 below 1500ft.... 75-85 above 1500ft.   **LITTLE CHANGE**

**HUMIDITY:** 35-50% below 1500ft... **20-35% above 1500ft.   10% DRIER**

#### **20 FT WINDS:**

**ABOVE 1500ft** – Southwest 5-10 mph. Gusts up to 15 mph.

**BELOW 1500ft** – Southwest 5-10 mph. Gusts up to 15 mph.

**BELOW 1500ft** – Downslope-downvalley 3-6 mph.

**MARINE LAYER:** up to 1500ft.

### INPUTS

#### WEATHER SUMMARY

Marine influence will have less influence over the upper elevations of the fire. Lower elevations will continue with the marine layer influence. A warming and drying trend continues and will become much hotter and drier into late next week. Light winds over the fire area from the Southwest

### OUTPUTS

#### FIRE BEHAVIOR

**GENERAL:** The fuels in the fire area are made up of a heavy timber mix of Hardwoods and Coastal Redwoods along with thick litter and some intermixed grass and brush. The region is experiencing moderate to severe drought due to rainfall for the area at about 50% of average with the last recorded wetting rain occurring more than 90 days ago. The heavier 100 and 1000-hour fuels and thick duff layer continue to burn due to the persistent dry pattern the region is experiencing. Fuel moistures in the brush are at critical levels, and the 100-hour fuels are around 10% with the 1000-hour fuels moistures around 8%. Heavy dead down fuels will be consumed near 100% leaving deep seated heat in ash pits and large burned out stump holes

ERC currently at 80% for Dense Conifer fuels, but is trending up

#### SPECIFIC:

Below 1500 foot elevation: The marine layer and smoke will be over the fire for these areas for the first part of the shift, burning off midday. This marine layer is affecting the lighter fuels and moderated fire activity. Fire spread is occurring mainly in the North Zone with active backing, flanking and rollout, causing slopovers. Deep seated heat in the duff layer continues to smolder and uncontrolled edges of Interior islands and pockets will continue to burn, and may cause ember production and control issues. Probability of ignition is 40%

Above 1500 foot elevation: Active creeping and smoldering ground fuels can burn through control lines in dirty burn areas loaded with thick duff. Widespread isolated heat signatures are still showing in most areas still with heavier ground fuels consuming near 100%. Fuel orientation is changing with trees and brush falling over stump holes and smoldering duff layers. Probability of ignition is 50%

**AIR OPERATIONS:** Smoke and marine layer may remain over the fire for a good portion of the morning, should burn off midday.

Sunset: 19:39 Sunrise: 06:37

#### SAFETY

- Weather is getting hotter and drier. Watch for poor overnight humidity recovery at the upper elevations
- Be aware of ash pits and stump holes across the incident, watch where you step!
- Fire weakened trees and branches continue to release, falling with little warning and can easily block roadways.

- Leaders attend operational briefing and brief every firefighter every shift.
- Weather is getting hotter and dryer. Drink water and maintain proper nutrition.

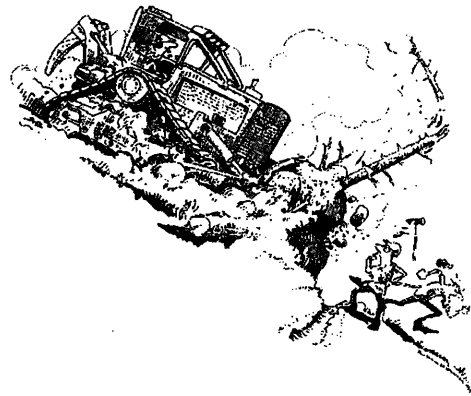

## Fire and COVID-19 Briefing Checklist

### Self-Awareness / Screening

- Immediately separate yourself from others.
- Notify supervisor if you or others experience:
  - Cough, more than expected
  - Shortness of breath or difficulty breathing
  - New loss of taste or smell
  - Fever                      ○ Sore throat
  - Chills                      ○ Muscle pain
- Review and follow crew and division plans to isolate, triage, and transport symptomatic personnel.

### Hygiene on the Fireline

- Properly wash or sanitize your hands often, especially before and after eating or entering a public place, and after coughing or sneezing.
- Avoid handshakes and communal use items.
- Maintain a supply of hand sanitizer and hand wipes. Inform supervisor of needed resupply.
- Disinfect high touch surfaces often:
  - Radios, phones, doors, pumps, fuel cans, etc.

### Social Distancing and Protective Equipment

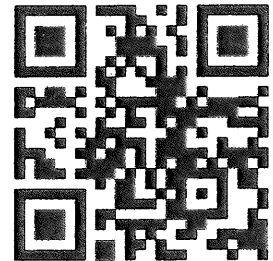
- Initiate, practice, and remind others of social distancing.
- Conduct briefings and conversations outdoors and at least 6 feet apart.
- Utilize face coverings as a tool when practical.
- Clean or replace dirty face coverings, equipment, and PPE.

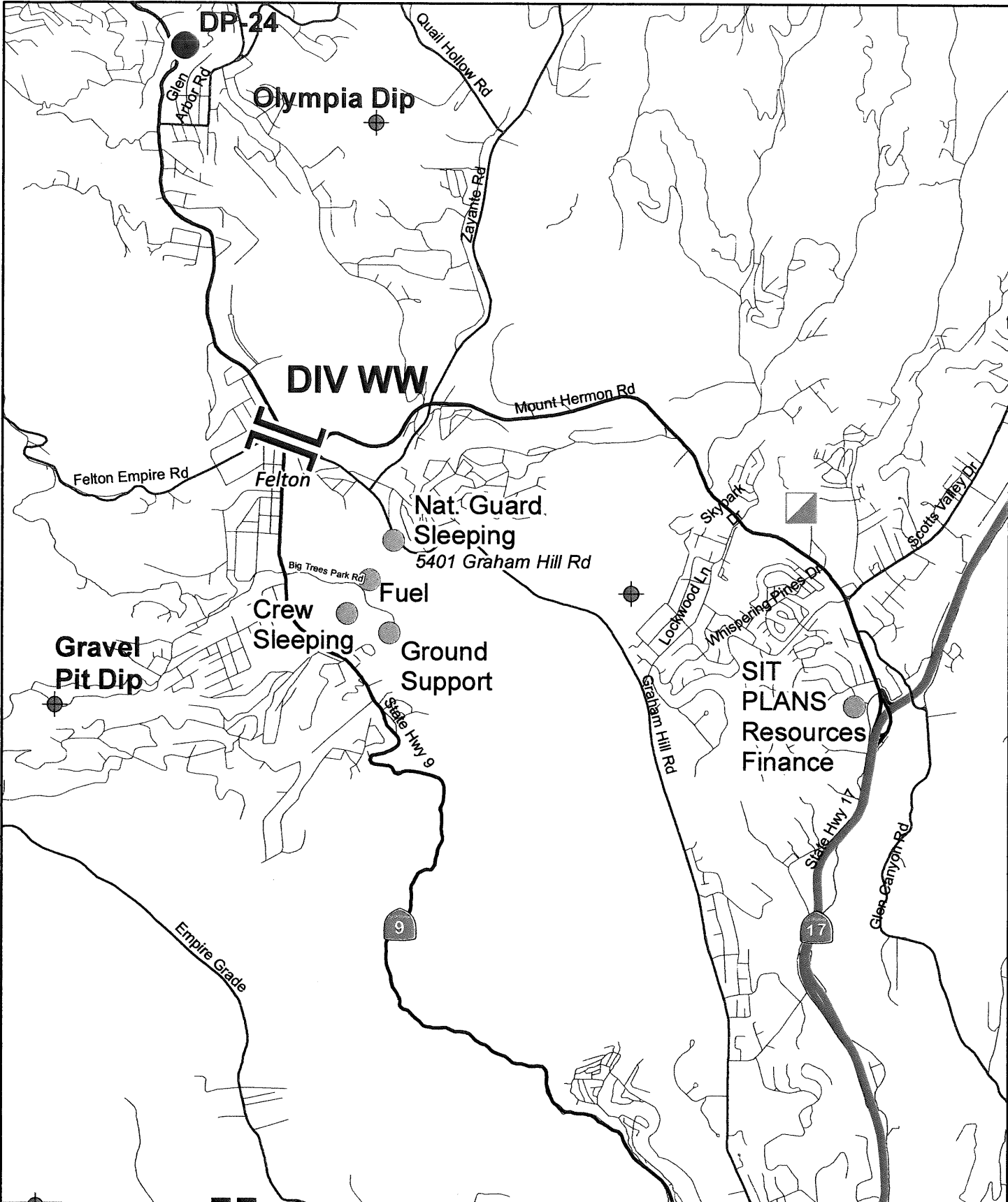


**CZU LIGHTNING COMPLEX

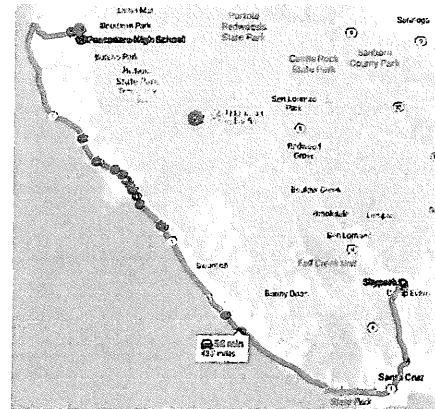

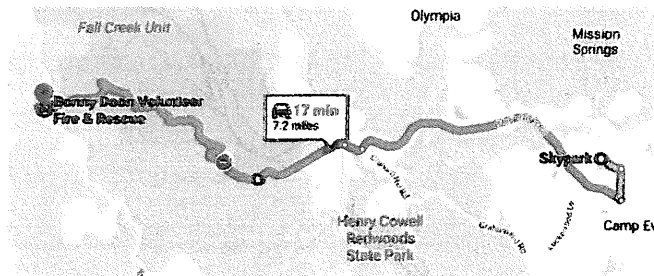

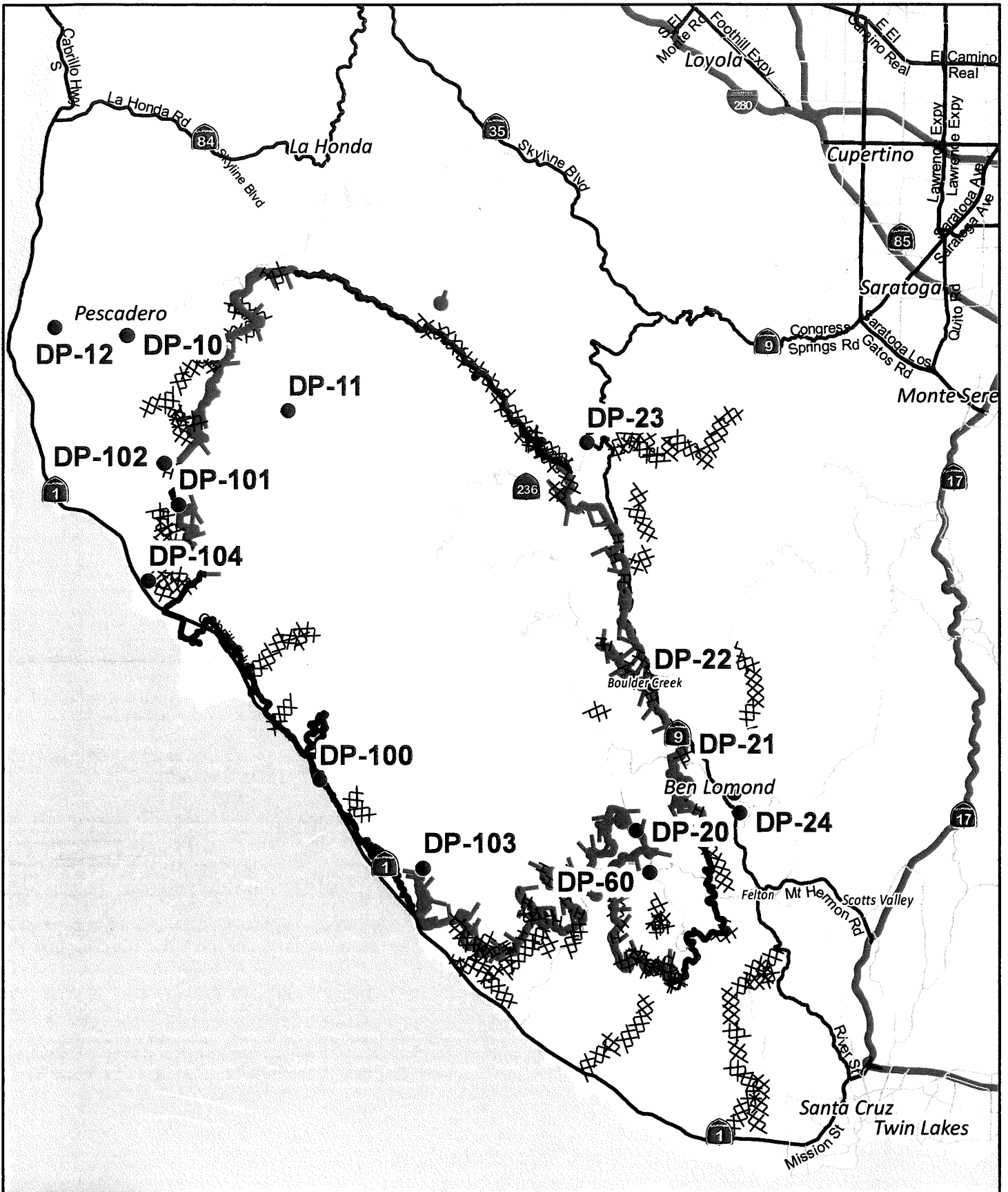
