

WEATHER DISCUSSION: High pressure will provide a short stretch of clear sky and moderate winds. Depending on how clear and calm conditions are overnight, early morning lows will be either chilly (low to middle 30s), or *very chilly* (middle 20s). In the afternoons however, full sun will easily warm temperatures into the 50s at the highest elevations in the fire area and all the way into the 70s in the warmest valleys down low. Because of this temperature difference and the lower general wind speeds, look for local terrain-driven to battle with the general winds, and the terrain winds may often become the dominant wind.

TODAY: Sunny and dry, with winds generally out of the east around 10 mph. The strongest gusts down east-west aligned valleys and drainages may reach to around 15 mph.

High Temperatures: Valley/Drainages: 72-79° Mid-Slope (4500-5500 ft): 67-75° Ridges (> 5500 ft): 58-63°
Minimum Relative Humidity: Valley/Drainages: 12-20% Mid-Slope (4500-5500 ft): 12-20% Ridges (> 5500 ft): 15-25%
General Winds: Valleys and Lower Slopes: Light, downslope/downvalley winds becoming upslope/upvalley around midday, becoming 5-10 mph. Gusts up to 15 mph.
Upper Slopes and Ridges: Light and variable early, with terrain-driven winds emerging after 0900. Afternoon wind speeds 5-10 mph with gusts to around 15.

Stability: Nighttime inversion lifting after 1000 with afternoon mixing heights 4000 ft AGL.

Chance of Precipitation: 0% LAL: 1 Transport Winds: Light and variable.

TONIGHT: Mostly clear and chilly with nocturnal downslope/downvalley winds prevailing.

Low Temperatures: Valley/Drainages: 28-34° Mid-Slope (4500-5500 ft): 32-40° Ridges (>5500 ft): 27-38°
Humidity Recovery: Valley/Drainages: 70-80% Mid-Slope (4500-5500 ft): 50-60% Ridges (> 5500 ft): 45-60%
Winds: Valleys/Drainages: Terrain-driven winds dominate most of the night. Southeasterly general winds develop by midnight, with light conflicting winds less than 5 mph through morning.
Slopes and Ridges: Terrain-driven winds dominate most of the night. Southeasterly general winds develop by midnight, with light conflicting winds less than 5 mph through morning.

Stability: Nighttime inversion developing by 2300.

Chance of Precipitation: 0% LAL: 1 Transport Winds: N-NE 5 mph

SATURDAY: Another sunny day with a chilly start and a warm, dry afternoon.

High Temperatures: Valley/Drainages: 74-82° Mid-Slope (4500-5500 ft): 67-76° Ridges (> 5500 ft): 62-69°
Minimum Relative Humidity: Valley/Drainages: 12-20% Mid-Slope (4500-5500 ft): 12-20% Ridges (> 5500 ft): 15-25%
General Winds: Valleys and Lower Slopes: Terrain driven winds around 5 mph through the day. Switching from downslope/downvalley to upslope/upvalley around noon.
Upper Slopes and Ridges: Downslope winds around 5 mph becoming upslope after 1000, increasing to 5-10 mph with gusts to 15 in the afternoon. SW winds develop to overcome terrain-driven winds late in the afternoon or early Saturday evening.

Stability: Nighttime inversion lifting after 0800 with afternoon mixing heights 6000 ft AGL.

Chance of Precipitation: 0% LAL: 1 Transport Winds: Light and variable.

Extended Outlook: High pressure controlling the above forecast periods will exit the region as a new area of low pressure moves onshore for Sunday. In response, winds will become strong and gusty on Sunday. Areas most exposed to southwest winds (eg Southwest-Northeast oriented valleys) will see the strongest winds, which may reach to around 25 mph sustained with gusts to around 40 mph. Increased clouds will keep temperatures a bit cooler than Saturday, and a chance of some light showers will trail these winds late Sunday night. This disturbance will move on as quickly as it appeared, but is only part of pattern of unsettled weather that is expected to continue through the rest of next week.

- Sunny, warm and dry with breezy easterly winds
- Max. Temps. 65-75°
- Min. RH: 15-25%. Max. nighttime RH recovery: 50%
- Winds: Easterly with gusts 15-18 mph after in the afternoon

FIRE BEHAVIOR

GENERAL:

Northeast California Energy Release Component is about 50

- **Expect very little fire activity** with a few isolated areas of smoldering and creeping in unburned interior islands, dozer berms, stumpholes and post-burn needlecast.
- **Fuels are grass, brush and timber** - Scott and Burgan fuel models GS2, SH3/4/9, TU1/5 and TL 6/9. 1000-hour fuel moistures are **DRY**, < 10% and live fuels are 60 – 75%.
- **Topography is widely varied** including mountain peaks, hills, benches meadows and drainages. The elevation ranges from 4000' to over 8000' in Lassen Park. All aspects are represented and slopes range from 0 to over 80%.

SPECIFIC FIRE BEHAVIOR:

Very low fire behavior and potential. Some smoldering hotspots still remain within the fire perimeter. Primary concern is for any new starts outside the fire perimeter that could flare-up under moderately strong, warm, dry afternoon winds.

West Zone: Only a few areas of isolated heat with an occasional smoke visible, but no threats to containment lines are expected.

East Zone: Very little heat evident. There may be some hot stumpholes and buried dozerline heat remaining. Very light smoke may be visible well interior with no threats to containment lines anticipated.

Maximum Fire Behavior (new starts or outside of containment lines with sustained eye-level winds up to 15 mph):

- Surface Flame Lengths
 - Grass: 3-6', Brush: 5-9', Timber: 3-6'
- Surface Rates of Spread
 - Grass: 9-27 chs/hr, Brush: 13-40 chs/hr, Timber: 5-11 chs/hr
- Spotting Distance: 0.1-0.4 miles
- Probability of Ignition: 60+%

AIR OPERATIONS

- No weather or fire behavior issues anticipated for aviation operations.

SAFETY

- Watch for hot stumpholes and **rekindle potential** in areas of continuous, post-burn long (pine) needlecast or partially burned brush patches.



The Swiss cheese model of accident causation illustrates that, although many layers of defense are between hazards and accidents, there are flaws in each layer that, if aligned, can allow the accident to occur.

- Invulnerable – This can't happen to us
- Anti-authority – Disregard of the team effort
- Impulsive- Do something even if its wrong
- Macho- Trying to impress or prove something
- Complacent-Just another routine fire
- Resigned-We can't make a difference
- Group Think-Afraid to speak up or disagree

If we deny this pain, and the sources, they produce unnecessary heat in our minds while we work in dangerous environments. Before you lead your crews today do an honest evaluation of what you must compartmentalize so that it doesn't impact how you lead them. Don't fear emotion and be mature enough to cry, scream, and be sad...in other words get it off your chest when it rises and then put it back in the box when the pain is gone to improve individual and collective situational awareness.

Take Home Message:

Compartmentalize to avoid allowing your personal pain from affecting the team.
