

### Safety Thought:

### "MODULE AS ONE"

Module as One should be used by crews and modules to reduce exposures to COVID-19 and other sickness from outside resources or the public. Face coverings must still be worn within the module when operating in close quarters EXCEPT when alone, when outside and able to maintain at least 6-feet of distance, or actively engaged in firefighting on the fireline.

### Key Points:

- *Exposing yourself could mean also exposing your module and your family*. Crews and modules should limit close contact with other resources and the public on incidents to insulate their module. When coming into close contact or riding in vehicles, all resources should wear cloth face coverings or masks. While the practice of handshaking, hugging, or any physical contact is a deeply rooted etiquette within the United States, this practice should be avoided to reduce further potential for disease transmission.
- *Further reduce exposure by identifying select individuals on your crew or module that will pick up meals and supplies, interact with the public and enter ICP.* Ensure these select individuals protect themselves by using face coverings, physical distance, and good hand hygiene during every interaction. This is especially important when working in or traveling through an area with high community transmission.


