WEATHER DISCUSSION: ...RED FLAG WARNING UNTIL 800 PM THIS EVENING...
CRITICAL FIRE WEATHER conditions are expected through this evening. Southwesterly and upvalley winds will gust 20-30 MPH this afternoon and evening, before diminishing overnight. Relative humidity will drop to the 8-16% range today with moderate recovery tonight.

WEATHER FORECAST:

WEATHER: Mostly sunny. Areas of smoke.

MAX TEMPERATURES: Ridges/Upper Slopes: 76-84.
 Valleys/Lower Slopes: 82-92.

MIN HUMIDITY: 8-16%.

RIDGETOP - Southwest 5-10 MPH, increasing to 10-20 MPH with gusts 25-30 MPH in the afternoon. Isolated gusts 35 MPH possible along well exposed ridges.



EXTENDED OUTLOOK: For Friday and Saturday, warmer temperatures are expected with slightly lower relative humidity. Winds will be weaker with southwest/upvalley winds expected each afternoon. On Sunday, slightly cooler conditions with slightly higher relative humidity is expected.

FIRE BEHAVIOR

Red Flag Warning expiring at 2200. Potential for large fire growth and spread. The North and Northeast areas (DIVs N,O,P) of the fire are wind prone, prepare for spotting and resistance to control. Expect all fuels to be available for ignition, both live and dead. Open line is subject to strong SW winds and spotting. Fire activity has shown to increase at approximately 1200 and intensify around 1400 to 1500. Anticipate crown fire when alignment exist.

SPECIFIC FIRE BEHAVIOR:

Branch XX

Division N: Expect active fire behavior in the Wolf Creek area. Surface fire, group torching and spotting.

Division O: Anticipate active fire behavior in the Williams Valley, Pecks Valley and Keddie Ridge, Surface fire runs, torching and crown fire with alignment. Spotting potential from SW winds (1-1.5 miles)

Division P/Q: Expect active fire behavior in the North Canyon and Hunodim Peak area. Heavy fuel with dense canopy. Potential crown fire runs with alignment.

Greenville Contingency

Potential for active fire behavior similar to Division O to include structure defense.

Evens Fire Minimal Activity, interior smoldering

Branch XXIII

Division R/U/V: Minimal activity, interior smoldering.

Division W: Minimal activity, interior smoldering.

Division X/Z: Minimal activity, interior smoldering

Meadow Valley

No fire behavior expected.

Night Branch

Mild temperatures and low RH in the beginning of the shift. Red Flag Warning (RFW) expiring at 2200. Expect RFW conditions to remain for several hours into the shift. Moderate RH recovery on ridge tops (up to 45%) and valleys (up to 65%). Potential to secure containment lines with the improved conditions. Be mindful of wind shifts and speeds due to topographical features. The shift will start with a Pig of 70-80% diminishing after sunset. Expect fire activity to diminish in the morning hours.

See Something Say Something, Communicate Safety!

- **Take Charge** of assigned resources.
- **Motivate** firefighters with a “can do safely” attitude.
- **Demonstrate Initiative** by taking action in the absence of orders.
- **Communicate** by giving specific instructions and asking for feedback!
- **Supervise** at the scene of the action.

Module as One

- Same as “module as a crew/family. Same people travel together for the season. No need to physical distance within the crew.
- A “close contact” is defined as less than 6 feet, for at least 15 minutes with or without face coverings/mask.
- On the fireline; the **Fire** is the focus. Try not to co-mingle close (less than 6’ apart) from other personnel.
- In camp, **coronavirus** is the focus. **Use face coverings** and physical distance in common areas such as briefing areas, chow line, shower area etc.

Driving

- When driving keep the speed at or below the posted speed limit and turn your headlights on.
- Is the posted speed limit a safe speed under the current conditions and traffic?
- **Use caution on unimproved roads as some have soft shoulders. Some roads are also only one lane with pullouts!**
- Road surfaces are variable with washboard conditions and thick dust that can compromise turning and braking.
- Watch for and anticipate stock and wildlife especially from dusk to dawn.
- Always fasten your seat belt before the vehicle is set into motion. Use backseats.
- Don’t tail gate, especially in dusty conditions.
- Slow down, slow down, and slow down!

Hazard Tree Indicators

- Tree burning for any period of time.
- High risk tree species (rot and shallow roots).
- Numerous downed trees.
- Dead, broken, or burning tops and limbs overhead.
- Accumulation of needles, bark, or limbs.
- Leaning or hung-up trees.
- Eliminate the hazards with qualified sawyers and modify suppression tactics or fireline location to avoid high risk areas.
- Always provide timely feedback to others regarding any hazard trees sufficient for tomorrow.

Dixie Fire East Zone COVID-19 Prevention & Mitigation Expectations

- All incident personnel will follow all local, State and CDC guidelines for COVID-19.
- As you travel through the local communities proximal to the fire, be mindful of the communities in the State of California, by wearing a face covering and social distancing in public areas.
- Incident personnel are expected to comply with the following incident guidance:
 - **Everyone follow** COVID-19 prevention and mitigation guidance for un-vaccinated individuals regarding physical distancing and mask/face covering use in fire camp unless alone in an enclosed space or actively engaged in firefighting on the fire line.
 - **Utilize Module-as-one concepts** to reduce the risk of transmitting the novel Coronavirus. This limits “close contacts” to those within the module. A “close contact” is defined as less than 6 feet, for at least 15 cumulative minutes in a 24-hour period with or without face coverings/masks.
 - **Social Distancing.** Maintain a minimum of 6’ physical distancing, especially from those outside of your module-as-one.
 - **Face Coverings.** Face coverings are required to be worn, **in the appropriate manner covering nose and mouth**, when at ICP and camps. Outside of camps, all incident personnel will wear a face covering when social distancing is not possible, especially with those outside your module-as-one.
 - **Wash your hands.** Wash your hands often with soap and water for at least 20 seconds, especially after blowing you nose, coughing or sneezing. If soap and water are not readily available, use a hand sanitizer that contains at least 60% alcohol. Do not use hand sanitizers containing methanol or 1-propanol. Cover all surfaces of your hands and rub them together until they feel dry. Avoid touching your eyes, nose and mouth with unwashed hands.
 - **Clean and disinfect** vehicles and equipment. Disinfect all high-touch surfaces frequently, such as radios, phones, door handles, etc.



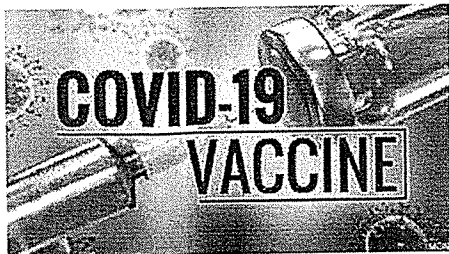

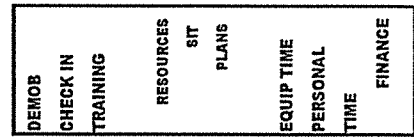
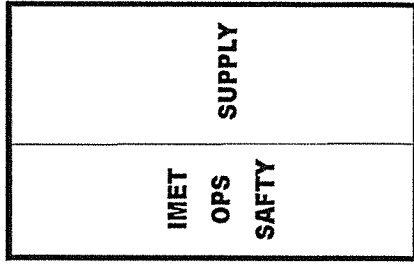
