

Minimize acres burned on all lands by effective and efficient firefighting efforts that offer the highest probability of success while maintaining safety first.

Work effectively with cooperative partners towards a common goal of protecting values in a safe and efficient manner. All incident assigned personnel should be prepared to take appropriate actions regarding:

WEATHER DISCUSSION: A mix of widely scattered wet/dry thunderstorms with erratic wind gusts and lightning are expected this afternoon. Highs are forecast in the mid to upper 90s, with a few locales experiencing triple digits, and min RH in the mid teens. Southwesterly upvalley winds will gust around 15 mph this afternoon, but expect gusty and erratic winds to be generated by any nearby storms. Overnight recoveries will be moderate.

FIRE BEHAVIOR

HIGH RISK BURN ENVIRONMENT due to forecasted thunderstorms. Potential for ground strikes. Ridge top winds were measured at 41 mph as the thunderstorm past the previous shift (Red Hill Lookout west of Twain). Expect resistance to control and erratic fire behavior due to downdrafts. Be mindful of your location on the landscape and review the 30/30 rule in the IRPG. Fire behavior will remain active under the smoke inversion and anticipate increased fire behavior in clear air.

SPECIFIC FIRE BEHAVIOR:

Branch XX

Evans Group: Expect active fire behavior in the Wilcox Valley area to include surface fire and potential for torching and spotting. Wind prone area, fire intensity can increase suddenly.

Dyer Group: Moderate fire behavior, fuel driven flanking fire near Coyote Peak, moving at a slow ROS towards Hamilton Mountain. Moderate activity on Dyer Mountain, interior smoldering with potential for spotting due to alignment.

Hunt Group: Flanking fire in Hunt canyon and Keddie Ridge down to Keddie Point.

Branch XXV

Division QQ: Moderate activity, interior smoldering and flanking in the Hunt Canyon area.

Division RR/WW/XX: Minimal activity, interior smoldering.

Night Branch

High risk burn environment due to forecasted thunderstorms into the late evening. Potential for ground strikes and downdrafts. Mostly clear with areas of smoke. Moderate to good RH recovery (up to 65%). Improved conditions should provide opportunities to reinforce containment lines and reduce spotting potential. Fire behavior should moderate in the late evening. The shift will start with a higher probability of ignition as a slightly warmer Day Shift is forecasted. Inversion developing after 2100.

Foot Travel in Steep Terrain

- When walking through steep and rocky terrain, watch footing and maintain proper spacing.
- Identify safe routes and local conditions.
- Test and use secure footing.
- Watch for over-head hazards, carry tools on downhill side, and wear gloves.
- Treat “hot spots” on feet before they become blisters.

Firing Operations

Have a firing operation plan in place.
Brief all resources in firing operations, have firing teams and holding resources identified.

- Post adequate Lookouts.
- Have a good starting and ending point for firing.

- Wear and use all PPE.
- Know what your fire is doing at all times.

CIRCLE OF SAFETY:

- Walk around the vehicle.
- Check the windshield, wipers, and wiper fluid level.
- Keep windows, mirrors, and lights clean to better see and be seen.
- Check headlights, turn signals, tail lights, reflectors and running lights.
- Adjust mirrors.
- Check front and back tires (including wheels and lug nuts).
- Under the hood, check all fluid levels and especially the Air Filter

STATISTICS

- NFPA estimates 65,880 FF injuries occurred in the line of duty in 2017
- An estimated 45% of those injuries occurred during fire-ground operations
- The leading injuries during fire-ground operations involved injuries such as sprains, strains, and muscular pain attributed to fatigue
- An estimated 19% of those injuries involved loss of work
- Injuries are more prevalent between the hours of 2:00 and 5:00 PM



Assessing Risk

With all the inherent dangers already present in firefighting positions, the risks you encounter when off the clock must pale in comparison but – they’re still there, and worth paying attention to.

While we’re all here, all of us have the responsibility to be able to respond and report to duty if necessary. We need to be technically and tactically proficient in the event of an emergency on top of an emergency, and we can’t do that if we’re impaired. As such, there is just no place for drug and/or alcohol-related misconduct, and our position on the subject is: Zero Tolerance.

That said, the last thing anyone wants is to move forward with a premature demobilization action because of a few beers. We don’t need to lose anyone for this. We need firefighters out there, doing what you’ve been trained to do, because the reality is there is no one else in between the fire and the communities we’re here to help.

So, please, “look before you leap,” assess the risks (both on and off duty) before making a determination and moving forward with your plan of action.

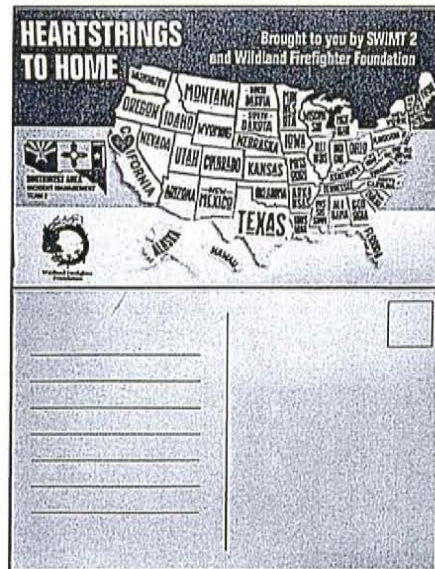

RESOURCE ADVISOR MESSAGE

Reporting of Cultural Sites

- Do not use the radio. Looters listen to our frequencies and will note where you find things.
- Grab a GPS point, bump it up the chain of command or directly inform a Resource Advisor on the line or in camp.

Stay Out!

- READs will be using flagging for areas to avoid suppression activities. Strip of red/black flagging.
- For more information, please consult with a READ.

Food & Wildlife

- Throwing away and storing food in proper containers can keep wildlife off the line which prevents encounters with firefighters as well as future harm to the animals.

Riparian Areas

- Meadows are natural barriers. Tie the line to them, not through them. If line is needed, go around and outside of the meadow to avoid damage.
- Stream and creeks will not be used as line. If needing to cross, minimize damage (i.e. on a dozer lift the blade and only track over) to prevent post-fire stability issues. Do not push or cut line through or along them.

Water Drafting Sites

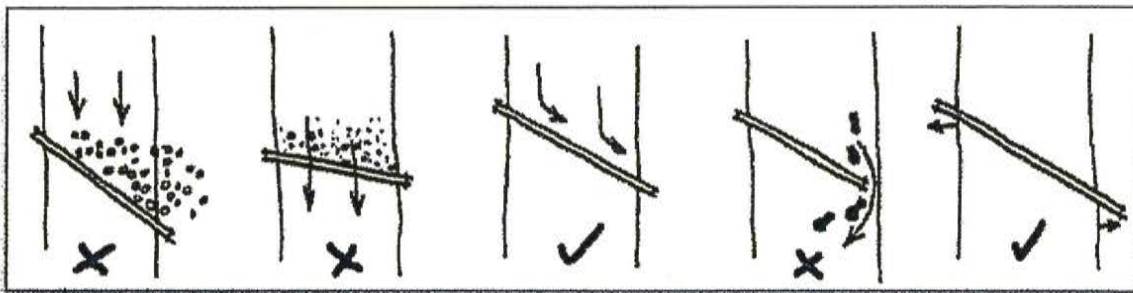
- Access the water source while trying your best to minimize damage to the soil and vegetation.
- If using a portable pump, make sure there is a spill kit and absorption pads to catch any accidental spills.
- Place portable pumps as far away as you can from the water source. Use screens on the intakes.
- Store fuel cans away from the water source and on a flat surface.

Working in the Wilderness

- Follow MIST for suppression actions.
- Utilize system trails as much as possible for travel and/or handline.
- Consult with READs for spike camps, helispots, and sling sites locations.
- Practice "Leave No Trace" as much as possible.
- Work with READs to minimize visual impacts to wilderness areas when possible.

Suppression Repair

- Utilize and coordinate with READs when implementing suppression repair plan.
- READs will determine when a line is completed by "approving" the line verbally and/or in ArcGIS Collector.
- Where the use of waterbars are applicable, see visual bird's eye view below. Questions? Ask a READ.
