Strategic Objective

Implement a full suppression strategy on the Dixie Fire. Strategy and Tactics implemented on the incident are to be prioritize utilizing life safety, community infrastructure defense, and natural/cultural values as a guiding principal. Minimize acres burned on all lands by effective and efficient firefighting efforts that offer the highest probability of success while maintaining safety first.

Leaders Intent

Work effectively with cooperative partners towards a common goal of protecting values in a safe and efficient manner. All incident assigned personnel should be prepared to take the appropriate actions regarding:

- Professional behavior, conduct timely / effective communications
- Personal safety and safety of others, including driving slowly, safely and defensively Implementation of tactics that offer a high probability of success
- Manage fatigue by taking breaks and maintaining work rest guidelines
- All line supervision personnel including crew and striketeam leaders must attend the morning Operational Briefing

Management Objectives

- Utilize the risk management process to identify and mitigate hazards to protect first responders and the public. Emphasize strategies and tactics that have the highest probability of success and the least exposure to first responders and the public.
- Develop proactive strategies to protect life, residential properties, communities, businesses and infrastructure. Employ tactics that fulfill these strategies while being mindful of the necessity for contingency and emergency plans. Ensure strategies account for incident priorities, applying resources to those protecting life and residential properties first.
- Follow COVID-19, CDC and established local, state and federal guidance to limit virus spread within the incident and surrounding communities near the fire area.
- Provide timely and continuous incident information to affected agency partners, cooperators, California Team 1 as well as the public.
- Utilize social media and all other communications tools to keep the public well informed of the fire conditions and other pertinent information.
- Maintain fiscal accountability and keep costs commensurate with values at risk.

Control Objectives

- Keep the fire north of fire perimeter and Highway 162 and the junction on Highway 70
- Keep the fire south of Harvey Valley Road
- Keep the fire east of Mill Creek drainage
- Keep the fire west of the eastern Lassen County line

General Situational Awareness

Steep and rugged terrain, critically dry and receptive fuel beds, active area for fire history and drought stressed trees.

WEATHER DISCUSSION: Broad southwesterly winds will continue across the fire area with gusts along ridgetops up to 25 mph in the afternoon. Otherwise, expect mainly terrain driven winds in sheltered valleys under partly cloudy skies. Smoke will continue to delay rising temperatures in the morning but thinning through the afternoon is expected with the steady southwest winds. Ventilation will improve during the afternoon hours as southwest winds increase aloft but smoke will fill back in tonight as a light drainage flow redevelops after sunset.

SKY/WEATHER: Smoke and haze. A few afternoon clouds.

CHANCE OF THUNDERSTORMS: 0% **LAL:** 1.

WINDS: **Valleys:** Mainly light drainage winds in the morning. Upslope and upvalley wind 3-6 mph in the (20 FEET) afternoon, southwest 5-7 mph with gusts to 13 mph in exposed and aligned drainages.
Ridgetops: Southwest 5-10 mph in the morning, increasing to 11-16 mph in the afternoon with gusts up to 25 mph.

HAINES: 4 (low)

MIXING HEIGHT: Rising to 7,300 feet by 1700. **TRANSPORT WIND:** Southwest 15-20 mph.

VISIBILITY: One half to 1 mile in valleys in the morning. 7-9 miles in the afternoon.

INVERSION: Inversion gradually mixing out between 1200 and 1330.

WINDS: **Valleys:** West to southwest 6-10 mph in the evening with localized higher gusts in the terrain (20 FEET) favored areas, becoming downslope/down valley 2-4 mph after midnight.
Ridgetops: Southwest 10-15 mph with gusts to 20 mph in the evening, decreasing and transitioning to the west at 5-10 mph by morning.

TRANSPORT WIND: West 10-15 mph.

STABILITY/INVERSION: Moderate inversion and poor valley ventilation developing after midnight.

EXTENDED OUTLOOK: Thursday through Monday. Light winds in the wake the passing upper-level trough are expected across the fire area through weekend. A north to northeasterly wind component is expected Friday and Saturday but it will be light, less than 10 mph. A warming and drying trend will also take place with temperatures rising to above normal, poorer overnight humidity recoveries and critically low daytime humidity values. The next disturbance is expected early next week which could bring gusty southwest winds back into northern California with dry conditions persisting.

INPUTS

WEATHER SUMMARY:

Temperatures will warm to the mid 70's to the lower 80's with minimum humidity dropping to 15 to 23% during the day. Light drainage winds in the morning, becoming 3-6 mph mid-day, 11-15 mph on the ridges with gusts to 25 mph possible. Overnight the temperatures will be in the mid 30's to mid 40's with humidity recovery at 65-70%, except 55-60% in the mid slope thermal belt areas. Winds overnight will continue from the Southwest at 6-10 mph becoming downslope in the early morning hours.

OUTPUTS

FIRE BEHAVIOR

GENERAL: ****FUELS AND FIRE BEHAVIOR ADVISORY IN EFFECT FOR THE FIRE AREA****

Smoke will be over the fire, especially in the valleys and low areas before beginning to thin somewhat. Overall fire activity will be moderated by this smoke cover to begin the shift. Ridgetop winds will increase in the afternoon and thin the smoke, allowing for increases in fire activity. As the smoke thins and fire becomes aligned with topography, expect a quick increase in activity with torching and spotting. All the fuel in the area is extremely dry and receptive to ignition. Smoke conditions will affect burning conditions, if thick smoke remains over the fire, expect activity to be moderated.

SPECIFIC:

Butte Sector: Smoldering material will continue to burnout, especially in the stump holes and large dead and down. Needle cast fallen over hot material can ignite and potentially spread. Minimal heat exists in the sector, expect this to continue as mop up and patrol continues.

Lassen Sector: Fire activity should be low to moderate to start the shift, but will increase when wind speeds increase and cause thinning of the smoke. Topography in this sector is very mountainous which will channel winds and increase the probability of ember cast and spotting, especially in upper elevations or thinner tree stands. Spread rates will generally be slow to moderate, but will increase with any change of conditions, such as wind speed or slope alignment. Heavy fuels will hold heat through the night and continue to burn out, and potentially challenge control lines within Branch 9 & 16.

Clear/Lake Branch: Fire activity in this branch will be primarily smoldering and isolated ground fire. Needle cast has fallen over much of these areas, be aware of potential ground fire if the needle cast is over hot spots and stump holes.

Janesville Branch: Holdover heat in the heavy fuels, debris piles, and smoldering ground fuels is the primary activity within the Branch. Short range spotting is possible in wind aligned areas. Thinning smoke can cause intensity to increase with an increase in spotting production and distances. Limiting these spots by increasing mop up distances will be vital to holding existing control lines. Wind over the escarpment may cause swirling on the eastern face, be aware of erratic winds..

AIR OPERATIONS

Air operations may be limited early today, but smoke may clear enough by mid-afternoon for air operations.

SAFETY

- Snags and stump holes are likely in timber areas.
- Make sure to identify escape routes and safety zones early in the shift before dark.

Fuels and Fire Behavior Advisory

Northern California

August 17, 2021 to August 31, 2021



Subject: Potential for extreme fire behavior due to critically low live and dead fuel moistures, very dry conditions resulting from persistent drought, minimal snowpack and spring precipitation, and elevated fire danger rating values across much of northern California.

Discussion: Fires burning in northern California are exhibiting extreme fire growth based on critical fuel conditions. Fire spread is fuel driven and does not depend on wind to spread. Surface fuels are very receptive to embers. Long range spotting, area ignition, and group torching is occurring on large fires frequently.

Difference from normal conditions: Northern California is in a drought; currently with 90% at Extreme to Exceptional levels. The drought is expected to persist or intensify through out the fire season. Deficient rainfall and snowpack with early melt off has resulted in fuels that are below average in dryness, with record setting conditions for most areas.

Concerns to Firefighters and the Public:

- Energy Release Component (ERC) at numerous weather stations set record maximums already this year and are running at or above the 97th percentile in most cases. Expect increased fire intensity and spread rates in these areas. Early season extreme fire behavior has been observed in both light and heavy fuels. **Anticipate increased spread rates, spotting, and active nighttime burning.**
- The combination of persistent drought and record-low rainfall and snowpack amounts has led to very low live and dead fuel moistures. Low 1000-hour fuel moistures have been evidenced by complete consumption of dead fuels on recent fires. Live fuel moistures in grasses, shrubs and trees, have already reached critical levels in many areas of Northern California due to limited green-up this spring. **Expect fires to ignite easier and spread faster. Do not expect fires to exhibit reduced fire behavior when entering areas of live fuels; anticipate increased spread rates and spotting.**
- Direct attack is often not feasible under regular diurnal wind conditions with ground resources. And aviation utilization is often insufficient in moderating rate of spread without immediate heavy ground resource response. **Anticipate higher resistance to control in all fuel types.**
- Already this year, Northern California has experienced large fire activity and multiple team deployments. California will likely experience an extended fire season. It is important to be mindful of and manage fatigue for all resources. **Everyone, every day, returns home safely.**

Mitigation Measures:

- Local and inbound fire personnel need to be aware that fire behavior across the state is exceeding normal expectations for this time of the year. **Local briefings need to be thorough and highlight specific fire environment conditions. These include but are not limited to local weather forecasts, Pocket Cards, ERC's, live and dead fuel moistures.**
- Suppression actions need to be based on good anchor points, escape routes, and safety zones. **Remember LCES. Experienced lookouts are essential under these conditions.**
- Base all actions on current and expected behavior of the fire. **Augment initial attack resources as incident activity dictates.**

Area of Concern: Northern California except for the following Predictive Service Areas: North Coast and Bay Marine, west of Highway 101 in Mid-Coast to Mendocino and Diablo-Santa Cruz, and the north eastern portion of Far Eastside.

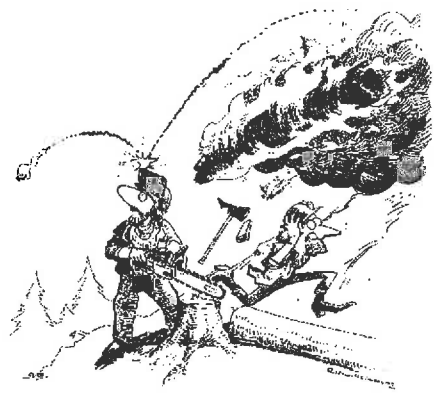

ALL	COVID 19	<ul style="list-style-type: none"> Masks are required indoors in Nevada. Wash/sanitize hands often. Maintain social distancing when applicable. <u>Unvaccinated personnel should wear masks when not socially distanced.</u>
ALL	EXTREME FIRE BEHAVIOR	<ul style="list-style-type: none"> Expect intense fire runs with plume dominated fire behavior. Long range spotting of one mile plus has been observed. Prepare for pyro-cumulus collapse with severe out flow winds in all directions.
ALL	DRIVING HAZARDS	<ul style="list-style-type: none"> Watch your speeds. Drive defensively! Expect the unexpected. Watch for road degradation, smokey, and dusty conditions. Be aware of debris in the roadways from rollout and suppression operations. Park off of the single lane roadways to allow for through traffic.
ALL	WUI HAZARDS	<ul style="list-style-type: none"> Be aware of the hazards in and around structures, including power lines, septic tanks, and narrow roads/driveways. Generators may illegally back-feed electrical lines.
ALL	PERSONNEL SAFETY	<ul style="list-style-type: none"> All personnel are responsible for their personal safety. Immediately report any suspicious activity. Be sure to wear all required PPE while on the fire line.
ALL	HYDRATION	<ul style="list-style-type: none"> Drink water before, during, and after each shift. Be alert for signs of heat stress in yourself and others.
ALL	FIRE AND DROUGHT WEAKENED TREES/SNAG HAZARDS	<ul style="list-style-type: none"> Follow Hazard Tree Safety Guidelines (IRPG p. 22). Many of the trees within the fire area and along roadways are stressed due to drought conditions and burn times.
ALL	CIVILIAN PRESENCE	<ul style="list-style-type: none"> Watch for civilian traffic. Watch for residents in and around the area.
ALL	COMMUNICATIONS	<ul style="list-style-type: none"> Check the communication plan for frequency assignments. Be clear and concise when talking on the radio. Use human repeaters as needed.
ALL	BRIEFINGS	<ul style="list-style-type: none"> Make sure everyone gets a briefing on the plan for the day. Document this on your ICS 214.
ALL	LCES	<ul style="list-style-type: none"> Ensure that LCES is being utilized.
ALL	AIRCRAFT AWARENESS	<ul style="list-style-type: none"> Be aware of rotor wash when working near helicopters. Hazard trees may respond to the impacts of aircraft.
ALL	HEAVY EQUIPMENT	<ul style="list-style-type: none"> Watch out for heavy equipment traffic! Be watchful around heavy equipment, they may not see you.
ALL	WILDLIFE	<ul style="list-style-type: none"> Wildlife including bears have been observed by fire personnel.

Fire and COVID-19 Briefing Checklist

Self-Awareness / Screening

- Immediately separate yourself from others.
- Notify supervisor if you or others experience:
 - Cough, more than expected
 - Shortness of breath or difficulty breathing
 - New loss of taste or smell
 - Fever
 - Sore throat
 - Chills
 - Muscle pain
- Review and follow crew and division plans to isolate, triage, and transport symptomatic personnel.

Hygiene on the Fireline

- Properly wash or sanitize your hands often, especially before and after eating or entering a public place, and after coughing or sneezing.
- Avoid handshakes and communal use items.
- Maintain a supply of hand sanitizer and hand wipes. Inform supervisor of needed resupply.
- Disinfect high touch surfaces often:
 - Radios, phones, doors, pumps, fuel cans, etc.

Social Distancing and Protective Equipment

- Initiate, practice, and remind others of social distancing.
- Conduct briefings and conversations outdoors and at least 6 feet apart.
- Utilize face coverings as a tool when practical.
- Clean or replace dirty face coverings, equipment, and PPE.

Communications

- Face coverings and social distancing complicate communications. Ensure effective sender/receiver messaging.

Today's Feature: Fire Beetles

- Most things run from fire with a couple of exceptions: firefighters and fire chasing beetles. Many times, they arrive together and don't usually get along. Beetles typically swarm fire areas and harass firefighters, mistaking them for burned trees in their frenzy to mate and lay eggs.
- Woodboring beetles in the Genus *Melanophila* are the most encountered and are attracted by smoke and heat. They possess two sensory pit organs on their thorax that contain infrared receptors. Inside each receptor is a small pocket of water that expands when heat is detected, triggering a nervous system response to follow the heat source. Even when a fire isn't emitting smoke, the beetle is able to detect its heat signature—sometimes from dozens of miles away.
- These beetles, along with many others, start the natural decomposition process of burned trees by boring into the wood and introducing decay fungi, a boon for woodpeckers using beetle larvae for food and a race against time for land managers wanting to utilize trees for lumber.

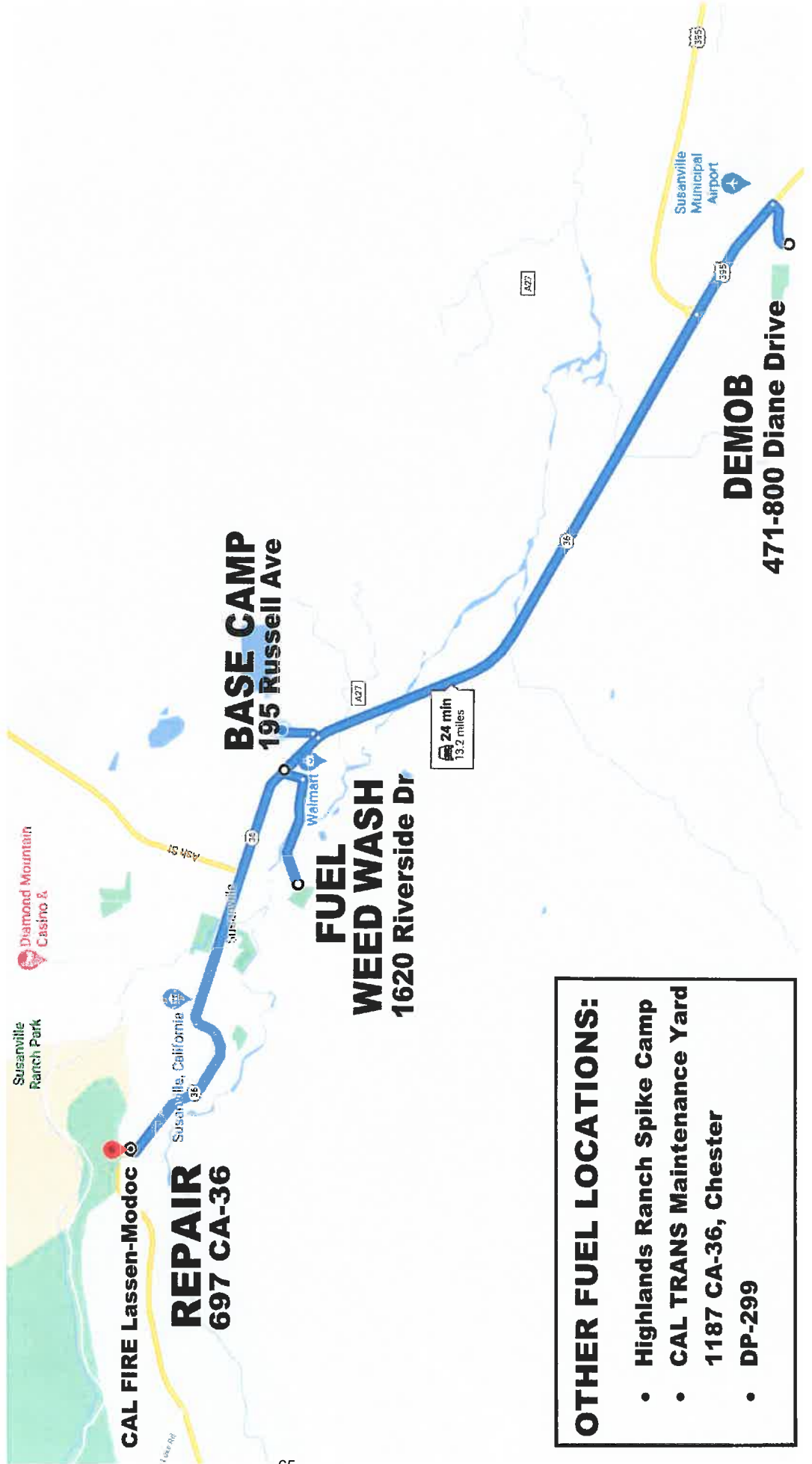
