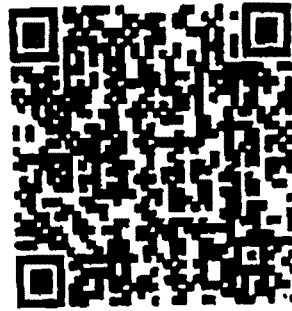

3. Objective(s): <ul style="list-style-type: none"> • Provide for firefighter and public safety by assessing and mitigating risk in order to develop and implement sound tactical operations. Ensure all resources have a clear understanding of assignments and associated hazards. • Protect homes, businesses, communities, utility infrastructure, transportation corridors, county watersheds and timber values from immediate and long-term threats. Contain the fire where it is safe to do so. Have contingency plans for uncontained fire edge. • Maintain and enhance relationships with agency partners, cooperators, stakeholders, and the public through timely and accurate information exchange. Ensure long-term strategies are communicated. • Ensure coordination and communication is taking place between South Zone, West Zone, and Area Command to ensure unified strategic direction, efficient resource use, and common public messaging across all three zones. • Follow CDC, local, state, and federal COVID-19 mitigation guidance and protocols to reduce exposure and protect firefighters and the public from virus spread. • Treat all personnel with dignity and respect by providing a harassment free, zero-tolerance work environment. • Ensure financial and documentation packages are prepared in accordance with agency requirements and agreements are closed out when no longer necessary. 													
4. Operational Period Command Emphasis: Predicted winds have the potential to promote fire growth. Ensure today's priorities are identified and all incident personnel are informed. Pre-identify resources to support priority operations in a safe and coordinated response.													
5. General Situational Awareness: Be prepared for wind shifts in both direction and speed. Be proactive in your plan of attack. Have your back up plan known to all your resources and be ready to implement it when trigger points are reached.

WEATHER DISCUSSION: ****Red Flag Warning from 0500 Sunday until 2100 Monday****

Today will be a critical fire weather day with breezy northeast ridgetop winds, low minimum relative humidity and warm temperatures. The strongest winds and lowest relative humidity values are expected between 1100 and 2200 today. Localized ridgetop and terrain gap wind gusts 28 to 35 mph will be possible, along with some enhanced downslope winds across the Mad River Valley near Ruth. As low levels stabilize toward sunset, the higher winds will be confined to the ridgetops and midslope gap locations overnight, before weakening by Monday morning. Critical low relative humidity values are expected today through early the upcoming week, along with very warm temperatures.

WEATHER: Breezy, warm and dry with areas of smoke.

TRANSPORT WIND: ENE at 20 to 25 mph, becoming 14 to 19 mph after 0200.
INVERSION: Shallow inversion lifts by 1000.

EXTENDED OUTLOOK: Monday through Thursday: A large ridge of high pressure both at the surface and aloft will build across northern California for early this upcoming week and prevail into most of the week. This will result in much above normal temperatures, mainly lighter terrain driven winds, and low relative humidity values with potential poor recoveries at night. Temperatures and relative humidity values could be impacted by areas of smoke, as daily mixing in the deeper valleys will be limited.

SPECIFIC: <p>Branch 21 Potential for rapid rates of spread and extreme fire behavior if fire jumps control lines especially in grass or brush fuels. Strong surface winds and clear air can cause downhill fire runs if alignment occurs. Fire behavior will significantly increase if it transitions from timber to brush or grass.</p> <p>Branch 31 – Strong down canyon winds can cause significant spotting problems. Any new spots will have potential for rapid rapids of spread in all fuel types. Higher ridges could have more long-range spotting. Do not assume previous fire scars will act as slowing features.</p> <p>North Structure Group – The threat to Post Mountain will decrease slightly as the winds turn more NE. Fire progression below Highway 36 as well as firing will need to be monitored throughout the day.</p> <p>Branch 40 - Minimal threats to the line are expected. Interior fuels will continue to burn out especially in areas that have heavy fuel concentrations to support combustion. The Buck fire scar will continue to check fire spread.</p>			
AIR OPERATIONS: Sunrise 0702 Sunset 1857. Good visibility is expected over most of the fire. Strong gusty northeast winds may be the limiting factor for aviation.			
SAFETY: During strong wind events fire weaken trees represent a significant hazard to both fire fighter safety, access/egress, and the hazard to fire spread.

SAFETY MESSAGE

BACKFIRING OR BURNOUT OPERATIONS

Backfiring or burnout operations are often critical operations in the fire management job. If planned and executed correctly, they can speed control of a fire and greatly reduce suppression costs. Conversely, if done incorrectly, they can endanger personnel, extend control time and increase cost. Safety considerations must always be given first priority. No backfiring or burnout action, regardless of strategic importance or other critical factors, is worth risking one human life!

- **Backfiring or burnout operations must not jeopardize the safety of personnel or equipment or compromise suppression actions on adjacent portions of the fireline.**
- **One qualified individual must be responsible for controlling and directing the firing operation.**
- **Before beginning backfiring or burnout operations, assure that:**
 - **Lookouts are posted.**
 - **Communications are established with both firing and holding teams.**
 - **Escape routes and safety zones are established, known to all resources, and will not be compromised by the firing operations.**
- **If it is necessary, and time allows, concentrations of fuel adjacent to and inside the control line should be removed.**
- **Fuel outside the control line may be removed; concentrations of fuel may be scattered, covered with foam or wet down, or treated by ground or aerial retardant applications.**
- **Critical points such as hooks in the fireline, saddles or canyon may require extra holding forces.**

IMT COVID-19 INTENT for the AUGUST NORTH COMPLEX

All wildland firefighters must take COVID-19 messaging seriously and demonstrate consistent, preventative measures known to be effective in limiting viral spread. The Alaska IMT is reminding firefighters to apply the core values of wildland fire management community of “Duty, Respect, and Integrity” and apply these values to the COVID mitigation requirements:

- **Duty:** To provide a workforce safe from known hazards such as disease transmission, and keep us, our fellow firefighters, and the public safe, on and off the clock.
- **Respect:** To demonstrate respect to oneself and to each other by taking routine precautions as guided, such as wearing a mask and social distancing.
- **Integrity:** To do the right thing when at home, while travelling, or on assignment. Undertake the precautions to keep ourselves and the rest of the workforce healthy and able to respond, then we are not the source of an outbreak within the public we are assigned to protect.

Concept of “Module as One:”

Team members, crews, and other resources should use a “Module as One” approach to insulate as one unit and reduce exposure to the public and other crews. If each member within a unit is monitored, screened, and healthy, then proximity, when necessary, is not an issue.

By insulating as a unit, crews and modules can limit outside viral exposure and may safely complete operational tasks in closer proximity, and ride in vehicles without face coverings when working within their “Module as One” concept:

- As often as practical, the same team members should travel in the same vehicle, work together in the same space, and ensure module members are conscientious regarding mitigations.
- Identify select individuals on a crew or module that will interact with the public, ensuring this person relies on social distancing, wears a cloth face covering, and practices hand hygiene during or after every interaction.
- When the “Module as One” has been established, minimize contact with public and outside community. This is to protect every crew member, their family, and the community we serve.

Essential Mitigations:

- **Pre-Screening and Regular Monitoring:** Individuals should measure temperature and assess symptoms each day prior to starting work. Ideally, temperature checks should happen before the individual enters the facility or interacts with others on staff or the crew.
- **Social/Physical Distance:** The employee should maintain 6 feet and practice social distancing as work duties permit in the workplace.
- **Wearing a Mask:** Employees should always wear a facemask or face covering when social distancing cannot be maintained. When facemasks cannot be worn during arduous work tasks, social distancing practices should be implemented.
- **Disinfect and Clean:** Clean and disinfect all areas, particularly “high touch surfaces” such as engine compartments, bathrooms, common areas and shared electronic equipment routinely.
- **Empower** all individuals to ask co-workers to follow social distancing guidelines.
