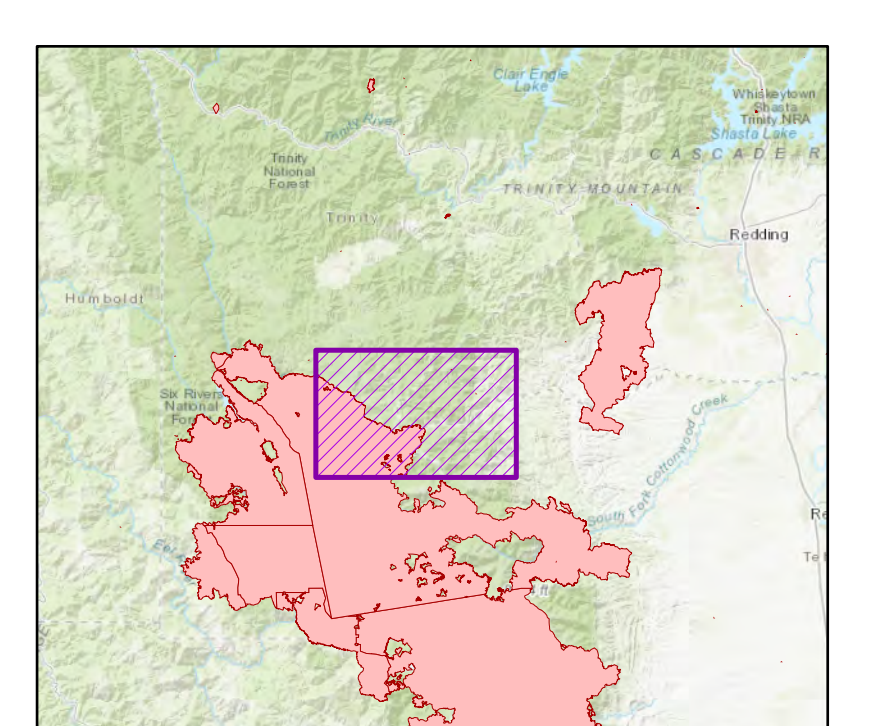
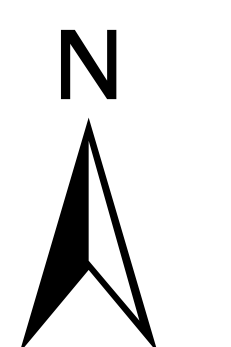


**OPS Div M1
