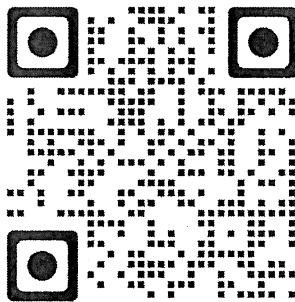




WEATHER DISCUSSION: Typical southwest afternoon breezes will return this afternoon with warm and dry conditions continuing into Saturday. An incoming low pressure system may increase SW wind gusts on Sunday and into early next week with critical fire weather conditions possible. No precipitation is expected into early next week.

Today (0600-1800):

Weather: Southwest breezes return. Increasing areas of smoke. Sunny.

High Temperatures: (24hr Trend: Little Change)

Upper Slopes & Ridges: 69-75°F (21-24°C)

Mid Slopes & Valleys: 85-90°F (29-32°C)

Afternoon Min RH: 10-15% (24hr Trend: +3%)

20 Foot Winds: (24hr Trend: Winds becoming SW)

Valleys/Low Slopes: Down drainage 5-8 mph, then SW 7-10 mph after 1100. (8-13kph, then 11-16kph)

Ridges/Upper Slopes: Down drainage 4-7 mph, then SW 10 mph after 1100. (6-11kph, then 16kph)

Transport Wind: SW 10-13 mph (16-22kph)

LAL: 1

A.M. Inversion/Thermal Belt: 6,000-6,500ft MSL

Chance of Wetting Rain (> or = to 0.10''): 0%

Afternoon Mixing Height: 11,000 feet AGL.

Tonight (1800-0600):

Weather: Clear, areas of smoke.

Low Temps: Valleys: 40-45°F (3-6°C) Slopes/Ridges: 58-63° F (14-17°C) (24hr Trend: +2° F)

Max RH: Valleys: 65-85% Slopes/Ridges: 30-35% (24hr Trend: +10%)

20 Foot Winds:

Lower Slopes: SW 5-10 mph, becoming down drainage 5-8 mph after 2200. (8-16kph, then 8-13kph)

Upper Slopes: SW 5-10 mph, becoming down drainage 4-7 mph after 2200. (8-16kph, then 6-11kph)

LAL: 1

Inversion: 6,000-6,500ft MSL.

Chance of Wetting Rain (> OR = to 0.10''): 0%

2-5 Day Outlook, Friday-Monday: Warm/dry into Sat. Gusty SW winds, low RH. Critical Fire Weather possible. High pressure rebuilds across the region resulting in lighter southwesterly breezes along with warming and drying conditions through the weekend. An incoming low pressure across the Pacific Northwest may result in increasing gusty southwest winds by Sunday through early next week.

Dryness: Dead and down fuel moistures :1 hour – 3% day, **10 hour– 3%**, 100 hour–5%, and 1000 hour– 7%.

FIRE BEHAVIOR

Expect a moderate to high risk burn environment due to high temperatures, low RH and critically low fuel moistures, live and dead. Limited overnight recovery on ridge tops. **Local Thresholds will be exceeded today 20' wind over 6mph, RH less than 20%, Temperature over 80 degrees and 10hr FM less than 5% (see forecasted above).** Where fuel, topography and wind align, expect a significant increase in fire activity from active to very active (crown fire and long-range spotting). Smoke inversion may limit fire behavior in the North Zone.

SPECIFIC FIRE BEHAVIOR:

Branch V South Zone:

Division BB: Fuel/topography driven fire consisting of flanking, upslope runs and slope reversals.
Division DD: Active fire behavior with SW/NE drainage alignment. potential for spotting and erratic winds.

Branch VII South Zone:

Division JJ: SW/NE drainage alignment will increase fire behavior, spotting and erratic winds. Anticipate fire activity from the West Zone (CALFire).
Division GG: Expect active fire behavior with potential for SW/NE drainage alignment. Possibility of erratic winds.

Branch X North Zone:

Division AA: Minimal fire activity expected.
Division MM/QQ: Expect significant fire activity as the fire continues to advance to the North with SW/NE drainage alignment and receptive fuel beds.
Division TT: DP88 will be tested with the predicted SW wind. Potential for upslope runs and spotting.
Division P: Expect creeping and smoldering.
Division S/V/X: These divisions are in mop-up/patrol status. Interior islands will continue to smolder and creep.

Night Division: Limited overnight RH recovery on the ridge tops. Winds will be SW 5-10 mph. the General wind coupled with the Diurnal downslope may increase the wind in drainages.

AIR OPERATIONS

Air operations in the North Zone may be limited due to smokey conditions.

- What am I going to do to make a positive impact on this incident today?

Wildland Urban Interface

- Maintain continuous situational awareness.
- Key to success in the WUI is preparation and preplanning.
- Be active and engage in defense preparations and don't wait for the fire to arrive.
- Be decisive in tactical engagement. Know when to engage or disengage.
- Establish management decision points, safety zones, and escape routes.
- Expect to encounter hazardous conditions such as solar, septic tanks, propane, increased carcinogens due to plastics and other materials.

Ensure....

- Strategic and tactical decisions take into account extended duration firefighting efforts with massive destruction.
- Tactical decisions keep pace with the evolving fire conditions and behavior.
- Firefighting operations are coordinated with adjacent branches, divisions, and groups.
- Specific firefighting tasks are consistent with the strategy and tactics to control the incident.
- We avoid the arrogance of success or, think what we did yesterday will be sufficient for tomorrow.

North Complex COVID-19 Expectations

- All incident personnel will follow all local, State and CDC guidelines for COVID-19.
- **As you travel through the local communities proximal to the fire, be mindful that in the State of California, face coverings are required inside local businesses.**
- Being a Federal fire, incident personnel are expected to comply with the following Region 5 and incident guidance.
- Use the COVID-19 Daily Screening Tool, provided in the IAP, to monitor self and module.
- Utilize Module-as-one concepts to reduce the risk of transmitting the novel Coronavirus. This limits “close contacts” to those within the module. A “close contact” is defined as less than 6 feet, for at least 15 minutes with or without face coverings/masks.
- **Social Distancing.** Maintain a minimum of 6’ physical distancing, especially from those outside of your module-as-one.
- **Face Coverings.** Face coverings are required to be worn, **in the appropriate manner covering nose and mouth**, when in identified “mask areas” at Camp. Outside of camp, all incident personnel will wear a face covering when social distancing is not possible, especially with those outside your module-as-one.
- **Wash your hands.** Wash your hands often with soap and water for at least 20 seconds, especially after blowing you nose, coughing or sneezing. If soap and water are not readily available, use a hand sanitizer that contains at least 60% alcohol. Do not use hand sanitizers containing methanol or 1-propanol. Cover all surfaces of your hands and rub them together until they feel dry. Avoid touching your eyes, nose and mouth with unwashed hands.
- Clean and disinfect vehicles and equipment. Disinfect all high-touch surfaces frequently, such as radios, phones, door handles, etc.



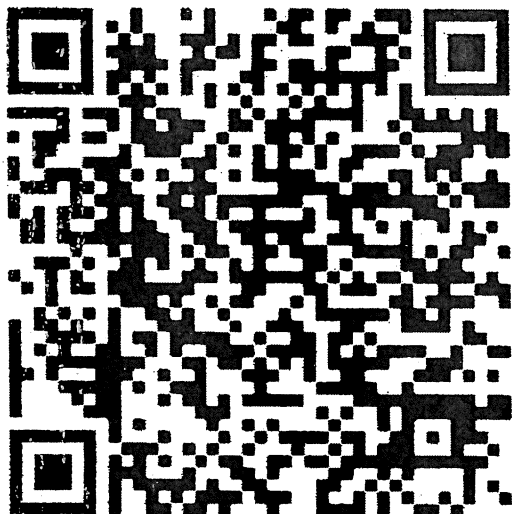

FINANCE SECTION STANDARD OPERATING PROCEDURES

WORK REST CYCLE

IT IS NATIONAL DIRECTION TO MEET 2 TO 1 WORK/REST RATIO (1 hour of sleep/rest for every 2 hours of work). Every effort shall be made to manage work hours so you don't exceed the maximum of 16 hrs. Work hours exceeding 16 hours shall be approved by your supervisor in advance, and a justification/mitigation form completed for review by Section Chief & approved by IC. It is each person's responsibility to comply with this direction to manage for fatigue and safety.

OPERATIONAL SHIFTS

Pay status for assigned overhead and crews on the fireline will not start prior to the posted briefing time and will terminate on arrival back in camp (except for debriefing—additional time may be accrued by those required to attend debriefing). Supervisors will be allowed ½ hour prior to briefing and after return to camp to ready crew and equipment.

DUTY STATUS

Division/Group supervisors and Unit Leaders are responsible for establishing on and off duty status. The objective is a 2 to 1 work/rest ratio. Personnel will normally work, travel, and/or be placed on ORDERED standby 8 to 16 hours per day and be off duty 8 hours or more (breaks count towards 8 hrs.). Off duty time will be in a non-pay status. Each federal employee is guaranteed **at least 8 hours** of pay status each 24-hour period (midnight to midnight) unless it is the first or last day of an assignment or stated otherwise in a contract or agreement.

PERSONNEL/EQUIPMENT TIME REPORTING

Personnel time will be reported to the Time Unit daily or every other day once they are signed by the next level supervisor. Situations entitling you to HAZARD PAY are to be noted in remarks (i.e. HP=Uncontrolled Fireline, hovering hookups, low level flights, etc.)

Private Contracted Equipment time must be tracked on a Shift Ticket daily or every other day and hours on shift noted even if it is a daily rate. When swapping out operators you need to notify Finance as well as changing from single to double shift and vice versa.

Supervisor's - If you are responsible for daily tracking of equipment or personnel, please ensure you understand the agreement, and follow the rules provided in this document. Do not sign documents for resources you did not manage unless you have knowledge of their assignment hours.

MEAL AND OTHER WORK BREAKS

Compensable meal periods are the exception, not the rule (5 CFR 551.411 © and 29 CFR 785.19(a)). Until the fire is controlled, personnel on the fireline MAY BE compensated for meal periods if all of the following conditions are met: 1) The fire is not controlled and 2) The Operations Section Chief makes a decision that it is critical to the effort of controlling the fire that personnel remain at their post of duty and continue to work as they eat, and 3) The compensable meal break is approved by the supervisor at the next level and documented on CTR. For personnel in support positions, and fireline personnel after control of a fire, a meal period of at least 30 minutes must be ordered and taken for each work shift of eight hours or more. In those situations where personnel cannot be relieved from work and must remain at a post of duty, a meal period may be counted as time worked, which will be compensable. If breaks are NOT able to be taken, CTR should have a statement in remarks explaining the situation. Please also show in remarks section what division you are working in.

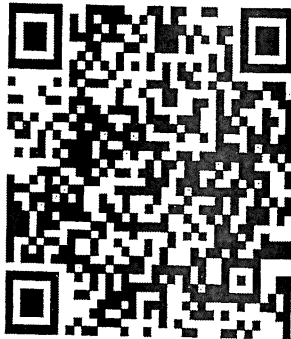

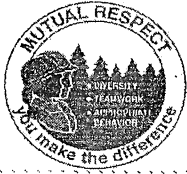

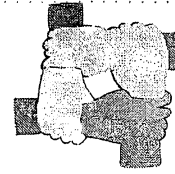

Suicide Prevention Week September 6-12, 2020

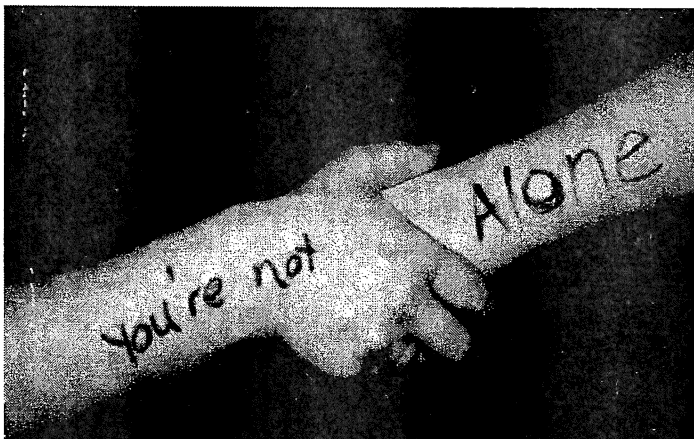
We are in unprecedented times in our Nation and the world. We are being told to social distance and isolate. Maidu Requests for Visiting Homeland

1. "Be good to the land and the land will be good to you." Maidu quote

Thank you fire fighters for helping us keep our homes and cultural sites safe.

2. Enjoy your visit in the Mountain Maidu and Valley Maidu homelands.

Archeological sites and the resources they contain are not public property. A place, site or resource may have significance to a family or local tribe, which often carries with it a special level of protection.

3. Take care to avoid injuries.

Cultural sites are very old and fragile. Archeological resources are anything over 50 years old and can therefore erode easily. Also, historic dump sites can be hazardous, with sharp glass, rusty metal, and compounds and chemicals that can harm you.

4. Enjoy with care.

Oils from skin damage pictographs (rock paintings) and petroglyphs (rock carvings). It ruins irreplaceable historic resources, and it is illegal.

5. Don't touch the knickknacks.

ALWAYS LEAVE ARTIFACTS RIGHT WHERE YOU FIND THEM. Out of context, artifacts mean little to archeologists. Often the most important aspect of archeological resources is their relationship to the place and other adjacent resources. Archeological sites and artifacts are our direct link to stories that otherwise might not be told. How can these stories be complete or accurate if the setting is altered or lost? For this and other reasons, it is illegal to move or remove artifacts.

6. Feel free to discover.

Some of the sites are identified, and some sites are not recorded. If you happen to come across a cultural site we ask you to treat it like you would any cultural artifact. And note the location and report it to a Resource Advisor.

Speak with resource advisors about the potential for archaeological sites being located adjacent to roads or proposed fire lines. It's easy to destroy features and artifacts in the dark.

- Over approximately 160 years, many changes have reshaped tribal relationships with these vast landscapes as well as with each other, and yet our knowledge of and responsibilities to these incredibly rich and vast landscapes remains strong. **We appreciate your dedication to care for and building your own relationships with our natural environment while protecting these fragile and irreplaceable resources!**
