

Efforts will be made to minimize impacts to residences, critical infrastructure and private timberlands through the application of well-planned tactical responses.</p> <p>Management Objectives</p> <ul style="list-style-type: none"> • Ensure that strategies and tactics provide for firefighter and public safety through the application of sound risk management principles. • Minimize the threat to private property, critical infrastructure, and commercial timberlands. • Establish and strengthen cooperator, partner, and stakeholder relationships. • All suppression repair work will be conducted in close coordination with assigned READs. <p>Control Objectives</p> <p>Keep the Delta Fire:</p> <ul style="list-style-type: none"> • North of the line that runs from Delta to Mosquito Creek Ridge to minimize impacts to I-5 and protect the communities of Pollock, Lakehead, and Lakeshore. • South of Middle Ridge (west side of I-5) to protect private timberlands. • South of Hazel Creek Road (east side of I-5) to minimize threat to communities and residences along I-5 corridor. • East of the East Fork of the Trinity River to minimize impacts to Highway 3 and protect recreational sites. • West of Crane Mountain to halt eastern spread. <p>Hirz Fire:</p> <ul style="list-style-type: none"> • Continue to mop-up and patrol as needed to ensure that fire stays within existing containment lines.

WEATHER SUMMARY

**** See Fire Weather Forecast ****

Weather: Partly cloudy. Areas of smoke. Inversion breaks around 1100.
Max Temps: 76-81 ridgetops and 90-95 lower drainages.
Min RH: 16-21 percent ridges and 13-18 percent lower drainages.
20 FOOT WINDS: Ridges: North-Northeast 3-8 mph until 1100, then becoming South-Southwest 5-10 mph with gusts to 16 mph
Slope/valley: Downslope/Downvalley 2-6 mph until 1100, then upslope/upvalley 3-7 mph

FIRE BEHAVIOR

INPUTS:

- **Fuels:** Low fine dead fuel moistures, even under the inversion, will promote fire growth today.
- **Topography:** Ridge top locations in clear air will experience the greatest amounts of spread today. Fire has transitioned from surface to group torching when slope promotes fire spread.

FIRE BEHAVIOR: Under the inversion, fire movement will primarily be terrain driven today; backing, flanking, and short slope runs will characterize behavior. The inversion will be present over the fire for most of the burn period, minimizing solar exposure on fuels - activity is expected to be low until smoke/inversion is pushed to the Northeast by forecast winds around 1400. Southern aspects with active fire have exhibited moderate fire behavior until sundown.

Probability of Ignition: 90% in clear air.

DIV ZZ: Fire backing into Campbell Creek will need to cross to the South in order to find slope alignment. Rollout is possible, but the division will remain under the inversion for all but the final hours of the burn period.

DIV AA: Continued backing and flanking into Dog Creek today. Western portions of the division near Damnation Peak could see clearing in the afternoon. Forecast wind will push back against possible slope runs out of the head waters of the North Fork of Dog Creek.

DIV BB: Clear air conditions will return. While movement West into Blodgett and Clear Creek will be slowed by forecast winds, expect steady spread through timber fuels through flanking and backing.

DIV CC: Fire in clear air will actively back into Fools Gulch and the East Fork of the Trinity River. Slope runs on Southern aspects should be expected around 1600 as fuel temperature reaches its highest level for the day.

DIV DD: Dissected land forms and variable fuel treatments characterize this area. Fire moving up Slate Creek will be presented with multiple opportunities to transition from surface fire to group torching or crown runs in brush fuels. Monitor the transition from surface to isolated torching to anticipate moderate to high intensity fire runs. Any break in the inversion will accelerate the transition.

DIV JJ: Inversion should remain in place throughout the day. Slope runs out of the South Fork of Shotgun Creek may be possible if the fire finds heavier fuels.

Hirz Fire: Threat of spread from the fires edge remains low. Inversion along with mostly ridgetop line locations would result in backing fire under moderate burning conditions.

AIR OPERATIONS

Air operations will be hampered by inversion throughout the day. North and East portion may not see clearing.

Incident Management Team Transition

- Sometimes called the 19th Watch Out Situation.
- Take the time to understand the plan. Ensure all resources completely understand the assignment, the Communications Plan, and the Medical Plan.
- Briefings: Required every shift, for all personnel, for new assignments, and for changing conditions.

Hazard Trees

- All trees need to be considered hazardous until they are evaluated.
- Even large healthy looking trees can be dangerous due to forest health issues.
- Use the look up, down, and all around process when working around or under trees.
- Minimize the number of personnel exposed, and the exposure time.
- Avoid unnecessary exposure around suspect trees during windy periods.
- Mitigate or close areas around hazardous trees in work areas.

Driving

- When driving keep the speed at or below the posted speed limit and turn your headlights on. Is the posted speed limit a safe speed under the current conditions and traffic?
- Use caution on unimproved roads as some have soft shoulders. Some roads are also only one lane with pullouts!
- Road surfaces are variable with washboard conditions and thick dust that can compromise turning and braking.
- Watch for and anticipate stock and wildlife.
- Always fasten your seat belt before the vehicle is set into motion. Use backers.
- Don't tail gate, especially in dusty conditions.
- Slow down, slow down, and slow down!

Personal Safety

- Make yourself visible to vehicle traffic while working on, or near roads. Use your headlamp or glow sticks.

Understand your mission, ask questions!

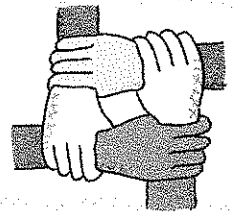
