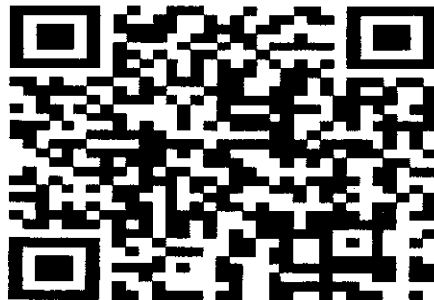



WEATHER TODAY:

WEATHER: Potential Thunderstorms near crest and drift toward fire. Be prepared for outflow winds. The upper Low pulled southwest of the region and offshore which brings more southeasterly ridge winds over the area. These will still contribute to warming, downsloping winds and increasing temperatures and decreasing RH in the morning. A struggle between winds from late morning to afternoon over the fire as westerly winds will likely battle the predominant ESE winds. Even the northeast flank should transition to a westerly component by mid afternoon.

TEMPERATURES: 77-82 *Trend: Up 3*
RELATIVE HUMIDITY: South/West Flanks: 30-40% increasing to 50%
North/East Flanks: 25-30% increasing to 40% *Trend: Little change*

20 FT WINDS:

RIDGETOP - North/east flank: Morning winds from ESE 10-20 mph with gusts to 30 mph over Hell Hole area through 1200 before weakening and shifting SW by mid afternoon.

South/west flank: NE 4-9 mph shifting westerly 3-6 with afternoon gusts to 10 mph.

SLOPE/VALLEY - North/east flank: Downcanyon 5-10 mph with gusts 15 mph (strongest 0500-1000) and shift WSW 5-10 mph around 1500.

South/west flank: Wind will shift upslope/upcanyon 3-5 mph between 0900-1000, increasing to 4-7 mph with gusts 10 mph in aligned canyons.

LAL: 1. STABILITY/INVERSION: Weak inversions breaking in deep canyons by 1000.

WEATHER DISCUSSION: Easterly/downcanyon winds this morning giving way to westerly slope winds over the lower/western portion of the fire by 1000 and the eastern portion by late afternoon. The Low weakens and moves northeast over the area on Sunday, which will bring variable ridge winds. Increasing SW winds dominate the fire early to mid next week.

WEATHER FOR SATURDAY NIGHT: Mostly clear with smoke settling downcanyon after 2200.

Low temperatures: Thermal belts/ridges 60-65... Valleys 52-58.

Max RH: Thermal belts/ridges 40-45... Valleys 50-60%.


20FT Winds:

Ridge – NW 3-7 mph shifting NE 3-8 mph after 2100 with gusts to 15 after 2400.

Slope/valley – Transition to downslope 2-5 mph. Downcanyon wind gusts 4-8 mph after.

OUTLOOK FOR SUNDAY: Low drifts eastward into western NV, shifting ridge winds more westerly and northerly steering wind above ridges will likely take smoke southward. **High temps:** 75-80. **Min RH:** 30-35%. **Ridge winds:** Westerly winds from 4-7 with afternoon gusts to 12 mph. **Valley/Slope winds:** Downslope 3-6 mph shifting upslope/upcanyon 4-8 mph by noon.

INPUTS

WEATHER SUMMARY-SEE ATTACHED FIRE WEATHER FORCAST

The upper low is south of the fire which brings southeasterly ridge winds over the area. Expect increased temperatures and decreased RH's.

Temperatures 77-82 Up 3 from yesterday

Relative Humidity: 25-40 %

Ridge top morning ESE winds on the East side of the fire will be 10-20 mph with gusts to 20. Morning ridgetop winds on the S and W side of the fire will be 4-9 mph shifting westerly 3-6 mph.

Slope/Valley winds on the East side of the fire will be downcanyon 5-10 mph with gust to 15 (strongest 0500-1000) and will shift WSW 5-10 mph around 1500. Winds on the S and W flank will be upslope/upcanyon 3-5 mph between 0900-1000, increasing to 4-7 mph with gusts to 10 mph in aligned canyons.

FUELS -The primary carrier of fire is timber. The fire area has many areas with fuel treatments and timber operations, which have created open and closed canopies and understories of grass, regeneration and brush. There are also areas of brush and grass. *Live and dead fuels are at critically low levels!*

FIRE DANGER INDICES-Thresholds for Active Fire Behavior in the King Fire area (Eldorado NF PocketCard):
* 20ft Winds (over 5 mph), *RH (under 22%), *Temperature (over 84°) and *1000hr FMC (under 9%).

Branch I- Upcanyon wilds will be favorable for holding. Monitor interior islands and unburned fuels adjacent to control lines. Expect erratic winds at the confluence of the American River and Slab Creek.

Branch III- Expect flanking fire behavior as the fire moves down into the Slab Creek Drainage under the daytime upcanyon winds. If the fire establishes in the drainage, there is the potential for upslope runs towards Slate Mountain and Mosquito Road.

Branch VII- Expect the fire to continue to burn to the NE from Silver Creek up Government Ridge toward Hunter Valley. Expect single and group tree torching.

Branch X- The fire will continue to burn to the N up Middle Fork of the American River toward Handy Camp. Expect single and group tree torching.

Branch XIV - Fire will continue to move to the NE south of Hell Hole Reservoir towards McKinstry Peak, where fuels and topography are in alignment.

AIR OPERATIONS

Upper level ESE winds will cause smoke to inundate the west side of the fire and will limit air operations.

Sunrise - 0649 hours Sunset 1903 hours

SAFETY

- Dead and live fuels are at critical levels. Alignment of fuels with topography or wind can initiate a rapid change in fire behavior.
- When developing strategies and tactics, safety zones and escape routes you should be evaluating potential fire behavior (worst case scenario), not just observed fire behavior.

TRANSITION

Today presents some unique hazards as we transition to dividing the fire into 2 zones managed by separate teams. Insure you have positive communications; know who you are working for. Stay in contact with supervisors, adjoining forces, and the incident command post. Utilize human repeaters if necessary.

Make sure you understand your assignment, be familiar with important locations. If you are unclear about any aspect of your assignment, do not hesitate to ask questions. Stay vigilant and keep up with changing situations.

POTENTIAL FOR EXTREME FIRE BEHAVIOR: Review "Severe Fire Behavior Potential" (IRPG p.68). Monitor current weather conditions and forecasts. Make sure all personnel receive thorough briefings every shift.

MAINTAIN ADEQUATE ESCAPE ROUTES AND SAFETY ZONES: Review "Safety zones" (IRPG. P.8). Advise all personnel if these are compromised or changed. Set trigger points and reevaluate continuously.

SNAGS AND HAZARD TREES: There are many snags in the area, especially in bug kill areas. Review Hazard Tree Safety, (IRPG p.22). Evaluate potential hazards. Areas should either be cleared of snags prior to allowing crews to work there, or kept totally clear of personnel. Pay particular attention to snags during windy periods. Post lookouts if necessary.

SITUATIONAL AWARENESS: Go to your assignments with a fresh set of eyes. Whether it is vehicle or equipment use, mop-up or rehab, ask yourself "Are my actions Safe and effective?" If not re-evaluate your plan. Keep an eye on other personnel; it is **EVERYONE'S** responsibility to stop an unsafe act.

AFTER ACTION REVIEW: A thorough and concise AAR at the end of a shift or after a significant event is a good idea. Determine the causal factors that led up to the event, what worked well and what did not work. How would you have done things differently? A good debriefing will improve efficiency & **SAFETY**.


How to Drive Slowly

- Allow ample time to get where you are going.
- Assess conditions that might make faster driving hazardous.
- Practice accelerating and decelerating gently and gradually.
- Be patient.
- Drive the speed of traffic, provided it is safe for conditions.
- Give others the space to pass.
- Use lower gears and let the engine slow the vehicle when descending longer hills.
- Work on keeping an even, moderate speed.

Accountability

- Know where your crewmembers are at all times.
- Have crewmembers work in pairs.
- Inform Division or your Supervisor of changing locations.
- Review radio procedures, and ensure your radio is properly cloned.
- Check **IN** with the Division Supervisor on site if not assigned there
- Check **OUT** with your supervisor (or Division) at the end of shift.

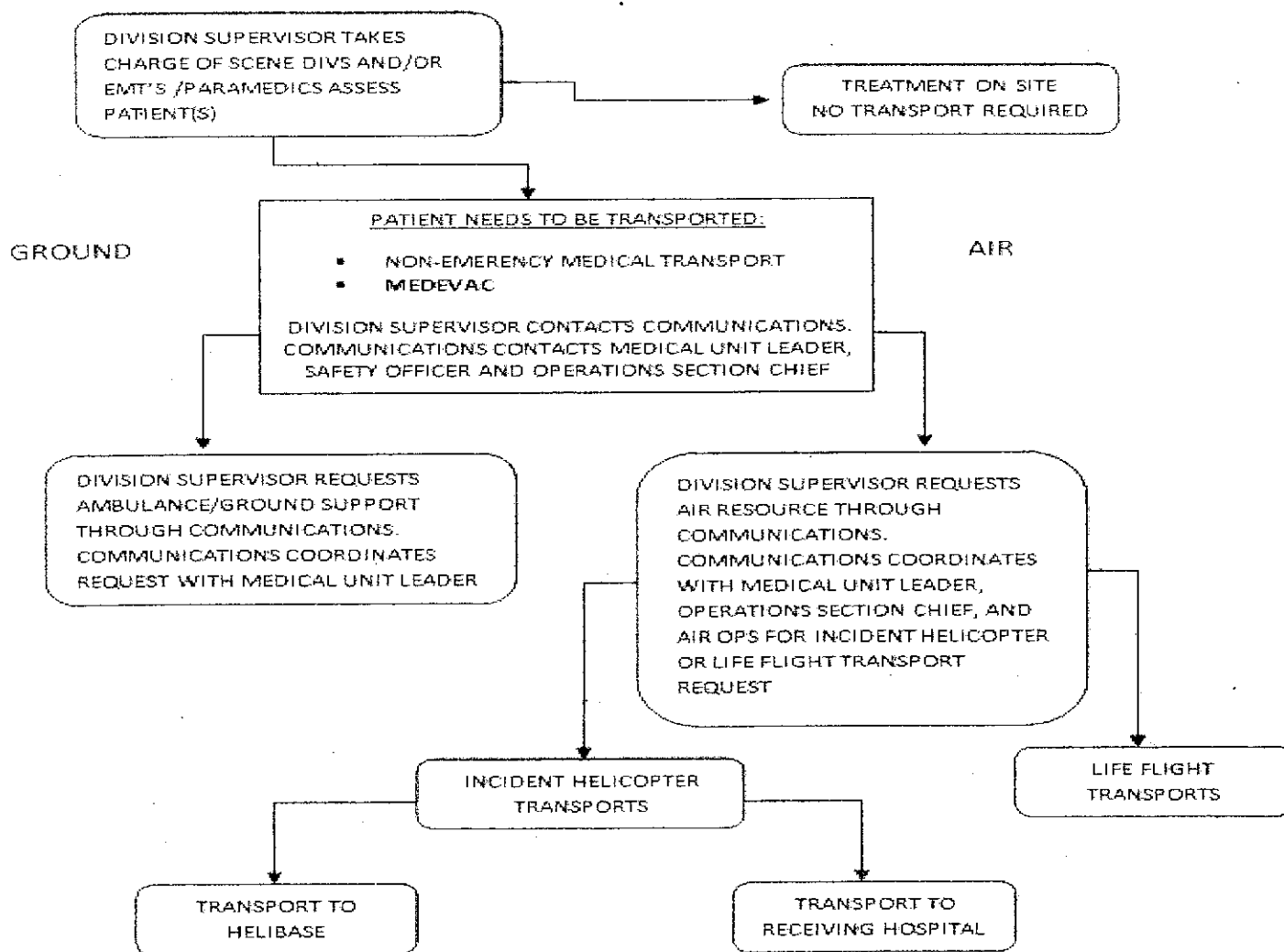

When an injury occurs, initiate care with available resources at scene and notify DIVS.

The DIVS shall coordinate the incident and direct necessary actions. The following steps shall be taken to mitigate the incident:

1. Determine the nature of the emergency.
2. If the emergency is a medical injury/illness, determine if the injury/illness is life threatening.
3. If the injury is life threatening, then clear designated frequency for emergency traffic.
4. Identify the on-scene point of contact by position.
5. Ensure that the Medical Unit Leader is contacted immediately.
6. Identify number injured, patient assessment(s) and location (geographic and/or GPS coordinates).
7. Identify on-scene medical personnel by position and last name (i.e. EMT Jones).
8. Identify preferred method of patient transport.
9. Determine any additional resources or equipment needed.

The Evacuation Plan should be continually evaluated, and contingencies developed in the event the first plan is not effective.

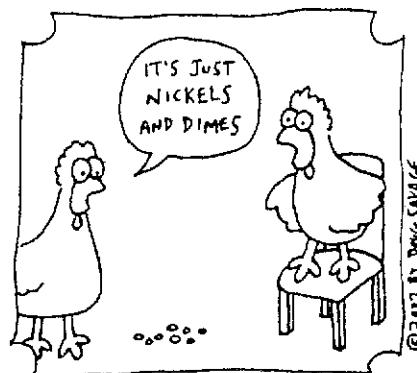
Some tips to manage change:

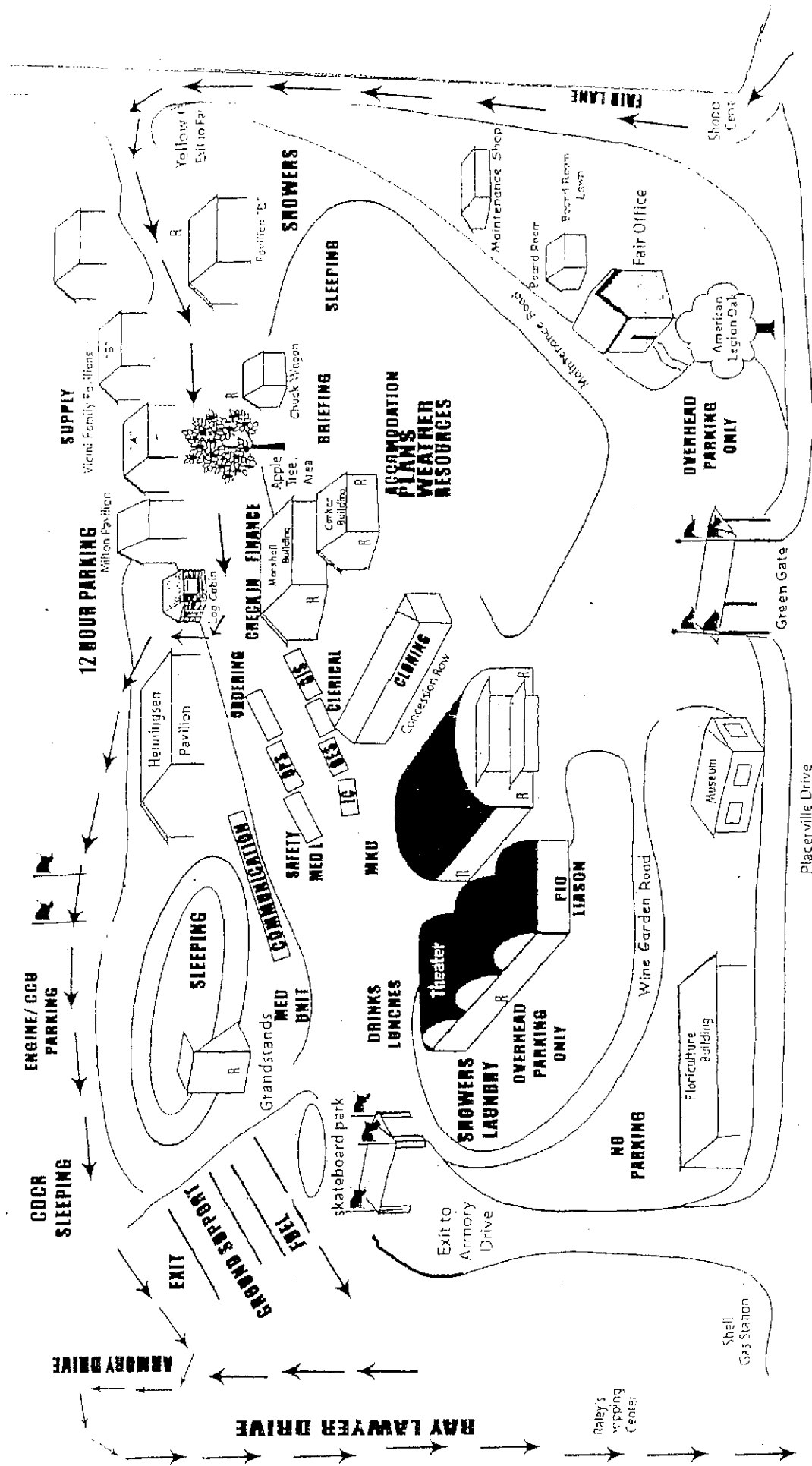
