**TEMPERATURES:** Ridges: 74-79...Slopes/Valleys 79-89 **Trend: Nearly Steady**  
**RELATIVE HUMIDITY:** 10-15% **Trend: Nearly Steady**

**20 FT WINDS:**

**Slope/Valley:** Downslope/Downcanyon 4-9 mph until 1000...then upslope/upcanyon 7 mph G15.  
**Ridgetop:** East to southeast 5 mph G9 until 1000-1200...then southwest to west-southwest 7 mph G15.

**LAL: 1. STABILITY/INVERSION:** Inversion to 1300 FT AGL, breaking by 1000.

**WEATHER DISCUSSION:**

Strong High Pressure over California will remain in place through Sunday, then begin to break down and shift east Monday through Wednesday. As a result, today and Sunday will be very similar with regards to high temperatures, relative humidities, and winds. Terrain driven winds can be expected with upslope/upcanyon winds from 1000 through 2000, then downslope/downcanyon winds thereafter. Ridgetop winds will favor a northeast to east-southeast direction at night into the early morning, transitioning to southwest and west-southwest from 1000-1200. In the northern King Fire across the higher peaks, northeast winds of 15 mph G25 will be common at night into the early morning hours.

**WEATHER FOR SATURDAY NIGHT:** Clear. Poor maximum relative humidity recovery.

**Low temperatures:** Valley/Ridges: 58-64

**Max RH:** Ridges 17-29%...Slopes/Valleys 20-35%.

**20FT Winds:**

**Slope/Valley:** Downslope/Downcanyon 4-9 mph.

### INPUTS

**WEATHER SUMMARY:**

Mostly sunny, warm and dry

Temps and RHs – Max Temp 74-89° RH 10-15% LAL 1

20ft Wind –

Slope/Valley – Downslope/downcanyon 4-9 mph until 1000, then upslope/upcanyon 7 mph gusts to 15 mph

### OUTPUTS

**FIRE BEHAVIOR****GENERAL:****FUELS**

Predominantly mature mixed conifer with heavy shrub loading. Fuel loadings are generally heavy. Live fuels moistures remain dry; however the dead fuels still remain moist in sheltered areas.

Thresholds for Active Fire Behavior in the King Fire area (Eldorado NF Pocket Card): 20ft Winds (over 5 mph), RH (under 22%), Temperature (over 84°) and 1000hr FMC (under 9%). *Currently ERC's from local RAWS stations are 50% and 1000 hr fuel moisture is 13% which is above the threshold for active fire behavior.*

**FIRE BEHAVIOR**

Warmer, drier, and lower windspeeds today. As the ERC's continue to rise and 1000 hour fuel moisture continues to drop, fuels are drying out on multiple sunny exposed aspects, and the soil is beginning to dry out as well. However the fuels are still holding moisture under the canopy on all aspects. Heavy fuels continue to burn out throughout the interior.

Unburned islands adjacent to heat sources on exposed southerly aspects could carry fire, if inline with slope and wind. Single tree torching maybe possible in plantations. Maximum rate of spread could be up to 6 ch/hr with 2' flame lengths on unshaded southerly aspects. Probability of ignition on southerly exposed aspects is 32%, otherwise 1% on cooler aspects.



7. Control Operations

Mop up 200' or to the degree necessary to make the likelihood of escape very low: based on experience, terrain, fuel types and fuel conditions, and current/predicted weather conditions. Continue coordinating repair efforts with READ. Remove and backhaul all unnecessary hoselays, pumps, and portable tanks.

8. Special Instructions

Every two hours South Rim of Rubicon Ridge take weather observations and call into communications. Divisions must debrief daily with cost apportionment at King ICP and Sunset Base Camp. Noxious weeds are marked by orange "noxious weed" flagging. Minimize or avoid activities in the area. Sensitive areas are marked with pink/black checkerboard flagging. Minimize ground disturbing activities in the area. Field weed wash heavy equipment used off roads in Branch III before leaving to assignment on another section of fire. READ verifies location for wash.

- Mosquito Rd is still the fire line Div E, also lots of chipping on Soda Springs rd, don't drive on them unless you have work in the area. Drive slowly and prepare for oncoming traffic, repair equipment and firefighters on the road.
- Headlights on; creep around blind curves and corners.
- Expect heavy traffic on Highway 50 over the weekend. Apple Hill just east of Placerville is a very popular attraction and draws large crowds from the Sacramento area.
- Engines patrolling and working along Wentworth Springs use extreme caution, its open to the public. Watch for people looking at the fire damage not the road...
- Deer are common along the roads, dusk and dawn times are the worst.

### **Fireline:**

- Suppression Rehab is in full swing watch for lots of heavy equipment dozers, excavators working the fireline.
- Watch for rolling debris beneath the rehab operations, keep crews clear.
- Be familiar with Medical plan. Don't commit to ground you can't get someone out of.

### **Spike Camps:**

- Bears are very attracted to trash and any food smells. Keep your camps clear of all trash and food. Trash cans must be emptied every day before nighttime into bear proof dumpsters.
- No food or personal hygiene products in your tent.
- Keep the bears wild.

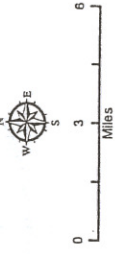
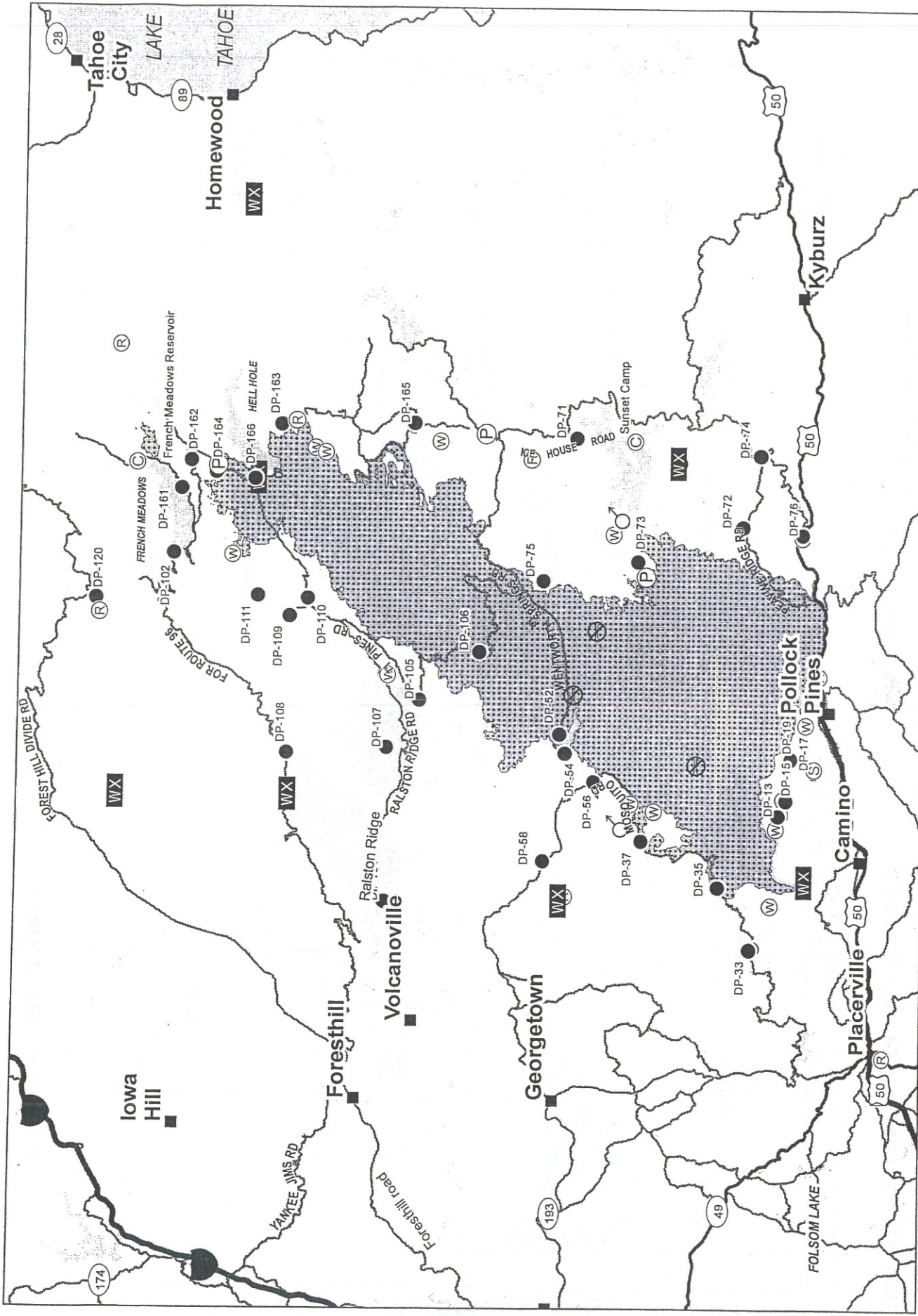
