...Excessive Heat Warning Remains in Effect Today...

WEATHER DISCUSSION: Well above normal temperatures continue and may nudge slightly higher in some areas today. Winds will be a little stronger this afternoon and evening then diminishing winds after sunset with lighter terrain driven winds prevailing overnight. Continued dry with low afternoon humidity followed by poor to moderate overnight recovery. Mainly sunny skies will prevail over the fire area. There is a decreased threat of outflow boundaries impacting the fire area today but it still cannot be ruled out. Temperatures will be slow to cool this evening with warm conditions persisting well into the night in some areas, especially in Doyle Branch.

WEATHER FORECAST for SUNDAY:

Weather around fire area



WEATHER: Mostly sunny and hot. Areas of smoke. Pyrocumulus development likely.

TEMPERATURES: Valleys/Lower Slopes: 97-103° Mid-Slopes/Ridges: 91-97°

HUMIDITY: 9-15% **HAINES INDEX:** 6 (High potential for large fire growth)

20 FT WINDS:

RIDGETOP - Southwest 5-10 mph increasing to 10-15 mph by afternoon. Gusts to around 25 mph.

SLOPE/VALLEY - Upslope/upvalley 4-8 mph in the morning, becoming west southwest 8-14 mph with gusts to around 25 mph in the afternoon.

20 FT WINDS:


RIDGETOP - Southwest 10-15 mph with gusts to around 25 mph in the early evening, decreasing after sunset to southwest 5-10 mph.

SLOPE/VALLEY - West southwest 7-14 mph with gusts around 25 mph in the early evening diminishing after sunset and transitioning to downslope/downvalley 1-6 mph.

STABILITY/INVERSION: Becoming more stable overnight with inversion developing after midnight.

OUTLOOK for Monday through Wednesday: The Excessive Heat Warning remains in effect and has been extended through Tuesday. Temperatures will start to trend slightly lower Wednesday. A southwest flow will continue with gusty afternoon and evening winds, followed by lighter terrain driven winds overnight. Relative humidity remaining low with poor to moderate overnight recovery.

FIRE BEHAVIOR

The fire environment will continue to be hot and dry. Potential for Pyrocumulus development (down drafts and erratic winds). Fires adjacent to the escarpment have a history of producing extreme fire behavior. Fire behavior will include surface running fire, group torching, long-range spotting and potential for fire whirls. As the fires East flank becomes closer to the escarpment, plan for a transition of fuel from timber understory and grass to a tall grass and brush model east side of the escarpment. **ROS** in Tall grass 350-360 chains per hour, **Flame length 20-25ft, Spotting distance 1 mile.** **ROS** in brush 315-320 chains per hour, **Flame length 35-40ft, Spotting distance 1.5 mile.**

SPECIFIC FIRE BEHAVIOR:

Branch III

Division A: Minimal fire behavior, interior smoldering and creeping near the line.
Division C & Division E: Minimal fire behavior, interior smoldering.
Division G: Fuel and topography driven fire, potential for upslope movement.
Division I: Fuel and topography driven fire, potential for upslope runs, group torching and spotting.

Branch IV

Division N: Active, running fire, group torching, long-range spotting, potential for erratic winds.
Division R & Division T: Active, group torching, long-range spotting. Potential for strong down slope winds and erratic fire behavior.

Branch VII

Division V: Active, backing potential for alignment.
Division X: Active, Torching, backing, interior smoldering.
Division Z: Minimal activity, interior smoldering.

Night Division

High temperatures and low RH in the beginning of the shift. Moderate RH recovery on ridge tops. Be mindful of wind shifts and speeds due to topographical features. The shift will start with a Pig of 80-90% diminishing after midnight. Expect fire activity to diminish after 0300. Anticipate strong down slope winds and erratic fire behavior east of the escarpment.

Emotional Awareness

Wildfires with a wide range of destruction can cause mood swings, sleep disruption, and stress reactions.

Take care of yourself by:

- Talking to a trusted friend, colleague, adviser, or family about what your feeling.
- Staying connected to life outside of the fire.
- Taking frequent breaks from firefighting efforts if feasible.
- Eating healthy and get plenty of sleep.

Command and Control

Ask yourself key questions:

- Are tasks in alignment with tactical objectives?
- Are tactical objectives in alignment with the strategic objectives?
- Are the strategic objectives in alignment with the incident priorities?
- What am I going to do to make a positive impact on this incident today?

Driving

- When driving keep the speed at or below the posted speed limit and turn your headlights on. Is the posted speed limit a safe speed under the current conditions and traffic?
- **Use caution on unimproved roads as some have soft shoulders. Some roads are also only one lane with pullouts!**
- Road surfaces are variable with washboard conditions and thick dust that can compromise turning and braking.
- Watch for and anticipate livestock and wildlife especially from dusk to dawn.
- Always fasten your seat belt before the vehicle is set into motion. Use backseat.
- Do not tail gate, especially in dusty conditions.
- Slow down, slow down, and slow down!

Fatigue and Smoke Effects

- Be alert for signs of fatigue and take breaks as necessary.
- Maintain a 2:1 work to rest ratio.
- Monitor incoming resources for level of fatigue.
- Allow for extended rest periods if needed.
- Avoid working in heavy inversions for prolonged periods if possible. Take occasional breaks in clear air to mitigate CO and CO₂.




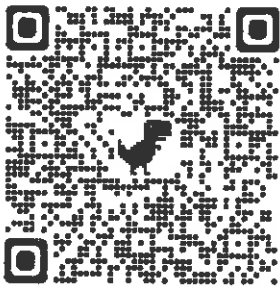
