



INPUTS

WEATHER SUMMARY *STRONG WIND GUST THIS AFTERNOON & EVENING*****

WEATHER: Mostly sunny and hot. Areas of smoke.

MAX TEMP: Mid Slope: 90-97° Valleys: 97-103°

Humidity 7-14%

20 FOOT WINDS: Valleys/Slope: upslope 4-8 mph becoming **WSW 12-18mph G30 mph** in the afternoon.
Ridge Top: **SW 5-10 mph** increasing **15-20mph** by afternoon **Gusts to near 30 mph.**

LAL: 0 HAINES INDEX 6 CHANCE OF WETTING RAIN: 0%

FUELS: The major fuel types, found in and around the fire area are timber understory and brush.

Ignition Receptiveness: ERC levels are above the 90th percentile. **Probability of Ignition** 100%

Dryness: Dead and down fuel moistures: 1 hour – 3% **10 hour–4 %**, 100 hour–4 %, and 1000 hour–6%.

FIRE BEHAVIOR

Hot and dry weather with continue through the end of the week. Expect active fire behavior where open line exist and fuels are abundant. Fire behavior has shown to intensify starting around 1400 in clear air and will continue through the morning hours. Watch for alignment of wind and topography. The ERC is over the 90th percentile. We are currently six weeks ahead in seasonal drying. Consider all fuels available. Be mindful of your proximity to the escarpment.

SPECIFIC FIRE BEHAVIOR:

Branch I

Division A & Division C: Minimal fire behavior, interior smoldering. SW wind should help keep fire in its current footprint.

Division I: Fuel and topography driven fire will continue to consume fuels and move to the North. Expect group torching, long-range spotting and slope reversal. Heavy concentration of fuels.

Branch IV

Division N: Interior smoldering islands will be susceptible to torching and spotting. Potential for turbulent winds east of the escarpment.

Division R & Division T: Smoldering heavy fuels and islands under windy conditions can spread embers into receptive fuel beds (grass and sage) near Hwy 395. Potential for spotting under strong downslope winds.

Branch VII

Division V: Minimal activity. Smoldering and creeping. Under windy conditions fire activity can increase.

Division X/Z: Minimal activity, interior smoldering. Potential for increased activity due to SW winds.

Night Division

High temperatures and low RH in the beginning of the shift. Moderate RH recovery on ridge tops. Be mindful of wind shifts and speeds due to topographical features. The shift will start with a Pig of 80-90% diminishing after midnight. Expect fire activity to diminish after 0300. Anticipate strong down slope winds and erratic fire behavior east of the escarpment.

...Stronger Wind Gusts this Afternoon & Evening...

WEATHER DISCUSSION: An **Excessive Heat Warning** remains in effect today with temperatures around 15 degrees above normal. A disturbance passing over the Pacific Northwest will bring an increase in winds again this afternoon and evening then diminishing after sunset with lighter terrain influenced winds prevailing overnight. Continued very dry with low afternoon humidity followed by poor to moderate overnight recovery. Warm conditions may persist well into the night in some areas, especially in Branch IV.

WEATHER FORECAST for MONDAY:

Weather obs around fire area



WEATHER: Mostly sunny and hot. Areas of smoke.

TEMPERATURES: Valleys/Lower Slopes: 97-103° Mid-Slopes/Ridges: 90-97°

HUMIDITY: 7-14% **HAINES INDEX: 6 (High potential for large fire growth)**

20 FT WINDS:

RIDGETOP - Southwest 5-10 mph increasing to 15-20 mph by afternoon. Gusts to around 30 mph.

SLOPE/VALLEY - Upslope/upvalley 4-8 mph in the morning, becoming west southwest 12-18 mph with gusts to around 30 mph in the afternoon.

STABILITY/INVERSION: Moderate stability in the morning, inversion around 5500', lifting late morning.

WEATHER FORECAST for MONDAY NIGHT:

WEATHER: Areas of smoke, otherwise mostly clear.

TEMPERATURES: Valleys/Lower Slopes: 60-72° Mid-Slopes/Ridges: 65-77°
(Warmest along mid-slopes in thermal belt)

HUMIDITY: Valleys/Lower Slopes: 35-50% Mid-Slopes/Ridges: 25-35%
(Lowest along mid-slopes in thermal belt)

20 FT WINDS:

RIDGETOP - Southwest 15-20 mph with gusts to around 30 mph in the early evening, decreasing after sunset to southwest 5-10 mph.

SLOPE/VALLEY - West southwest 12-18 mph with gusts around 30 mph in the early evening diminishing after sunset and transitioning to downslope/downvalley 1-6 mph.

STABILITY/INVERSION: Becoming more stable overnight with inversion developing after midnight.

OUTLOOK for Tuesday through Thursday: The **Excessive Heat Warning** will remain in effect Tuesday, with only slight cooling expected. Further cooling will occur through Thursday with temperatures lowering to a little above normal. Gusty west to southwest winds will continue each afternoon and, followed by lighter terrain driven winds overnight. Relative humidity remaining low with poor to moderate overnight recovery.

Carbon Monoxide, Particulate Matter, and Smoke Exposure

General signs and symptoms and associated levels of CO exposure:

- **Low** - No appreciable effect, except shortness of breath on vigorous exertion; possible tightness across the forehead; dilation of cutaneous (along skin) blood vessels.
- **Moderate** - Shortness of breath on moderate exertion; occasional headache with throbbing in the temples, Headache; irritable; easily fatigued; judgment disturbed; possible dizziness; dimness of vision.
- **High** - Headache, confusion; collapse; fainting on exertion Unconsciousness; intermittent convulsion; respiratory failure, death if exposure is long continued.

Identify hazards and mitigations prior to operational shifts. As fire increases, anticipate an increase of Carbon Monoxide, Particulate Matter, and Smoke in areas that previously were clear of smoke and reducing firefighter smoke exposure.

Firing Operations

Have a firing plan in place. Brief all resources in firing operations, identify all resources.

- Post adequate Lookouts.
- Have a good starting and ending point for firing.
- Hazards: Drip Torch Fuel, Firing Devices and Projectiles.
- Wear and use all PPE.
- Know what your fire is doing at all times.

POTENTIAL FOR EXTREME FIRE BEHAVIOR

- Review "Alignments and Patterns for Dangerous Fire Behavior" (IRPG p.73).
- Monitor current weather conditions and forecasts.
- Make sure all personnel receive thorough briefings every shift.
- Identify unburned pockets of fuel.
- Maintain adequate escape routes and safety zones. Set trigger points.

Maintain Situational Awareness!

WILDLAND URBAN INTERFACE

- Maintain continuous situational awareness.
- Key to success in the WUI is preparation and preplanning.
- Be active and engage in defense preparations and don't wait for the fire to arrive.
- Be decisive in tactical engagement. Know when to engage or disengage.

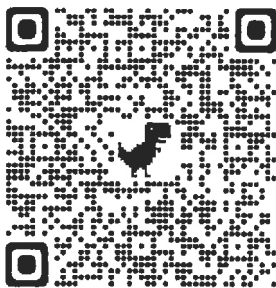

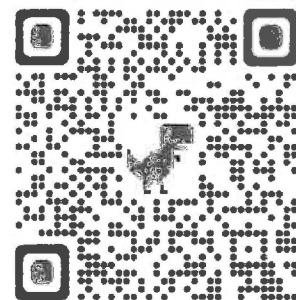

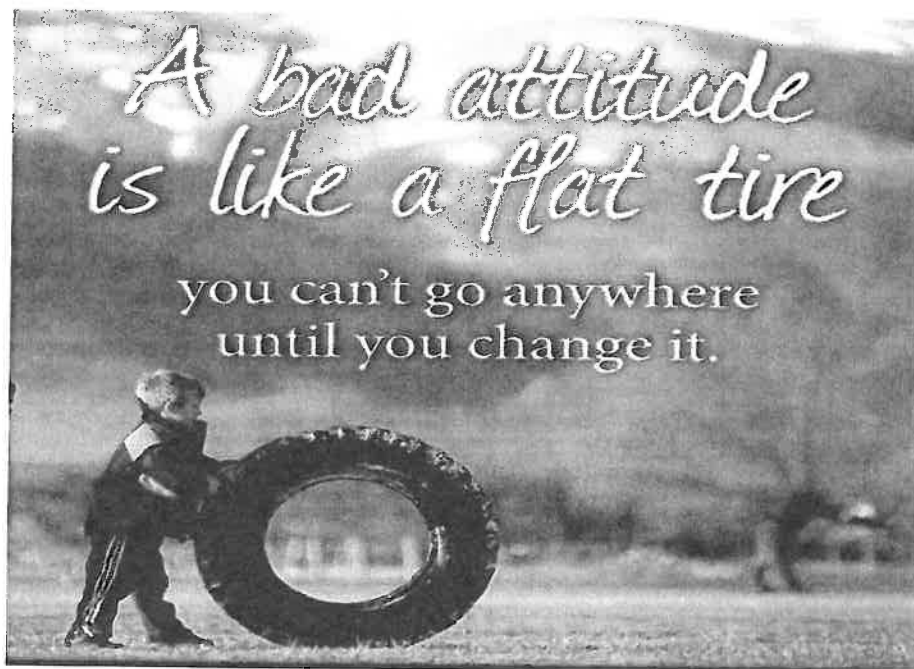
