**3. Objective(s):**

**Leaders Intent:**

- An aggressive full suppression strategy will be implemented for the Monument Fire. Efforts will be made to minimize impacts for residences, critical infrastructure, commercial timberland and surrounding communities through the application of well-planned tactical responses.

**Management Objectives:**

- Ensure that strategies and tactics provide for firefighter and public safety through the application of sound risk management principles.
- Minimize the threat to private property, communities, businesses and critical infrastructure.
- Establish and strengthen cooperator, partner and stakeholder relationships.
- Follow identified standard procedures to minimize the spread of COVID-19.
- Communicate effectively and often with the public and surrounding communities.
- Minimize the cost of the incident by employing tactics that have the highest probability of success while minimizing firefighter exposure.

**Control Objectives**

- Keep the fire North of Highway 3 and Highway 36.
- Keep the fire South of Siskiyou and Trinity County line, while preserving wilderness characteristics.
- Keep the fire East of the South Fork of the Trinity River and the New River.
- Keep the fire West of Canyon Creek and Trinity River.

**4. General Situational Awareness:**

- Diurnal winds will continue to challenge suppression efforts..... see attached Spot Weather Forecast.
- Be prepared for very active to extreme fire behavior with long-range spotting.
- The fire is burning in the 2008 Cedar Fire footprint; be extra aware of snags and hazard trees.



### WEATHER DISCUSSION

Increased stability today with lingering moisture and partly cloudy skies during the day. Humidities will be a little higher today with moderate to good recoveries overnight in the lower elevations and poor recoveries in the thermal belts and along the ridges. General winds will be upslope and up the Trinity River Canyon with gusts up to 20 mph in the late afternoon. Light east ridge winds in the morning will become northwest during the early afternoon with gusts up to 25 mph lasting into the late evening.

#### SATURDAY:

**WEATHER:** Partly cloudy. Thick smoke.  
**MAX TEMPERATURES:** 85-95°F  
**MIN HUMIDITY:** 18-28%.  
**20 FT WINDS:** Ridges: Southeast 3 to 6 mph in the morning, becoming northwest 8 to 12 with gusts up to 25 in the late afternoon.  
 Drainages: Light winds in the morning becoming 6 to 8 mph with gusts up to 20 mph in the Trinity River Canyon during the late afternoon.  
**LAL:** 1  
**CWR:** 0%  
**HAINES INDEX:** 4  
**MIXING HEIGHT:** 100-400 ft AGL increasing to 8,500 ft AGL in the early afternoon.  
**TRANSPORT WIND:** West around 12 mph, becoming west around 4 in the evening.

**HAINES INDEX:** 4  
**MIXING HEIGHT:** 8,500 ft AGL decreasing to 100-400 ft AGL early in the evening.

### Sunday/Monday Outlook

Temperatures will remain hot with humidities in the low 20s during the afternoons with moderate to good overnight recoveries. A weak trough moving through northern California will bring a slight increase in northwest winds to the ridges

and enhance the upcanyon winds.

## INPUTS

### WEATHER SUMMARY:

**\*\*\* Warm and Dry...Winds Switch Directions \*\*\***

Increased stability and partly cloudy skies. Humidity will be higher today with good overnight recoveries. Winds will be upslope, with gusts up to 20 mph in the late afternoon. Light east ridge winds become northwest during the early afternoon, with gusts up to 25 mph.

#### Day

Max.Temperatures- 85°-95° Min. Humidity- 8 to 28% Winds-SE to 6 mph, then NW to 12mph, **Gusting 25!**

#### AIR OPERATIONS:

Sunrise: 06:19

Sunset: 20:10

Expect poor smoke dispersion before the inversion breaks by late in the morning. Mixing heights start out at less than 400 feet; rise to 8,500 feet with daytime heating; then return to less than 400 feet after sunset. Anticipate terrain induced turbulence in the Trinity River corridor, especially during peak hours of afternoon heating, and in the vicinity of any building, mature, or dissipating thunderstorm .

## Driver Safety/Traffic Safety

- ✓ *Many roads are steep. Avoid heating up your vehicle's brakes!! Use the transmission's gears when possible.*
- ✓ Driving conditions and stopping distances will change when the roads are dusty, wet, or muddy.
- ✓ Be familiar with the traffic plan for your division, and any division you may travel in.
- ✓ Stop and look at all unmarked intersections before proceeding.
- ✓ Use extra caution on HWY 299. Watch your speeds! Beware of falling rocks and trees.
- ✓ Beware of congested vehicle and pedestrian conditions in the Base Camp parking lots and sleeping areas.

**REMAIN FIRE FOCUSED!!...COVID AWARE!**

## Air Operations

- Follow aviation watch out situations on page 46 of the IRPG.
- Do not plan on air resources for medical transport or resupply.
- Refer to page 58 of the IRPG for properly directing retardant and bucket drops.
- Ensure positive communications with all air resources.
- Look for flying objects and debris from nearby retardant and water drops.
- Be sure to always monitor the air to ground frequency so that you are not caught off guard.

## Safety Zones (IRPG pg# 8)

Separation distance between the firefighter and the flames should be at least four times the maximum continuous flame height. Distance separation for flat terrain and no wind is the radius from the center of the safety zone to the nearest fuels.

- Provide structure defense for the communities of Burnt Ranch, Friedrich Road, Cedar Flat and Underwood Mountain.
  - Patrol and mop-up previous firing operations from Highway 299 to DP 59.
  - Conduct firing operations from DP 59 south towards DP 52.
  - Continue to prepare Underwood Mountain Road, the 60 Road, and indirect handline/dozer line from DP 52 south to DP 50.
  - Continue firing operations from N28A Spear West Road to the N23 Road.
  - Defend structures along Corral Bottom Road/47 Road, and Progeny Site in south half of Section 19.
  - Monitor fire on the north side of the Trinity River and south of Ironsides Lookout. If the fire spots to the south side of the Trinity River, notify PG&E immediately.

- Store equipment at Drop Points. Secure all equipment to prevent theft.
  - GPS all pump locations and turn in to Division.
  - Backhaul all trash to appropriate disposal site.
  - Document any area that may have hazmat or unknown chemicals.
  - Red and black candy striped flagging identifies known Arch sites. Please avoid entering these areas and direct equipment around the perimeter.



**WORK/REST GUIDELINES**

Work shifts that exceed 16 hours and/or consecutive days that do not meet the 2:1 WORK/REST Ratio should be the exception, and no work shift should exceed 24 hours. However, in situations where this does occur (INITIAL ATTACK), incident management personnel will resume 2:1 WORK RATIO as quickly as possible.

The intent of the guidelines is to manage fatigue and provide flexibility for ICs and AAs managing Initial Attack, Extended Attack, AND large fires. The guidelines are designed to ensure that for every 2 hours of work or travel, 1 hour of time off shall be provided within a 24-HOUR period. It does not matter when the 24-hour period starts; all time recorded on the clock is counted as actual hours of work and time off the clock is counted as hours of rest, including meal breaks.

THE IC OR AA must justify work shifts that exceed 16 hours and those that do not meet 2:1 WORK/REST RATIO. Justification will be documented in the daily record (CTR/SHIFT TICKET). Documentation shall include mitigation measures used to reduce fatigue.

**MAKE SURE TO INCLUDE THE JUSTIFICATION IN THE REMARKS SECTION OF YOUR CTR/SHIFT TICKET IF YOU EXCEEDED THE 16 HOURS. YOU ARE REQUIRED TO GET THE IC'S SIGNATURE ON THESE CTR/SHIFT TICKETS.**

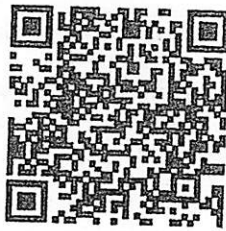

It may be unsafe to shoot photos or video and a firefighter who is concentrating on a camera may lose their situational awareness. When this happens, it could reflect poorly on all that are assigned to the incident.

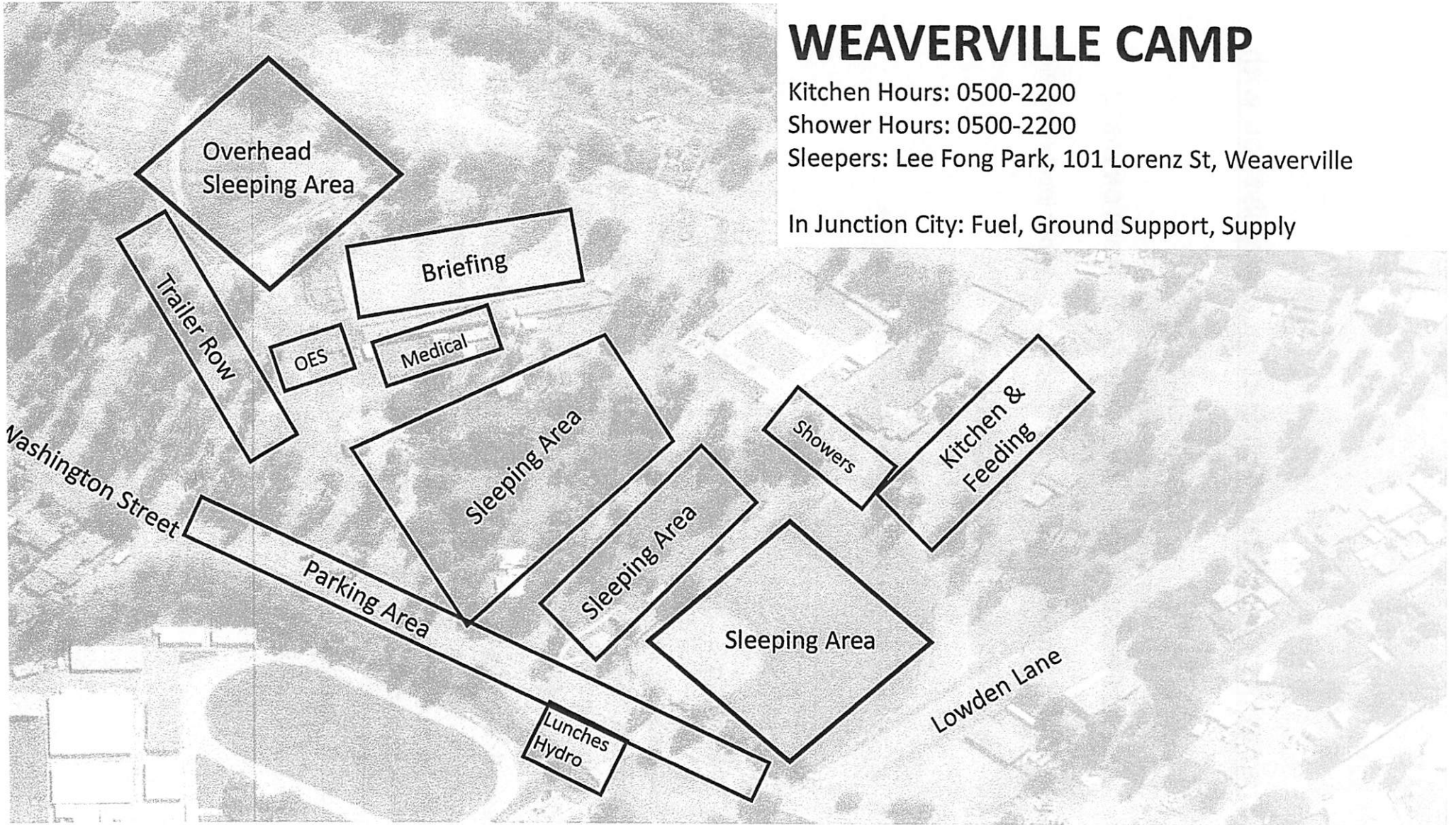

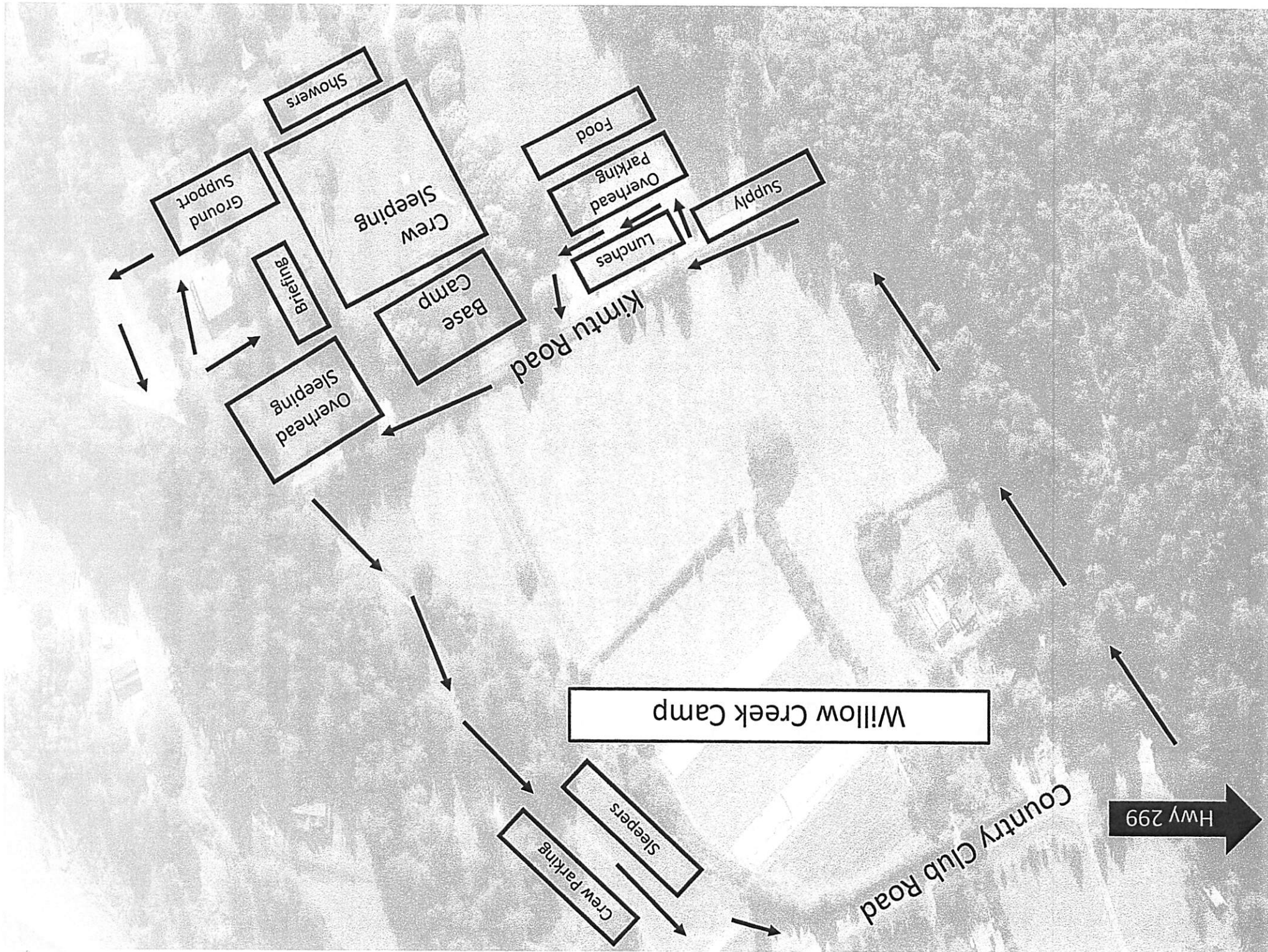
