DISCUSSION. High pressure will begin to take hold over the region today, causing subsequent warming and drying conditions across the fire. Smoke will once again be the wildcard in the forecast, with shading continuing to moderate weather conditions. Should any clearing occur, expect rapid changes to both weather and fire behavior. Above average temperatures are expected today and overnight, with low min RHs -- some reaching into the single digits -- and poor overnight recoveries.

FRIDAY: Sloshing smoke, dense at times. Areas of partial clearing.
CWR: 0% **LAL:** 1 **Stability:** Unstable afternoon

SPECIFIC:

- **All Divisions: All Sizes of Fuels are very DRY, very AVAILABLE, very RECEPTIVE...**

Flame Lengths- 2-6 ft. in Grass, Up to 30 ft. in Brush/Understory...Diminishing after midnight

Rate of Spread- 20 chains/hour in Grass, Up to 80 chains/hour in Brush...Slowing overnight

Spotting Distances- Up to .25 miles from Grass/Brush, Up to 1 mile in Timber (From Torching)

Probability of Ignition- Up to **90%** at the peak of the burn period, Diminishing to <40% overnight

Expect poor smoke dispersion before the inversion "breaks" by late morning. Look for poorer dispersion the further east you go. Mixing heights start out at less than 500 feet; rise to 8,000 feet with daytime heating; then return to less than 500 feet after sunset. Anticipate terrain induced turbulence in the Trinity River corridor, especially during peak hours of afternoon heating.

Act Deliberately, Not Urgently

- When committing personnel to a fire, have a plan. Ensure that your plans are clearly communicated and that everyone clearly understands your intent and the hazards that are associated with your plan.
- Do not be afraid to say no. Refer to page 19 in the I.R.P.G. for guidelines on properly refusing risk. Do not act beyond the limits of your training or ability.
- Ensure that escape routes and safety zones are clearly defined and made known to all fire fighters. Post lookouts and ensure that you know what radio frequency you will be using for tactics and command. Make sure LCES is in place prior to taking action.
- Review the “8-Line,” Incident within and Incident plan in your IAP. Spend time during breakout briefings discussing possible scenarios involving an incident within an incident. Know who that on-scene IC will be.

Fire Fighter Fatigue: Please continue to get enough rest. Take plenty of breaks and please continue to stay hydrated by drinking plenty of water. Ensure that all fire fighters meet the 2:1 work to rest ratio. Watch out for signs of fatigue in other fire fighters around you.

Snags/Hazard Trees: Maintain situational awareness and point out snags to others. Snags continue to fall in the burned area and near the fire line. Ensure that everyone is aware of the presence of snags and widow makers. Do not park vehicles under them. Use flagging tape to keep others out of the area.

Operational Leadership

- **Take Charge** of assigned resources.
- **Anticipate** changing conditions and potential emergencies.
- **Motivate** firefighters with a “can do safely” attitude.
- **Demonstrate Initiative** by taking action in the absence of orders.
- **Communicate** by giving specific instructions and asking for feedback!
- **Supervise** at the scene of the action.
- **Follow-Up** with feedback and suggestions for improvement.

Texting While Driving is Prohibited!

1. Texting while driving is against California State Law and is enforced by local and state law enforcement agencies.
2. 25% of all auto accidents in 2020 were attributed to cellular phone use while driving. *Taking your eyes off the road for 5 seconds while traveling 55 MPH, is equivalent to driving the length of 1 football field without looking at the road!*



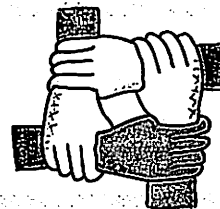
For federal employees associated with the Monument or Knob Fires, if you are injured, please contact the COMP UL for the Authorization for Treatment (CA-16). We can issue the form directly to the hospital or clinic, but we need full names and SSN for the required forms prior to being able to do that. The employee or supervisor should contact me as soon as possible or upon arrival at the hospital, whichever is convenient.

For claims there are different forms needed based on the circumstances of the property loss or damage. Please contact me first to find out which forms are appropriate for your situation, and what additional information might be needed. This will expedite the process. Unserviceable items must be turned into COMP if you are unable to replace at Supply. If items are lost or damaged on the fire line, the fire suppression module must provide a copy of the module's standard inventory with the documentation of broken or unserviceable items.

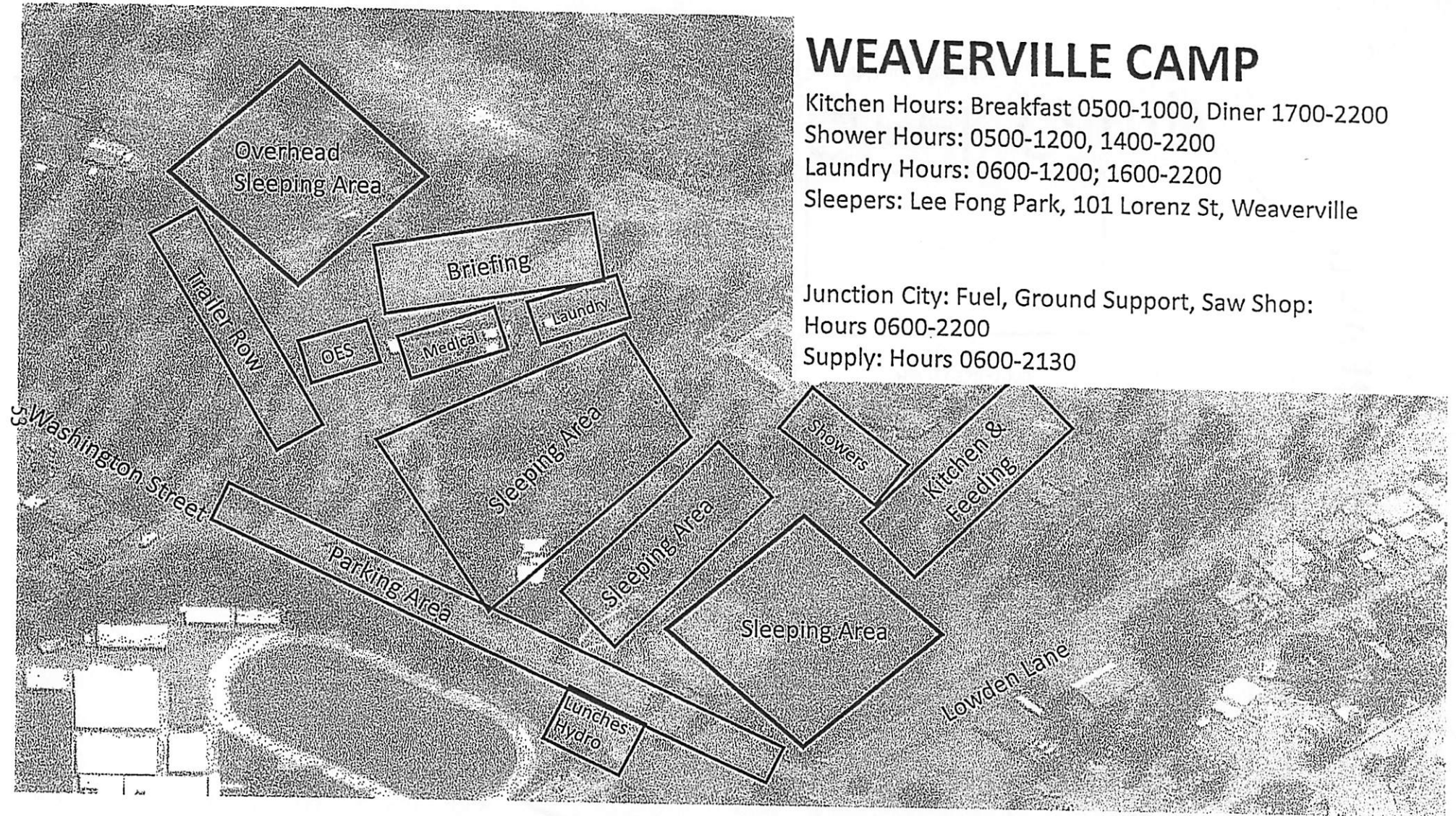

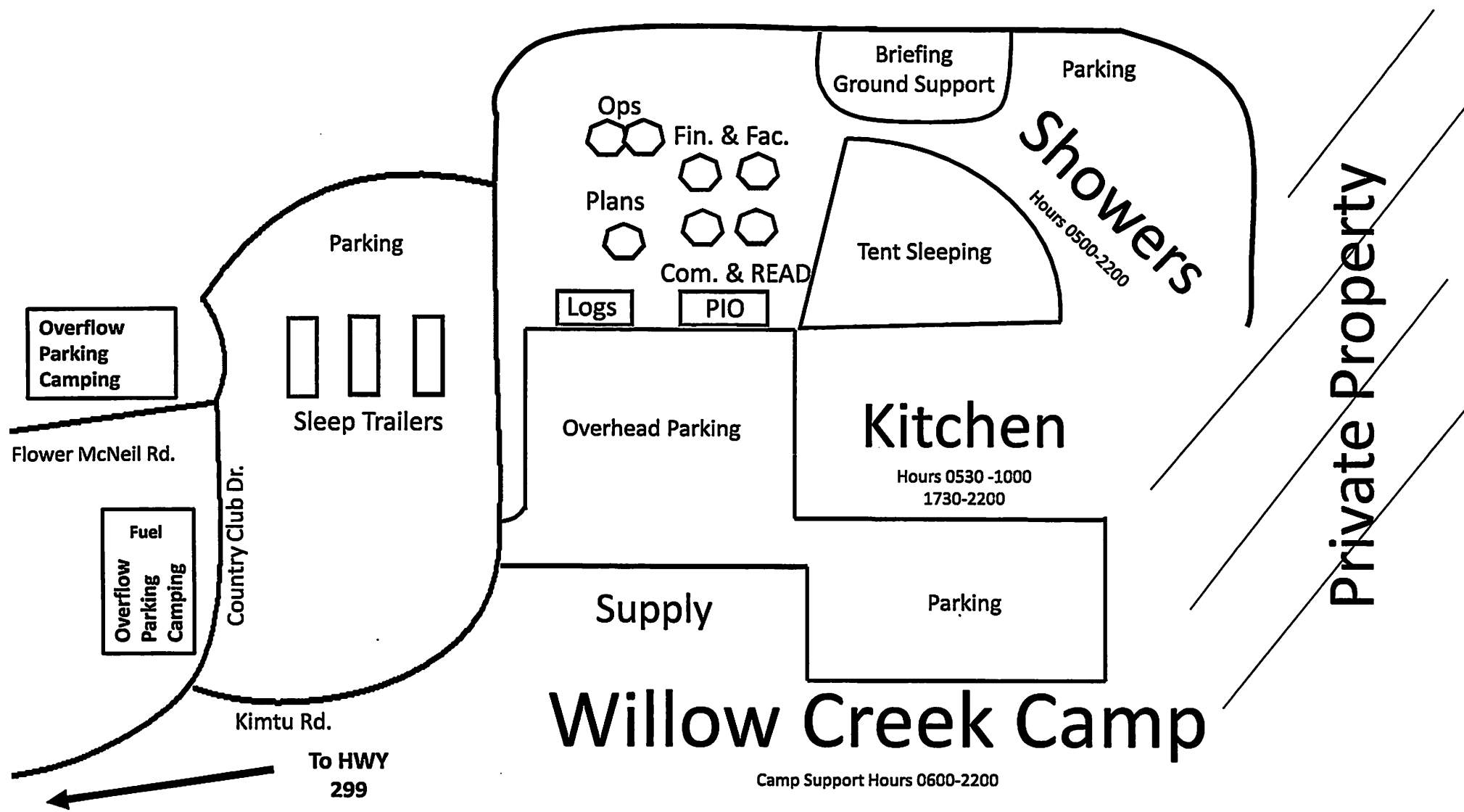
