



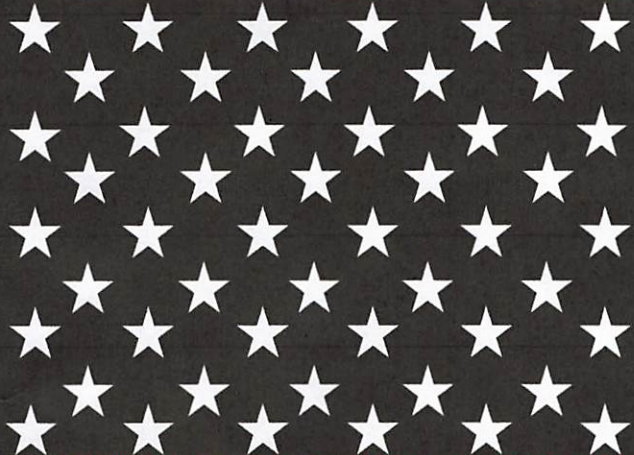

Leaders Intent

- An aggressive full suppression strategy will be implemented for both the Monument and Knob Fires. Efforts will be made to minimize impacts to residences, critical infrastructure and surrounding communities through the application of well-planned tactical responses.

Management Objectives

- Ensure that strategies and tactics provide for firefighter and public safety through the application of sound risk management principles
- Minimize the threat to private property, communities, businesses, and critical infrastructure.
- Protect the values within the Trinity Alps Wilderness, the Trinity Wild and Scenic River corridor, Inventoried Roadless Areas, and habitat for anadromous fish and other endangered and sensitive species.
- Establish and enhance cooperators, partner, and stakeholder relationships.
- Follow identified CDC, local, state, and federal procedures to minimize the spread of COVID-19.
- Minimize the cost of the incident by employing tactics that have the highest probability of success while minimizing firefighter exposure.



DISCUSSION. West-southwest flow aloft begins to take hold over the area today as temperatures rebound and RH starts to fall. A more typical terrain-driven wind regime favoring variations of westerly flow is expected with speeds between 5 to 10 MPH and gusts to 15 MPH. Partly cloudy skies will give way to mostly sunny conditions into the late morning/early afternoon.

Each dogleg in the creek presents an adverse wind profile where fire can escape through spotting. Wind eddies will occur in these areas along with complex wind profiles. Watch for slope reversal in DIV Z as the prevailing W slackens and the fire responds to fuels and slope. Evaluate re-burn potential.

Division U: Spot fires can occur up to 1/4 mile from the fire pushed by the prevailing WSW wind, expect continued northern spread from fuels and terrain.

Division K: Expect spotting, mostly uphill, northern spread will be checked by wind direction and drainages continuous to the Denny Rd. Slope reversal possible with fuel and terrain driven runs.

Division L: Flanks will fill in drainages under China Peak and Thurston Peak where fuels are continuous.

AIR OPERATIONS:

Expect poor smoke dispersion before the inversion "breaks" at 1400 hours. Earliest access to the fire by aircraft will be in the W divisions.

SAFETY

Spotting is possible. Ensure escape routes when suppressing spot fires. Anticipate aggressive and established burning conditions in areas pre-conditioned for re-burn.





We can issue the form directly to the hospital or clinic, but we need full names and SSN for the required forms prior to being able to do that. The employee or supervisor should contact me as soon as possible or upon arrival at the hospital, whichever is convenient.

For claims there are different forms needed based on the circumstances of the property loss or damage. Please contact me first to find out which forms are appropriate for your situation, and what additional information might be needed. This will expedite the process.

Unserviceable items must be turned into COMP if you are unable to replace at Supply. If items are lost or damaged on the fire line, the fire suppression module must provide a copy of the module's standard inventory with the documentation of broken or unserviceable items.

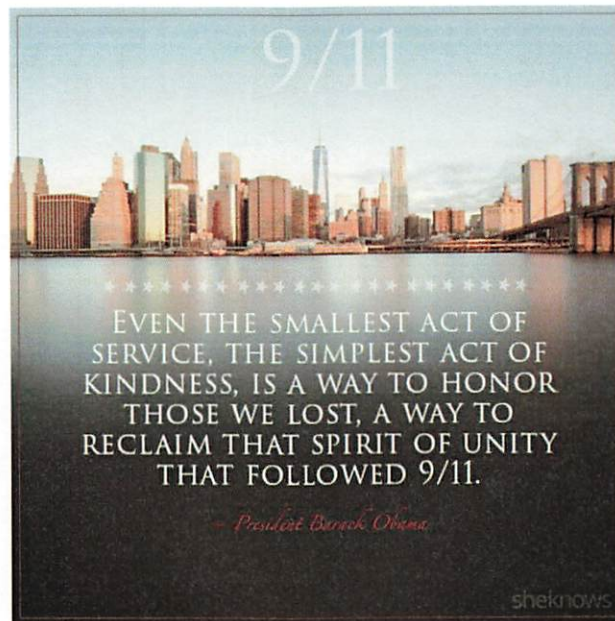

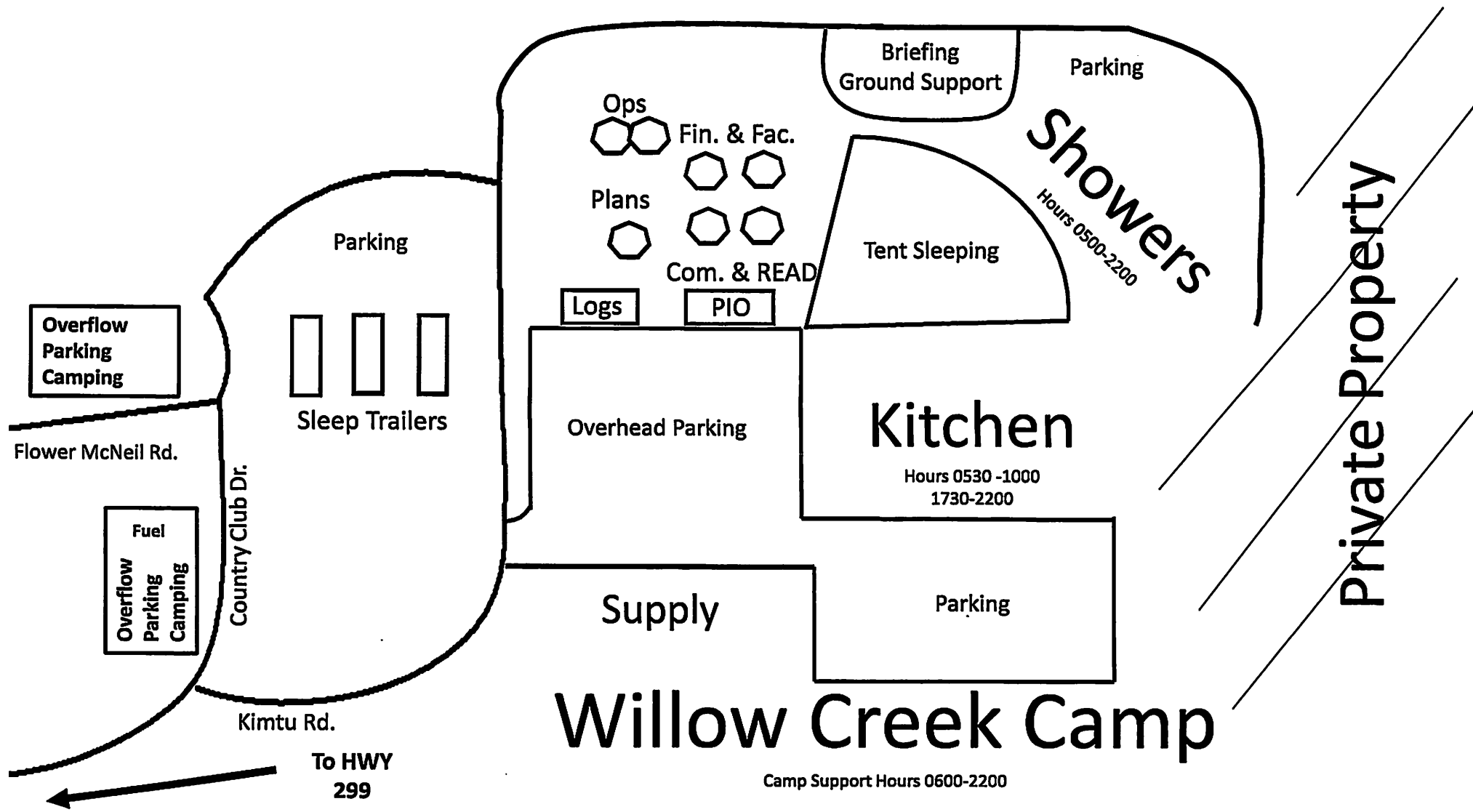


WEAVERVILLE CAMP
