KLAMATH NATIONAL FOREST FOREST ORDER No. 05-05-22-12

EMERGENCY FIRE CLOSURE – McKinney Fire

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Oak Knoll and Scott River Ranger Districts of the Klamath National Forest. This Order is effective from October 1, 2022, through October 31, 2022.

- 1. Going into or being upon National Forest System lands within the McKinney Fire Restricted Area, as described in Exhibit A and shown on Exhibit B. **36 C.F.R. § 261.52(e)**.
- 2. Being on any National Forest System Road within the McKinney Fire Restricted Area, as listed in Exhibit A and shown on Exhibit B. **36 C.F.R. § 261.54(e)**.
- 3. Being on any National Forest System Trail within the McKinney Fire Restricted Area, as listed in Exhibit A and shown on Exhibit B. 36 C.F.R. § 261.55(a).
- 4. Entering or using any Developed Recreation Site within the McKinney Fire Restricted Area, as listed in Exhibit A and shown on Exhibit B. 36 C.F.R. § 261.58(b).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire-fighting force in the performance of an official duty.
- 3. Owners or lessees of land in the area to the extent necessary to access their property.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

EMERGENCY FIRE CLOSURE – McKinney Fire Restricted Area Exhibit A

The boundary of the McKinney Fire Restricted Area begins at the intersection of Forest Road No. 46N53 (Collins Creek Road) with Siskiyou County 8G-004 (Walker Road) in Township 46 North, Range 10 West, Section 14, east of Brown Bear River Access Point, then continues easterly along the southern edge of Siskiyou County 8G-004 (Walker Road) to the intersection with Siskiyou County 8J-001 (Klamath River Road) and Barkhouse Creek Road in Township 46 North, Range 8 West, Section 13, then continues easterly along the southern edge of Siskiyou County Road No. 8J-001 (Klamath River Road) to the intersection with Township 47 North, Range 8 West, Section 11 east of Gottville River Access Point, then continues easterly along the northern edge of Township 47 North, Range 8 West, Section 11, then continues southerly along the eastern edge of Township 47 North, Range 8 West, Section 11, then continues easterly along the northern edge of Township 47 North, Range 8 West, Section 13 and Township 47 North, Range 7 West Section 18, then continues southerly along the eastern edge of Township 47 North, Range 7 West, Section 18, then continues easterly along the western edge of Siskiyou County Road No. 8J-002 (Humbug Creek Road) to the intersection with Siskiyou County Road No. 7H-002 (Middle Fork Humbug Road) to the intersection with the eastern edge of Township 45 North, Range 8 West, Section 11, then continues southerly along the eastern edge though Township 45 North, Range 8 West, Section 11 and Section 15, then continues westerly along the southern edge and northerly along the western edge of Township 45 North, Range 8 West, Section 15, then continues easterly along the southern edge of Township 45 North, Range 8 West, Section 9 to the intersection with Forest Road No. 45N53 (Collins Creek Road), then continues along the northern edge of Forest Road No. 45N53 (Collins Creek Road) northerly, then continues north westerly along Forest Road No. 45N28 (High CCC Road) to the western edge of Township 45 North, Range 8 West, Section 16, then continues along the southern edge of Township 45 North, Range 8 West, Section 8, then continues along Forest Road No. 45N49 (Deadwood Road) through Township 45 North, Range 8 West, Section 8, Section 7, Section 18 and Township 45 North, Range 9 West, Section 13, then continues southerly along Forest Road No. 45N52 (Indian Baldy Road) through Township 45 North, Range 9 West, Section 24, then continues westerly along the southern edge of Township 45 North, Range 9 West, Section 24 and Section 23, then continues north westerly along Forest Road No. 45N84X (Baker Cabin East Road) to the intersection with Latitude 122° 52' 30", then continues southerly along Latitude 122° 52' 30", then continues westerly along the southern edge of Township 45 North, Range 9 West, Section 20 and Section 21, then continues north westerly along Forest Road No. 45N63 (Scott Bar Stage) to the western edge of Township 45 North, Range 9 West, Section 20, then continues northerly along the western edge of Township 45 North, Range 9 West, Section 24 and Section 20 and Section 17 to Forest Road No. 45N27 (Mill Creek Road), then continues easterly along the northern edge of Forest Road No. 45N27 (Mill Creek Road), then continues northerly along the western edge of Township 45 North, Range 9 West, Section 18 and Section 7, then continues westerly along the southern edge, northerly along the western edge, and easterly along the northern edge of Township 45 North, Range 10 West, Section 1, then continues northerly along the western edge of Township 46 North, Range 9 West, Section 31, then continues along Forest Road No. 46N53 (Collings Creek Road) though Township 46 North, Range 10 West, Section 36, Section 35, Section 26, Section 22, and Section 23, then continues along the northern

edge of Township 46 North, Range 10 West, Section 23 and Section 14 to it reaches its starting point at the intersection of Forest Road No. 46N53 (Collins Creek Road) with Siskiyou County 8G-004 (Walker Road) in Township 46 North, Range 10 West, Section 14, east of Brown Bear River Access Point.
