Implement a full suppression strategy on the McKinney Fire. Values at risk include human safety, private timberlands, communities, critical infrastructure and associated improvements. Apply tactics that offer the highest probability of success.

- Management Objectives**
- Provide for firefighter and public safety through hazard recognition and application of the risk management process.
  - Coordinate all public information with CALFIRE to provide timely and continuous information to affected agency partners, cooperators, and the public.
  - Work with Resource Advisors to implement the fire suppression repair plan.
  - Ensure timely, efficient mobilization and demobilization of critical resources.

- Leaders Intent**
- Provide the highest level of customer service to all involved with or impacted by the McKinney Fire. Ensure transparent, timely and accurate communication at all levels of the incident and strengthen relationships with cooperators. All incident assigned personnel should be prepared to take appropriate actions regarding:
- Personal safety and the safety of others, including driving slowly and defensively.
  - Fatigue management by taking breaks and maintaining work/rest cycles.
  - Limiting exposure to infectious disease by implementing Center of Disease Control, California Department of Public Health, and agency guidelines.
  - Professional behavior, and timely/effective communication.
  - Keep supervisor informed on personnel changes to ensure LWD and personnel names assigned to the incident are accurate.

- Control Objectives**
- Keep the McKinney Fire contained to the current fire perimeter to prevent the fire from spreading to private property, surrounding communities, and other values at risk.

# Danger Tree Abatement Plan McKinney Fire

## Klamath National Forest

### Happy Camp/Oak Knoll Ranger District & Salmon-Scott River Ranger District

Fell danger trees in areas where suppression activities created hazard trees that would hit designated travel routes. Danger trees can be abated (felled) near designated features to provide for immediate firefighter and/or public safety. If after felling, downed trees pose a threat to firefighter and/or public safety, then remove and deck these trees in a location that does not pose a threat to firefighter and/or public safety. All work will be done only on National Forest System lands. Distances from the target feature are based on the following priorities:


- a.) Slash will be (in order of preference): chipped, lopped and scattered, or piled in a manner that will not impact man-made structures including but not limited to water tanks, water lines, irrigation ditches, roads, road borrow ditches, and water diversion structures.
- b.) Material extending three (3) feet or more outside the edge of a pile will be trimmed.
- c.) An eight (8) foot slash bay will be cleared of all but fine material around each machine pile and
- d.) When needed, an appropriate fire line will be cleared to mineral soil around the outer ring of the slash bay.
- e.) When lopped and scattered, all branches must be cut from main stem when main stem exceeds three (3) inches in diameter
- f.) Slash or chips must be spread to a height of not more than one (1) foot. Tree stems will be bucked, as necessary, to meet this height requirement and to avoid “jack-strawing” trees on top of one another.
- g.) All piles will be reasonably compact and free of soil to facilitate burning and will be constructed of such size and at such distance from trees so that burning will not result in unnecessary damage to residual timber.









**Stump Height:**

Stumps will be cut to a height of not more than **12 inches** from the high side of the stump, unless approved in writing by the Agency Administrator Representative or their designee.

Per the IC's letter dated 8/28, lodging and per diem have been authorized since the fire is currently not providing a camp, food, water. Therefore, federal and cooperators are to follow their agency's travel guidelines. Contractors are to comply with their contract.

Please note, in Yreka, California, US General Service Administrations (GSA) locality rate is \$96 for lodging and per diem (includes food and water) is \$59.

For contractors, please note, the Government will pay actual lodging expenses or the per diem locality rate published by the GSA, whichever is less. Double occupancy of hotel rooms is required. Any associated lodging taxes are reimbursable as documented. Lodging receipts, as well as documentation by incident personnel that a campsite was not provided, shall be submitted as supporting documentation with payment documents.

## **FIRELINE EMERGENCY PROTOCOL FOR THE MCKINNEY FIRE:**

- First person to arrive on-scene will be the Incident Commander of the IWI (Incident-Within-an-Incident) until relieved by a more highly qualified person (example: DIVS)
- IWI IC contacts Division Supervisor with nature of incident, location and immediate needs (i.e. ambulance).
- IWI IC contacts:
  1. Dispatch (“Yreka”) on Command (Black tone 1, 2 or 10) and states “Emergency Traffic” (this will stop unnecessary radio traffic on that channel).
  2. Closest incident medical resource (Line EMT/Medic/AMBU) on Command or Tac as appropriate.
- Dispatch notifies McKinney IC, who will notify:
  1. Operations
  2. Safety
  3. Comps/Claims
  4. Agency Administrator
- Division Supervisor will support needs of the IWI along with Line Safety.
- IWI IC will complete the Medical Incident Report (8-Line) to Yreka Dispatch (located in the IAP (Incident Action Plan):
  - Key Components:
    1. Identify emergency: life threatening (red) or non-life threatening (yellow or green)
    2. Identify nature of emergency, # of patients, patient assessment
    3. Identify location, transport/evac possibilities
- Dispatch will mobilize ground and/or air ambulance as needed
  1. Contact incoming ground ambulance on CDFSKU tone 1 or 5
  2. Contact incoming air ambulance on CALCORD tone 6

## **AFTER-HOURS EMERGENCY PROTOCOL:**

- Utilize 9-1-1 system to initiate medical response
- Contact YOUR supervision for the McKinney Fire.
- Then, your supervisor will contact the McKinney IC via phone with patient complaint/condition and location.


