

MAP 1 Description: If the fire is established East of the North-South Line through French Meadows Dam

Value to protect:

- SPI lands to South and South-West of the reservoir
- PG&E power lines, Ellicott Bridge
- Big Cedar Geologic Area, Lake Cedar Geologic area
- Middle Meadows Group Camp, Rec sites and Campgrounds around Hell Hole Reservoir
- Sacramento Municipal Utility District infrastructure and Rec sites around Union Valley reservoir, Ice House Reservoir, Crystal Basin

Location of Actions:

- East of Fire, Branch 10

Associated Actions:

- Notify: Via LOPR
- SPI representative
- Tahoe National Forest
- To the extent practicable area needed, Law Enforcement
- Reestablish the planning area
- Time to Implement: Notification: 5 min. Additional planning: 3-5+ days

Hazard exposure:

- Power Lines
- Extended access/egress
- SNUGs

Action is associated to the planned confinement perimeter

Considerations: The need to evacuate and protect developments/improvements around French Meadows reservoir. Feasibility of direct block. Consider threats to the Tahoe Basin Management Unit.

MAP 2/3 Description: If the fire becomes established East of the North-South line through the Ellicott Bridge.

Value to protect:

- SPI Land
- PG&E power lines, Ellicott Bridge
- Big Cedar Geologic Area, Lake Cedar Geologic area
- Middle Meadows Group Camp, Rec sites and Campgrounds around Hell Hole Reservoir
- Sacramento Municipal Utility District infrastructure and Rec sites around Union Valley reservoir, Ice House Reservoir, Crystal Basin

Location of Actions:

- East of Fire, Branch 10

Associated Actions:

- Notify: Via LOPR
- Eldorado National Forest agency representative
- SPI representative
- LE ESDG rep
- Sac Municipal Utility District

Time to Implement: Notification: 5 min. Additional planning: 3-5 days

Leadership: DIVV/Group or Higher

Other: Law Enforcement, MWD

Hazard exposure:

- Ellicott Bridge is a potential entrapment area
- Power Lines on Nevada Power Ridge and North of Hell Hole res
- SNUGs in American and King Fire burn scars

Action is associated to the planned confinement perimeter

Considerations: Consider evacuation warnings/for East and South East of Union Valley and Ice House reservoir and Crystal Basin. Opportunities for direct attack in the Subsonic River estuary limited.

MAP 4 Description: If the fire becomes established South of Westworth Springs rd or the fire becomes established in the Otter Creek drainage.

Value to protect:

- Need to reevaluate values at risk and current fire behavior
- Communities of Volcanville, Georgetown, Chiquita, Otter Crk, Quintette, SPI land, PG&E powerlines, ENF rec sites, and Blodgett experimental forest (SW to East/Southeast). Location of Actions: Notification, Branch 25

Associated Actions:

- Notify: Via LOPR
- Eldorado National Forest agency representative
- SPI rep
- LE ESDG rep
- Evaluate the need for evacuations based on current fire behavior

Time to Implement: Notification: 5 min. Additional planning: 3-5 days, depending on conditions time may be limited.

Leadership: DIVV/Group or Higher and 2 TFLD

Other: Law Enforcement

Hazard exposure:

- State Routes
- Wildland
- Access/Egress

Action is associated to the planned confinement perimeter

Considerations: Consider evacuating evacuations to Garden Valley and State Mountain areas to the South. Resource needs TBD based on actual fire behavior at time of event.

MAP 5 Description: If the fire becomes established North of Foresthill road.

Value to protect:

- Communities in the greater Foresthill area
- Michigan Bluff
- Washburn
- SPI land South of Cottage Home Hill
- Multiple Tahoe National Forest rec sites in the Sugerpine area
- North Fork American River Wild and Scenic Corridor. Location of Actions: Notification, Branch 10

Associated Actions:

- Notify: Via LOPR
- Eldorado National Forest Agency Administrator
- SPI rep
- PG&E
- Notify Placer County Sheriff's Office for evacuations of zone 11A
- Notify BLM Agency rep Jason Schroeder (916-350-1443)

Time to Implement: Notification: 5 min. Additional planning: 3-7 days

Leadership: 1 DIVV, 1 Group Sup, 4 TFLD

Other: TRO by OSC

Hazard exposure:

- Power Lines
- Traffic

Action is associated to the planned confinement perimeter

Considerations: Consider evacuating evacuations to include Placer County Sheriff's Office area 11A. Resource needs TBD based on actual fire behavior at time of event.

MAP 6 Description: If fire progression will threaten the Big Trees Botanical area.

Value to protect:

- PG&E power lines
- Big Trees Botanical area and Infrastructure Location of Actions: Notification, Branch 10

Associated Actions:

- Notify: Via LOPR
- Tahoe National Forest agency representative
- SPI rep
- PG&E
- Notify Placer County Sheriff's Office for evacuations of zone 11A
- Notify BLM Agency rep Jason Schroeder (916-350-1443)

Time to Implement: Notification: 5 min. Additional planning: 3-5 days

Leadership: 1 TFLD, 1 FRB

Other: TRO by OSC

Hazard exposure:

- Frontal Assault

Action is associated to the planned confinement perimeter

Considerations: Firing already conducted around the Big Trees site, evaluate the need to implement action if fire is established in Big Trees Botanical area.

MAP 7 Description: If fire becomes established North of Foresthill in the Todd Valley area and/or West of Todd Valley.

Value to protect:

- Communities in the greater Foresthill, Todd Valley area
- PG&E utilities
- Middle Fork American River Wild and Scenic Corridor. Location of Actions: Notification, Branch 10/25 western break

Associated Actions:

- Notify: Via LOPR
- Tahoe National Forest and Eldorado National Forest agency reps
- CAL FIRE agency rep and local gov reps
- LE rep
- Consider the need for unified command, bringing in state and local gov reps
- Notify BLM Agency rep Jason Schroeder (916-350-1443)

Time to Implement: Notification: 5 min. Additional planning: 3-5 days

Leadership: 1 DIVV, 1 Group Sup, 2 TFLD

Other: Law Enforcement

Hazard exposure:

- Wildfire
- Powerlines
- Traffic

Action is associated to the planned confinement perimeter

Considerations: Consider evacuations of Placer County Sheriff's Office zone 15. Unified command.

MAP 8 Description: If the fire becomes established West of the line from the Junction of Westworth Springs rd and HWY 193 North to Foresthill PD Station

Value to protect:

- Communities in the greater West Foresthill, Todd Valley area, Auburn Lake Trails, Greenwood, Georgetown, Cool
- Washburn Bar OHV area
- Middle Fork American River Wild and Scenic Corridor. Location of Actions: Notification, Branch 10/25 western break

Associated Actions:

- Notify: Via LOPR
- CAL FIRE and state agency reps
- Tahoe and Eldorado NF agency reps
- Re-establish the fire planning area
- Notify Placer County Sheriff's Office for evacuations of zone 11A
- Notify Placer County Sheriff's Office for evacuation of Cool zone

Time to Implement: Notification: 5 min. Additional planning: 3-10 days

Leadership: 1 OPRD, 2 DIVV

Other: Law Enforcement

Hazard exposure:

- Wildfire
- Powerlines/Utilities

Action is associated to the planned confinement perimeter

Considerations: Consider evacuation of Placer County Sheriff's Office Cool zone and zone 11A.

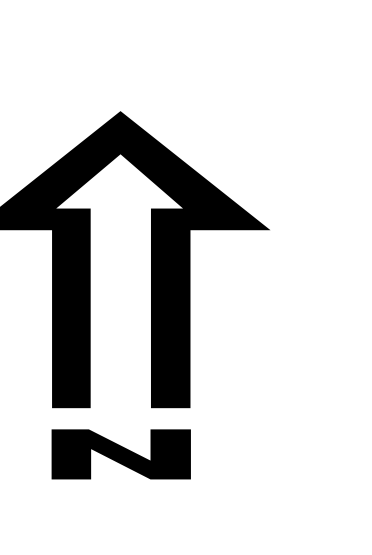
