- Keep the fire East of Drivers Flat Road.
- Keep the fire West of Eleven Pines.

...Rain Showers Today with Gusty Southwest Winds...
...Heaviest Rain Showers Late Tonight through Monday...

WEATHER DISCUSSION: A cold storm system will move inland today bringing cloudy skies and a chance of light showers in the morning, with a better potential for some wetting rain in the late afternoon and evening. Southwest winds could gust up to 24 to 28 mph over ridges in the afternoon. Higher humidity and cool temperatures in the 50s are expected. Heavier rain showers are expected late tonight through Monday. Isolated thunderstorms possible Tuesday. Periods of wet weather are possible into Wednesday.

Sunday Weather:
TEMPERATURES: 58-62 below 2000 feet and 50-58 2000-5000 feet.

MINIMUM HUMIDITY: 50-58%...12 percent higher.
20 FT WINDS:

RIDGETOP - Southeast 4 to 7 mph early morning becoming southwest 5 to 10 mph gusts 17 mph by 1200, 8 to 12 mph gusts to 24 to 28 mph by 1500.

SLOPE/VALLEY - Light upslope through midday then up canyon 4 to 8 mph gusts to 10 mph afternoon.

INVERSION: Morning inversion lifting around 1100 hours. **MIXING HEIGHT:** 5000 feet

Sunday Night: Good humidity recovery.

TEMPERATURES: 43-48...4 degrees cooler.

MAXIMUM HUMIDITY: 85-100%...15 percent higher.

20 FT WINDS:

RIDGETOP - Southwest 5 to 8 mph with gusts to 20 through 1900 then turning southeast 4 to 8 mph.

SLOPE/VALLEY - Evening up canyon 5 to 9 mph, down canyon 4 to 7 mph after 2300.

STABILITY/INVERSION: Weak inversion setting up around 2300 below 5000 feet.

OUTLOOK FOR MONDAY Wetting rain showers. Southwest ridgetop winds with gusts to 15 mph. Temperatures will be seasonably cool in the 50s. Afternoon humidity 70-80% with nighttime recovery around 100%.

EXTENDED FORECAST: Cooler weather continues Tuesday, with highs in the mid-50s to low mid-60s with southwest ridge winds gusting to 11 mph. Rain showers with isolated thunderstorms are possible, accompanied by periods of locally heavy rain. Rain showers linger into Wednesday. Dry and warmer weather returns by Thursday.

FIRE BEHAVIOR

GENERAL: Backing and smoldering outside of wind gusts. Heavy fuels will maintain heat & rekindle potential after precip. 1- & 10-hr fuels will become mostly unavailable.

RH & precipitation will minimize fire activity. Little movement expected. Fuels reacting to a week of moisture with ERC, BI, & 100-hr values now below average.

SPECIFIC:

Branch III / V / XX / XXV: No fire spread anticipated with expected weather event. Heavy fuels can retain heat for rekindle potential after weather system passes.

Branch X / XV: Little to no spread anticipated, mostly smoldering. Potential for minimal fire spread between pockets of showers, especially with wind gusts.

AIR OPERATIONS:

Limited visibility until smoke clears from rain. Cloud cover.
 Mixing height: 5,000 ft. AGL, Transport winds: S 24 mph, Sunrise 0647, Sunset 1907.

Fuels and Fire Behavior Advisory

Northern California

September 2nd, 2022



Subject: Potential for extreme fire behavior due to critically elevated fire danger indices, low live and dead fuel moistures, and very hot and dry conditions across much of northern California.

Discussion: An extended period of hot, dry weather with embedded periods of enhanced winds will impact Northern California. The elevated fire weather concerns with fuels reaching their yearly minimum moisture values will create conditions conducive to long range spotting, rapid fire growth, and high resistance to control.

Difference from normal conditions: The current values for Energy Release Component (ERC) are at or above the 90th percentile for the majority of Northern California, with live fuel moistures dropping to critical levels as herbaceous and woody fuels cure. These conditions will be exacerbated by a predicted heat wave, resulting in anomalous daytime highs with little relief in temperature or humidity recovery overnight. Some PSA's, may reach daily record ERC values, with all covered PSA's predicted to reach or exceed the 97th percentile for an extended period. The combination of extreme ERC's with high temperatures and poor overnight humidity recovery is highly correlated with extreme fire behavior in Northern California.

Concerns to Firefighters and the Public:

- The advisory coincides with the Labor Day holiday weekend that is likely to result in increased outdoor recreation and visitor use to public lands across Northern California. The increase in public use carries an increased risk of fire starts as well as potential for evacuations of visitors/recreational users in the event of a fire starting.
- Energy Release Component (ERC) in areas covered by this advisory are at or above the 90th percentile and are expected to approach or exceed the 97th percentile. **Anticipate increased spread rates, long range spotting, and active nighttime burning.**
- The combination of persistent drought, a building heat wave, and a very dry atmosphere will continue to decrease already low fuel moisture values:
 - 1000-hour fuel moistures are below average and approaching the 90th percentile,
 - Live woody fuel moisture in brush is near or slightly below average, making them readily available and will likely reach critical levels because of the forecasted hot, dry weather.
 - The above average herbaceous fuel load at low and mid elevations (below 5,000 ft.) is fully cured, with high elevation herbaceous fuels rapidly curing during the hot, dry forecast.
 - Higher than average surface fuel loading is present in areas that experienced winter snow and ice storms in the Coast Range and northern Sierra Nevada.
- **Expect fires to ignite easier and spread faster. Do not expect fires to exhibit reduced fire behavior when entering areas of live fuels; anticipate increased spread rates and spotting.**
- Periods of enhanced winds are expected during the hot and dry period. Given the current and anticipated fuels conditions, increases in winds will make direct attack of any new starts difficult and may hamper use of aerial resources.
- Review the current North Ops Outlooks and national fuels and fire behavior advisories.

Mitigation Measures:

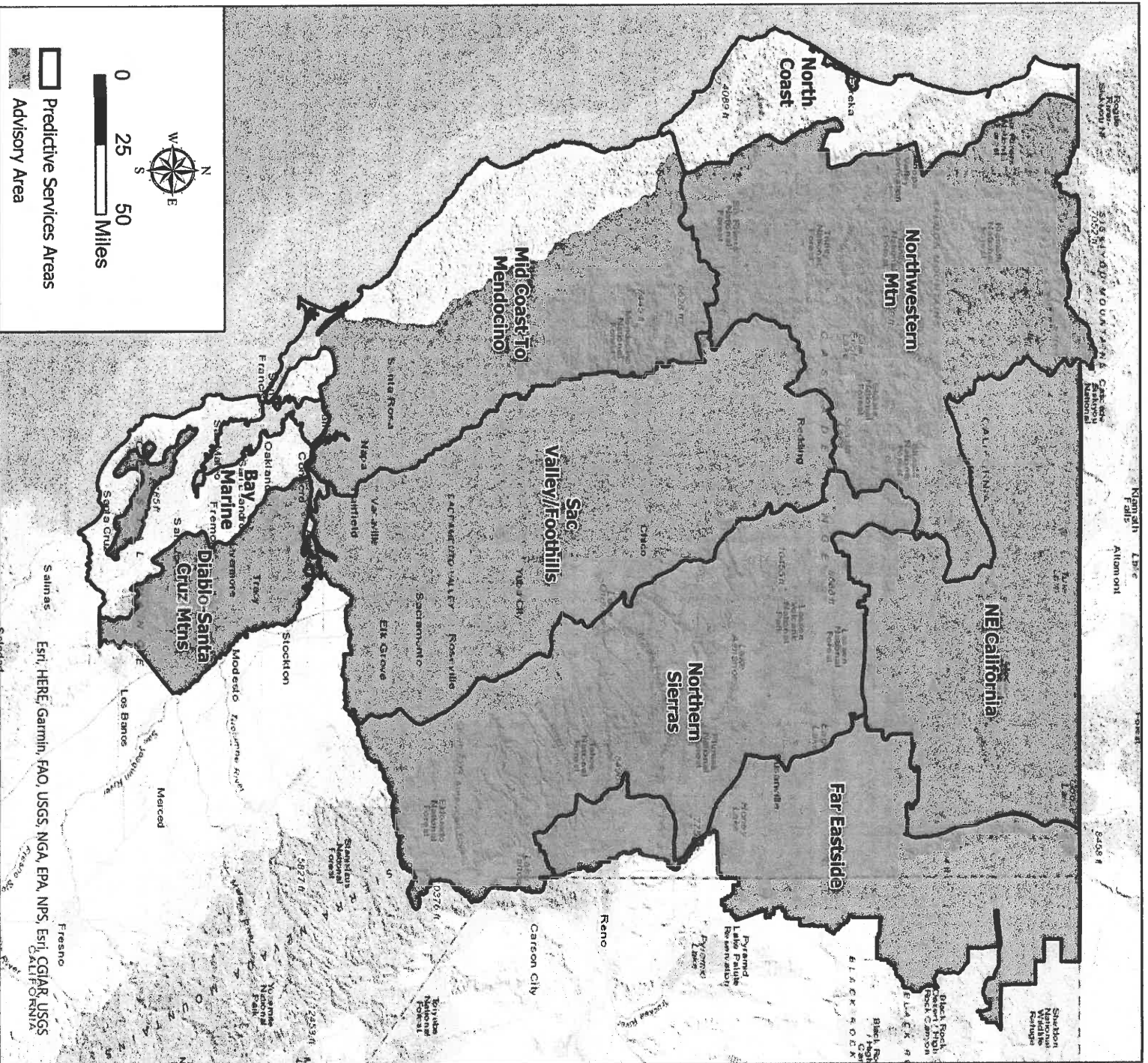
- Suppression actions need to be based on good anchor points, escape routes, and safety zones.
- **Remember LCES. Experienced lookouts are essential under these conditions.**
- Base all actions on current and expected behavior of the fire. **Augment initial attack resources as incident activity dictates**
- Fire managers should be aware of high use recreation and visitor sites in their area. **The holiday weekend will bring increased visitor use, increasing risk of starts during critical fire weather.**

Area of Concern: Northern California except for the following Predictive Service Areas: North Coast, Bay Marine, and west of Highway 101 in Mid-Coast to Mendocino.

RAIN EVENT

- Crew leaders should know and apply measures to enhance safety during rain events. The basic measures include:
- Seek shelter in vehicle during rain. Park away from hill sides where unstable soil caused by the fire may come down.
 - Stay away from areas that may be prone to funneling water such as drainages.
 - Reduce speeds and increase braking distances if driving, be cautious of slick road conditions, especially where retardant has been applied.
 - Ensure windshield wipers are functioning properly, headlights are on for your visibility and others.
 - Keep a safe distance from hazardous trees.
 - Stay dry; seek shelter, find cover in your tent or building at base camp, or inside your vehicle.
 - Winds at higher elevations are predicted to reach 30 mph early in the shift, increasing the threat of aerial hazards.

RISK OF HYPOTHERMIA

- The condition of having an abnormally low core body temperature.
- Occurs with core body temperature below 95 degrees.
- Symptoms:
 - Shivering slow shallow breath, slow weak pulse.
 - Altered level of consciousness, drowsiness and slurred speech.
- Mitigations:
 - Remove wet clothing, protect against wind.
 - Move to a warm dry shelter, begin gentle rewarming.
 - Offer warm liquids only if conscience and alert.
- **SEEK MEDICAL ATTENTION!**

Learn From Today

- Give, and demand, a quality briefing... Every shift!
- Speak up, ask questions, listen, have clarity, and communicate!
- Plan ahead!
- Evaluate the day's activity at the end of shift (AAR).
- Adjust the plan, based on what you learn.

THE DRIVE HOME

- Cumulative fatigue is a reality, many resources have completed a 14 day or extended 21 day assignment.
- Don't be in a hurry, follow posted speed limit signs and slow down when road conditions warrant.
- Take breaks as needed and manage fatigue.
- All personnel in the vehicle **MUST** wear seatbelts.
- Use safe following distances.
- Ensure all headlights, brake lights, turn signals, and windshield wipers are operating correctly.

MOSQUITO BASECAMP MAP

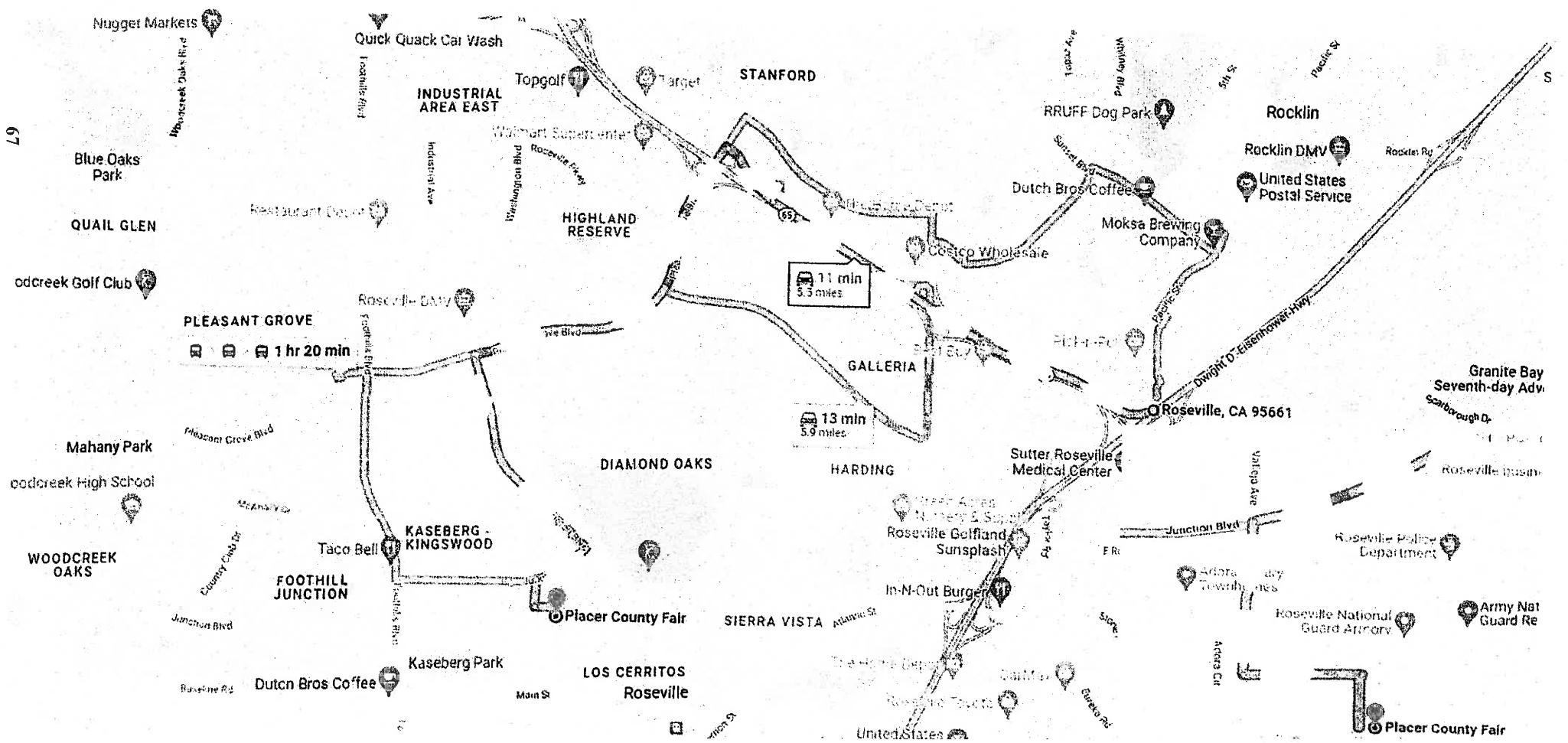


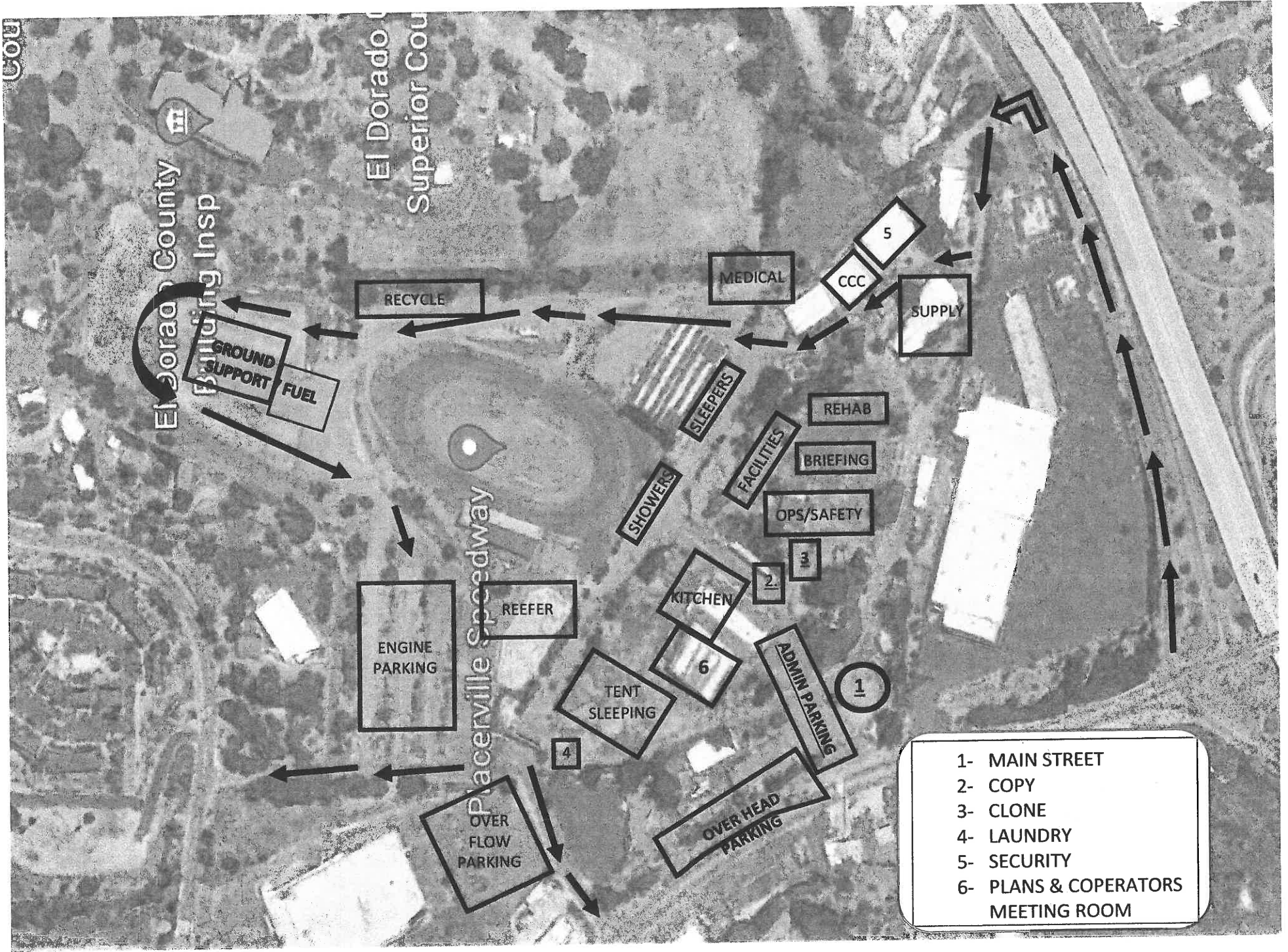

- Update Communications once the patient has been transported.
- Close the loop with **MEDT** at the end of shift.

"Yellow or Green" NON-EMERGENCY MEDICAL PLAN:

- Contact Division / Communications and declare you have a **"Non-Emergency Medical."**
 - Complete the 8-line if needed and turn it in to the medical unit at the end of the shift
- ICP/Camp Emergencies**
- ICP- Dial 911

Medical Incident Report

FOR A NON-EMERGENCY INCIDENT: WORK THROUGH CHAIN OF COMMAND TO REPORT AND TRANSPORT INJURED PERSONNEL AS NECESSARY.

FOR A MEDICAL EMERGENCY: IDENTIFY ON SCENE INCIDENT COMMANDER BY NAME AND POSITION AND ANNOUNCE "MEDICAL EMERGENCY" TO INITIATE RESPONSE FROM COMMUNICATIONS

Use the following items to communicate situation to communications/dispatch.

1. CONTACT COMMUNICATIONS / DISPATCH (Verify correct frequency prior to starting report)

Ex: "Communications, Div. Alpha, Stand-by for Emergency Traffic."

2. INCIDENT STATUS: Provide incident summary (including number of patients) and command structure.

Ex: "Communications, I have a Red priority patient, unconscious, struck by a falling tree.

Requesting air ambulance to Forest Road 1 at (Lat/Long.)

*This will be the Trout Meadow Medical Incident, IC is TFLD Jones. EMT Smith is providing medical care."
