**Leaders Intent**

Provide the highest level of customer service to all involved with or impacted by the Mosquito Fire. Ensure transparent, timely, and accurate communication at all levels of the incident; and strengthen relationships with stakeholders and cooperators. All assigned personnel shall be prepared to take appropriate action regarding:

- Personnel safety and the safety of others; including driving slowly and defensively.
- Fatigue management by maintaining work/rest cycles, taking breaks, and being fit for duty.
- Minimization of risk and exposure to infectious disease through implementation of Center of Disease Control, California Department of Public Health, and agency guidelines.
- Professional behavior, conduct, and timely/effective communication.

**Management Objectives**

- Provide for firefighter and public safety through hazard recognition and application of the risk management process.
- Coordinate suppression activities, suppression repair, and hazard tree abatement with assigned incident resource advisors to minimize impacts on natural and cultural resources.
- Provide initial attack assistance to both the Eldorado and Tahoe National Forests.

**Control Objectives**

- Keep the Mosquito Fire within the current perimeter.



**WEATHER DISCUSSION:** Warm and dry conditions will persist. Overnight humidity recovery was once again hampered by dry east-southeast winds. These winds will hold along the ridges through the early morning, before they shift to more typical diurnal/slope-driven winds in the afternoon. Gusts to 20 mph will be possible in the early morning for those working above 5,000'. Afternoon humidity will hold in the mid teens before coming up a bit in the late afternoon.

**Thursday Weather:** Sunny and dry. Breezy along the ridges in the early morning.

**TEMPERATURES:** 81-84 below 3000 feet and 75-79 3000-5000 feet...no change.

**MINIMUM HUMIDITY:** 15-20%...down 2%. Increasing to 20-30% by late afternoon.

**20 FT WINDS:**

**RIDGETOP** - East southeast 12 to 16 mph with gusts 20 mph through 1000, becoming west to southwest 6 to 10 with gusts 15-18 mph.

**SLOPE/VALLEY** – Southeast 4 to 8 with gusts 12 mph through with 1000, then switching to up canyon 4 to 7 mph, with gusts 10-12 mph through the afternoon.

**INVERSION:** Morning inversion lifting around 1100 hours. **MIXING HEIGHT:** 4000 feet **LAL:** 1

**Thursday Night:** Clear. Another night of enhanced east to northeast winds overnight along the ridges. Poor humidity recovery again.

**TEMPERATURES:** 56-63...no change.

**MAXIMUM HUMIDITY:** 16-21%...down 2%.

**20 FT WINDS:**

**RIDGETOP** – West to southwest 6 to 9 mph through 1900, then northeast-east 9 to 14 mph with gusts to 18 mph overnight.

**SLOPE/VALLEY** – Up canyon 3 to 6 mph early, becoming light and variable, then becoming down canyon 5 to 8 mph at 2200.

**STABILITY/INVERSION:** Shallow inversion setting up overnight. **LAL:** 1


**OUTLOOK FOR FRIDAY:** The pattern will be very consistent to end the week. Temperatures will run a few degrees above normal reaching into the mid 80s. Offshore winds overnight will hurt RH recovery. Expect afternoon RHs into the upper teens. Winds will be generally light and slope/diurnally-driven.

**EXTENDED FORECAST:** The ridge of high pressure will hold over the fire keeping things warm and dry. Temperatures should peak on Saturday before we start a slow and subtle cooling trend with higher RH values Sunday into early next week.

## INPUTS

Above normal temperatures with low day time RH's and poor overnight recoveries will continue to increase fuel flammability across all types and size classes. Periods of localized enhanced overnight winds will be felt on ridges in overnights periods, focused Wed night. **\*\* See daily Weather Forecasts for details/discussion\*\***

## OUTPUTS

### FIRE BEHAVIOR



#### GENERAL:

As warm, dry weather persists, fuels will continue to become more available following mid-September precipitation. Energy Release Component (ERC) values have increased to near 90<sup>th</sup> percentile values and may break some daily records. **This trend will increase fuel availability and lead to continued increases in fire activity in areas of remaining heat or uncontained fire line.** The increases include potential isolated torching as well as re-burn in areas with significant leaf or needle cast resulting from initial fire activity. Max spotting distances between ¼ & ½ of a mile.

In heavy timber understory and brush fuels, spots across fire lines or new initial attack fires could exhibit flame lengths at or exceeding the capability for direct action without water or air support. Rates of spread will be greatest in areas of slope and wind alignment, but the lack of a strong wind pattern is likely to make initial actions successful. Rates of spread may also be limited in grass and herbaceous fuels greening up from September precipitation, though this impact will wane in the next 1-2 weeks if no additional precipitation occurs.

#### SPECIFIC:

**Branch 10 (Div. J):** Existing containment lines expected to hold. Remaining Interior heat will result in slow to moderate spread in areas of unburned fuel or re-burn in areas with significant needle cast.

**Branch 25 (Div. U):** Low flame lengths with low to moderate spread in areas without containment. Isolated torching of brush and small trees is likely as fuels continue to dry and become available.

#### AIR OPERATIONS:

Air operations may be needed if fire escapes containment or during initial attack support. Inversions will impact air operations until late morning or early afternoon.

## SAFETY

The fire has been very mellow for multiple weeks, with limited heat detections via IR flights and none via satellite detection (MODIS/VIRS) in recent days.

**If the fire escapes containment or new IA fires occur, burning is likely to be far more aggressive than what your recent observations tell you!**

### **Hazards & Risks**

**Fire Camp Safety:** We usually don't think of Fire Camp as a dangerous place but camp has a few hazards to look out for:

- Trip hazards such as stairs, tent stakes, cables and wires are abundant.
  - Vehicle traffic in and around parking areas and driving through camp.
  - Electrical shock from all the power cords and power strips plugged in our tents, kitchen area, hand wash stations and shower unit.
  - Wildlife and insects.
  - Walking and talking or texting on our cell phones.
  - Sharp objects such as scissors, tacks, saws and nails.
  - Adverse weather; to name just a few Fire Camp Watch Outs.
- Sooooo pay attention to your surroundings and avoid distractions!

**Power line & Gas line Safety:** When working around powerlines, avoid parking or working under or near them. Communicate powerline hazards to all resources. Seek out power company advisers for information on specific hazards. ***Treat all powerlines and downed wires as energized!*** The same with high-pressure gas lines and propane tanks. Watch for buried or hidden lines, especially around structures. Sections of the gas line may be exposed above ground or buried in shallow ground. Consult with gas company representatives for guidance.

**Safety Reporting:** Safety Officers can't be everywhere or see every safety problem. It is incumbent upon every individual to make safety a priority in their daily work assignments. Please bring concerns or issues to the attention of a safety officer in order to maintain a safe working environment for all personnel.
