

...Breezy Southwest Winds and Cooler Tuesday and Wednesday...

WEATHER DISCUSSION: Little change is expected today, with mostly clear skies and warm temperatures continuing. Highs will reach the mid to upper-80s. Winds start out light of the east this morning, shifting to the southwest in the afternoon, with gusts to 13 mph over ridges, strongest at 1400. Afternoon humidity drops into the 20s. Tuesday into Thursday temperatures gradually trend down and humidity slightly trends up, along with some clouds and breezy southwest afternoon winds over ridges.

Monday Weather: Mostly sunny.

TEMPERATURES: 87-89 below 3000 feet and 80-87 3000-5000 feet...Little change.

MINIMUM HUMIDITY: 22-29%....Little change.

20 FT WINDS:

RIDGETOP - East 3 to 6 mph in the morning through 1100, becoming southwest 5 to 7 with gusts to 13 mph.

SLOPE/VALLEY – Down canyon 4 to 7 through 1000, then up canyon 4 to 6 mph with gusts to 8 mph through the afternoon.

INVERSION: Morning inversion lifting around 1300 hours. **MIXING HEIGHT:** 5400 feet **LAL:** 1

Monday Night: Clear. Moderate humidity recovery.

TEMPERATURES: 58-65...3 degrees higher

MAXIMUM HUMIDITY: 45-55%...5% higher.

20 FT WINDS:

RIDGETOP – Southwest 3 to 7 mph through 1900, then northeast 4 to 7 mph overnight.

SLOPE/VALLEY – up canyon 3 to 6 mph in the evening becoming light and variable, then becoming down canyon 4 to 8 mph at 2200.

STABILITY/INVERSION: Moderate inversion setting up overnight. **LAL:** 1

OUTLOOK FOR TUESDAY Dry and sunny weather continues. Southwest ridgetop winds 5 to 8 mph with gusts to 16 mph in the afternoon. High temperatures will warm to the upper 70s to mid-80s. Humidity trends a little higher, with afternoon humidity 23-29% and with night time recovery 45-55%.

EXTENDED FORECAST: Wednesday looks a little cooler with partly cloudy skies and high temperatures in the upper 70s to low-80s, with humidity around 25-30%. Afternoon ridge winds will be out of the southwest, gusting to 18 mph. Highs will be in the upper 70s to 80, cooling a few degrees more on Thursday

WEATHER SUMMARY: WARMING, DRYING TREND CONTINUES

Warming and drying. Mostly sunny.

Temp: 80-89 max; 58-65min

RH: 22-29% min; Night 45-55% max

Wind (20'): Normal diurnal flow expected, General daytime transport wind SW 5-7mph Gust 13 ridges; AM

Ridgetop E 5-7 becoming SW 5-7 in the afternoon; 1900: NE 4-7mph; 2200: Downcanyon 4-7mph

Fuel models: 10, TU5, TU1, SH2, TL6

OUTPUTS

FIRE BEHAVIOR

GENERAL: Smoldering and Creeping. Sunny skies and lowering RH. 1-hr and 10- hour available to burn in the afternoon. Night fine dead fuel moistures forecasted to hit 11 except for most exposed drier ridge tops.

RH low enough to support fire spread in the fine dead fuels in the afternoon. Little movement expected. Slow rates of spread 1-5ch/hr max. If fire gets established on an open S aspect aligned with wind and slope, spread rates of 8-12ch/hr max are possible. Isolated pockets of unburned fuel will have potential to support 2ft surface flame lengths.

Moving into a trend where isolated single tree torching may occur. This fire behavior will be isolated in nature.

Spotting distances will be short range less than a quarter mile max. Spotting from roll out as heavy fuels burn down on steep slopes may occur.

Fire activity (increasing potential) will continue in areas of the fire that are inaccessible as heavy fuels and duff layers continue to hold heat.

Expect an increase in smoke production as we continue to dry out. Expect to see more hot spots show themselves as we continue to dry out.

SPECIFIC:

Branch 10: Existing containment lines are expected to hold. Smoldering and creeping fire. If a spot occurs outside the main line, expect slow rates of spread and manageable fire behavior.

Branch 15/25: Smoldering and creeping fire. Minimal fire spread/growth in the forecast. Potential for isolated single tree torching, especially around jackpots of heavy fuels. Heat exists in heavy fuels - this can get into timber stringers, jackpots, and isolated pockets of fuels.

AIR OPERATIONS:

Mostly sunny with clear skies. Moderate inversion sets up overnight, light smoke settling in drainages in the AM. Mixing height: 5,400ft. AGL, Transport winds: SW 7mph, Sunrise 0651, Sunset 1900.

SAFETY

Be alert for any heat still present on a slope below your work area.

Fire weakened timber poses overhead hazards. Stump holes will continue to hold heat.

Words of the Day = Be Diligent

Diligent: having or showing care and conscientiousness in one's work or duties.

1. **On the Road Again** = Hazard Abatement, Suppression, and roads group are ramping up. If you are part of that group, **BE DILIGENT** When moving through a division let them know, use lead trucks, and scout your route. If you are on a road and see them coming **BE DILIGENT** Pull over and give them plenty of room. All should communicate the traffic to others when encountered.
2. **Fatigue/Compliancy** = Starting to feel like Groundhog Day? Getting a little worn down? **BE DILIGENT**. Are you ready for today's mission both mentally and physically? **BE DILIGENT** and watch out for one another. If something does not seem right with someone, talk to them. They may be your saviors one day and do you want them at 10 % or 100 %?
3. **Sneaky spots** – Well it has been a couple of days since the rain and things are drying out. Be on the lookout for new smokes. **BE DILIGENT**. Don't continuously keep your head down without taking a minute to look around. Keep your eyes open and if engaging, remember your LCES
4. **Where's Waldo?** As we move around camps and resources and operations change, there is a ready opportunity for missed communications and people get confused. **BE DILIGENT** in following communication responsibilities. When in doubt or feeling lost, **BE DILIGENT** and don't just wait or wander, reach out to leadership and confirm your mission.
5. Stings, scratches, and bites; starting to hear reports about bees, poison oak, and rattlesnakes. **BE DILIGENT** in checking out where you are sitting, sleeping, and working. If you see something, say something. For those that know they have allergies, let someone know.

Communication Responsibilities

All firefighters have five communication responsibilities:

- **Brief others as needed.**
- **Debrief your actions.**
- **Communicate hazards to others.**
- **Acknowledge messages.**
- **Ask if you don't know**
