## Warming and Drying Trend Continues

**WEATHER DISCUSSION:** No big day over day changes with high pressure over the region. Daytime highs will warm to around 90 degrees for the river valleys with upper 70s for the highest ridges in Branch XX. Skies should turn mostly sunny this afternoon with the increased sunshine helping to dry the fine fuels out while humidity values lower to as low as 25% in brushy fuels on southerly exposed aspects. Winds will remain light from the West on the ridges with diurnal winds for the lower slopes and river valleys. Good humidity recovery forecast tonight with low cloud and fog spreading into the river valleys overnight.

**Discussion:** No big day over day changes with a seasonal weather pattern in place. Plenty of sunshine expected this afternoon which should help to show any lingering heat in the heavier fuels and duff layers. Daytime highs briefly peaking in the mid 70s with afternoon humidity values around 55%. Winds will be westerly with light slope winds under the canopy. Marine clouds will spread onto the lower slopes overnight with full humidity recovery. Overnight lows in the lower 50s.

**Extended Forecast:** No big day over day changes are forecast the rest of the week and through the weekend. Daytime highs generally in the 60 and lower 70s with overnight lows in the 50s. Morning clouds giving way to afternoon sunshine which should continue to help expose any heat hiding in the duff layers while drying the fine fuels. No precipitation forecast other than localized fog or drizzle late night and early morning hours. Long range trends show a dry pattern through mid month and beyond.

**FUELS:** Primary fuels are conifer with litter and brush understory. The area has multiple burn scars adjacent to the fires with light fuels. Fire scars over 5-8 years old have a higher fuel load. Fire scars beyond 8 -10 years old generally have a significant dead and down component with higher and more continuous brush that will support substantially higher rates of spread and intensity under dry conditions.

### *Outputs*

#### **General**

Higher temps and lower humidity throughout the day will have a limited effect on fire spread potential again today. Fine dead fuels are still holding moisture, and high humidity recovery at night will reduce the effect of the warmer and dryer air. Down woody fuel moisture is high and this will last for several more days. Average to above average live fuel moisture in the timber and brush will remain. Fire Indices are below average for this time of year will be slow to rebound above a level that promotes fire growth.

#### **FIRE BEHAVIOR:**

Warmer and dryer air will start the drying process but the amount of daily solar radiation on the fuels will matter as well. All these factors will have a substantial affect on the fuels and the resulting potential for burning or fire spread.

Most of the fires in the complex show scattered heat that is distributed throughout the interior of the fire, but hotspots still exist along the perimeter of them as well. As solar radiation increases and warmer temperatures move into the area fuels will dry sufficiently enough that you will see an increase inn smoke over the next few days. Fire spread however will be very limited in the heavy fuels and will only spread actively through fine fuels exposed to the sun and wind.

#### **SAFETY:**

Although fire activity has moderated substantially, there are still lingering effects from the fire activity that can affect firefighters. Varied fire behavior will increase the likelihood that the hazard from snags, live trees and rolling debris will be prolonged, which can increase complacency where the fire did not burn intensely.

Share these points with the public as you have an opportunity.

- Recent rains have diminished fire intensity but have not put the fires out. Expect to see more smoke as the weather warms back up, although significant fire movement is unlikely.
- Firefighters are using a combination of direct and indirect attack to safely construct containment lines around the fires where possible. Several fires have already been fully contained and are being checked daily.
- Some of the more remote fires may not have constructed firelines but will be confined using natural fire breaks such as rock outcrops, ridgelines, and old fire areas until wetting rains put the fires out. This strategy provides for firefighter safety while minimizing resource disturbance.
- Suppression of the 2023 SRF Lightning Complex and Redwood Lightning Complex Fires is a collaborative effort involving US Forest Service, National Park Service, California State Parks, Karuk, Yurok, and Hoopa tribal authorities, and many other cooperators working together.
- Activities on the 2023 SRF Lightning Complex and Redwood Lightning Complex fires are being coordinated with other fires in the vicinity including the South Fork Complex, Happy Camp Complex, and Smith River Complex.

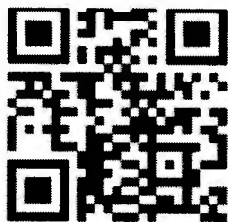

### **Complacency**

What has changed today – same section of line, same roads traveled, same elevated burning conditions – nothing has changed or has it? The reality is that things have changed, that is the only guarantee. Each day we brief that this a carbon copy of yesterday, but it is not. Challenge yourself to find what is different about today, your safety may depend on it. Avoid action focus – you are working in a complex environment full of hazards – step back to identify them and communicate them.

### **Human factors barriers to managing risk**

- **Low experience level**
  - ❖ Unfamiliar with work environment
- **Distraction from primary task**
  - ❖ Conflict
  - ❖ Previous errors
  - ❖ Collateral duties
- **Stress Reactions**
  - ❖ Communication deteriorates or grows tense
  - ❖ Habitual/repetitive behavior
  - ❖ Target fixation – “just try harder”
  - ❖ Action tunneling – “losing sight of the big picture”
  - ❖ Escalation of commitment – accepting more risk to complete the project
- **Hazardous attitudes**
  - ❖ Invulnerable – can’t happen to me
  - ❖ Anti-authority – disregard team effort
  - ❖ Impulsive – do something even if it’s wrong
  - ❖ Macho – trying to impress or prove something
  - ❖ Complacent – same old stuff
  - ❖ Resigned – we can’t make a difference
  - ❖ Group think – Afraid to speak-up or disagree
- **Fatigue**
  - ❖ Dehydration
  - ❖ Heat stress
  - ❖ Poor fitness level

### **Safety Teaming**
