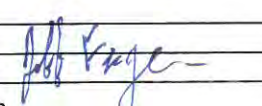

## WEATHER DISCUSSION:

Building high pressure will bring warm and dry conditions over the fire again today with temperatures 5-7 degrees above average. A long duration heat wave will start on Tuesday and bring dangerous heat to the lower elevations of the fire and fire camp at least thru the July 4<sup>th</sup> holiday period. This combination of high heat and low daytime RH will lead to an extended period of critical fire weather for most of next week. An Excessive Heat Warning is in effect starting Tuesday (7/2) thru Friday (7/5) including the Basin Fire and fire camp.

**MONDAY:** Smokey under the inversion breaking mid-afternoon, then sunny, hot and dry.

**MAXIMUM TEMPERATURE (deg F):**

87-93 degrees

**MINIMUM RELATIVE HUMIDITY:**

15-22%

### **WEATHER SUMMARY:**

**Temp:** Highs of 87-93 degrees.

**RH:** Minimum 15-22 percent.

**Winds:** Slope driven, 6-12mph early, then west 6-9mph gusts to 13mph.

**Night:** 64-72 degrees, RH 42-48%, down slope 6-12mph, Ridge NE 6-12mph

**Moonlight Illumination:** 31%

**Inversion:** Strong thermal inversion trapping smoke & haze over the lower terrain until mid afternoon.

### **GENERAL**

A Fuels and Fire Behavior Advisory has been issued for California Grass and Herbaceous-Dominated Ecosystems for above average fuel loading. This has created a continuous fuel bed, allowing for rapid spread of fire.

Fuels in the current fire area are predominately Grass with mixed Oak and brush, which is what the fire has taken advantage of so far. Notably the grass crop is the result of two good winters and is matted, resulting in higher resistance to control because retardant and water cannot penetrate all the way to the ground. Be aware that the fire may be creeping through the matted grass even if it seems to be controlled by retardant. Surrounding areas transition into brush, and timber with large amounts of dead and down, especially to the north near Dinky Creek. As the fire impacts these live fuels they will not support the higher rates of spread we have seen so far, the indices in live fuel and the heavies are not as severe as the average for this year. Therefore, aspect and fuels are going to be your best indicator for the Rate of Spread (ROS) you will see.

### **Specific areas of concern:**

**DIV A, D and M** - The primary concern for spread is in DIV A and D. The area west and north of Balch Camp and along Dinky Creek where the light flashy fuels begin to transition to heavier fuel loading. The drainage winds will aid in progressing the fire up canyon during the day. This will increase fire progression up drainage along Dinky Creek with opportunities for the fire to become established in dry stream beds with short runs leading up slope from Dinkey Creek. The west flank in this area will back against the wind to the west during the day with short up slope runs when slope, winds and fuels come into alignment, especially in lighter fuels. This activity could cause impacts to DIV U.

**DIV U** – Expect continued flanking and backing to the Kings River in the western and eastern portions of each of these divisions. This will increase the possibility of spotting from roll out and from swirling winds, especially in the areas where the river bends. Continue to be aware of the matted grass holding heat and continuing to move at the surface.

**Night:** Keep your situational awareness up with the winds in your area while paying attention to the wind shifting from up slope to down slope. Expect downhill/down canyon spread after the wind shifts during the night, and expect the fire to remain active well into early morning.

**Air Operations:** Smoke will adversely affect operations early in the day.

**What Makes Communication Difficult?**

**Words Mean Different Things to Different People**

Look up 500 different words in a dictionary and you will find over 2,500 meanings and/or definitions for those same words. To communicate effectively, both the speaker and the listener must have a mutual understanding of the words they use.

**The Presenting Problem May Not Be the Major Concern**

People often are hesitant to talk about what is really bothering them. The “real issues” are what they tend to hide most carefully. Trying to solve minor problems while the real problems are not clearly understood does not work. Doing this is a major source of ineffectiveness.

**Filters Distort What People Hear and Say and Emotions Are Blinding**

Our own expectations, experiences, values, biases, self-images, beliefs, ideas, worldview, etc. create a “zone of distortion”, the filter that distorts our interpretation of another person’s message. People are often unaware of how their emotions affect communications with others and emotions can literally put some people out of control and prevent them from communicating effectively.

**Here’s what to do to improve communication:**

Stand in the other person’s shoes. You have stood in the other person’s shoes when you repeat their point of view back to their satisfaction.

Drop your point of view long enough to take another way of seeing things.

Remember the point of communication is not to win or be right, but to either bring people together or clarify their differences.

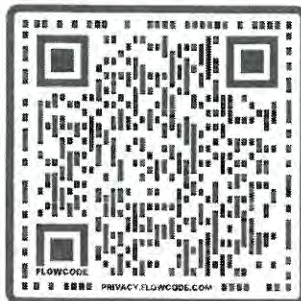

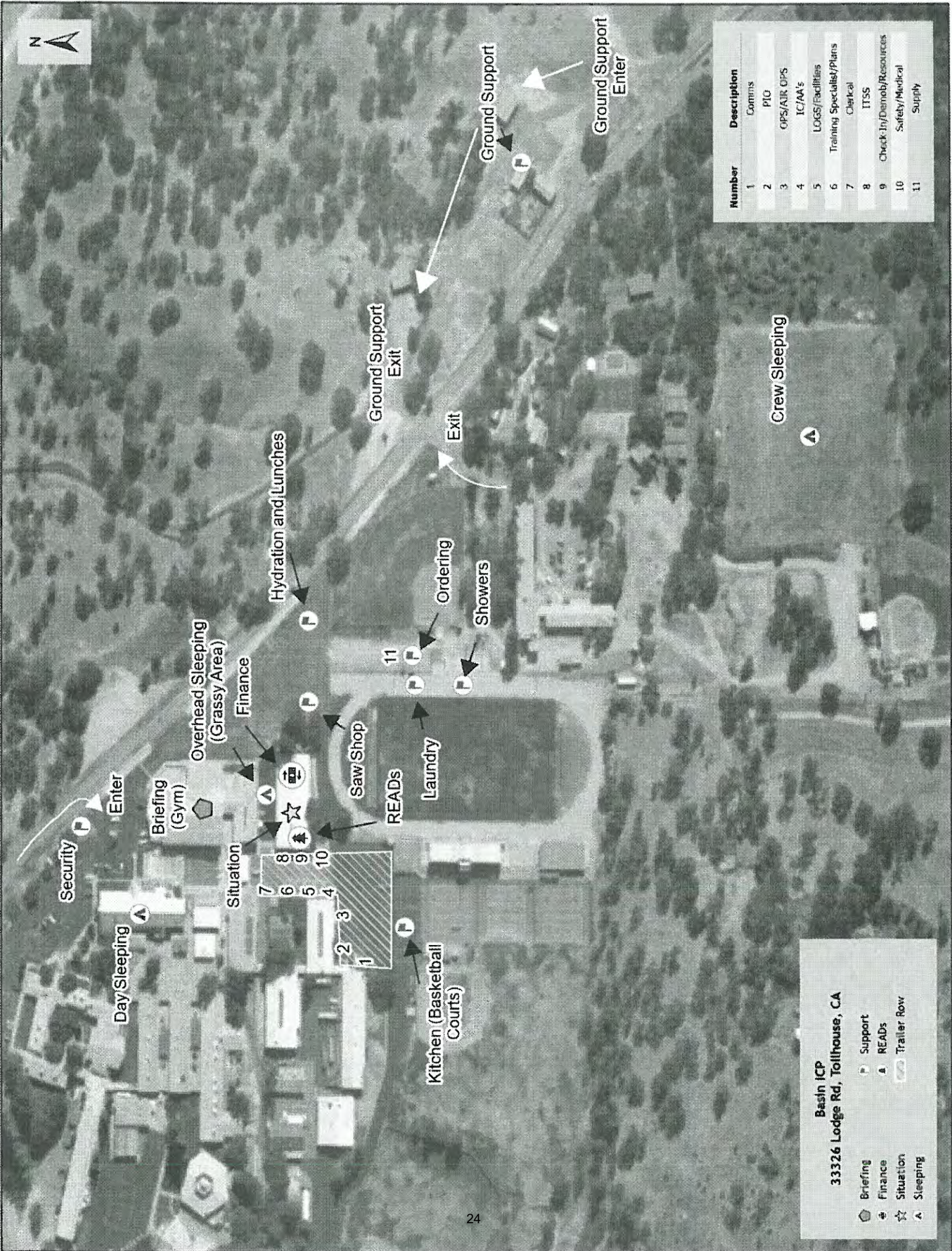

# Basin Incident DEMOB Procedures



In person check-out is being utilized on this incident. Monitor the IAP for the tentative DEMOB list. If there is an error on the dates, please communicate through your division or section to the check-in desk. They can then get the information verified and if needed, corrected.

Check out sheets will be available late afternoon on your last work day. Stop in at the DEMOB trailer to pick up your copy. Only get signatures from those sections that are highlighted.

1. All non-local resources will have at least 8 hours of rest prior to being released from the incident.
2. All resources will meet any agency-specific requirements on hours of travel per day or other travel restrictions.
3. Any heavy equipment operators or owners must have appropriate permits and follow any limitation on the movement of their equipment on public highways.
4. For an early release from the incident, prior to your last work day, an ICS 213 for the section must be submitted to DEMOB documenting an early release.
5. Emergency demobilization will be processed as quickly as possible. Individuals will be required to go through demobilization and checkout procedures. Demobilization and Resources Units will assure that manifests are changed as needed.
6. All resources needing airfare arranged will need to notify DEMOB 72 hours prior to the travel day.
