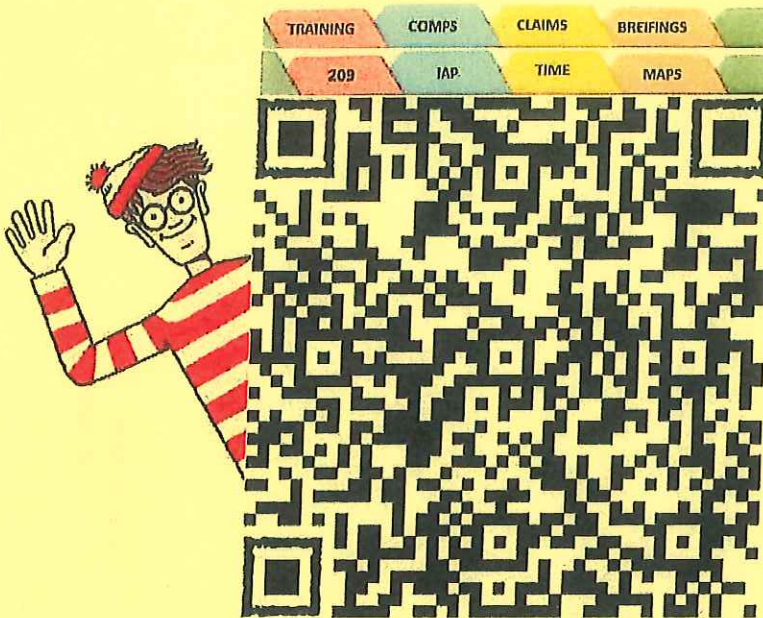



WEATHER DISCUSSION: Warmer and drier conditions are expected across the incident during the operational period. Maximum relative humidity will occur in the evening hours with the lowest values in the morning hours. Onshore/westerly winds will prevail through this evening, although speeds will be less than the last couple of days. Late in the operational period, ridgetop winds are expected to shift to a southeast to south direction.

The warming and drying trend will continue through the weekend with weaker wind speeds.

FIRE BEHAVIOR

GENERAL: The main fire progression will continue to the northeast towards Whitewater and has the potential to be in that drainage at the start of day shift To the west the fire will continue to be in a backing alignment. Expect active backing and flanking runs with short duration intense head fire runs as the main fire backs into drainage bottoms and aligns with slopes. Fire whirls and dust devils are probable on the lower slopes, the flats and at intersecting drainages. Make sure lookouts have a good view of the fire. When the winds pick up in the morning and the sky begins to clear, expect fire activity to increase.

At night, expect the fire to remain active as the peak RH occurs in the early evening then drops again, early in the morning.

With the dry fuels, spotting will be problematic. It should be short range less than 1/4mile and from rollout.

1000hr fuels are at 6%FM and are receptive to spots.

Probability of Ignition will be 80-90%.

Expect Flame lengths 1-4 feet in the grass, 4-25 feet in the brush.

SPECIFIC:

Branch I: Expect active flanking and backing fire on the south face of Yucaipa Ridge (Div F). The fire is holding at the top of Yucaipa Ridge and has the potential to start flanking west of Wilshire Peak. Any spotting would be from rollout but would back slowly into the Forest Falls drainage. Night crews need to continually assess down canyon winds.

Branch III: Minimal fire progression is expected in the northeast corner. What fire there is on the Branch is in sparse fuels and shows little potential for spread during the shift. Pockets of manzanita will readily burn and will be a source of visible smoke.

Branch V: Most of the Branch is at the head of the fire. The fire continues to flank along the west side of Millard Canyon. Expect active backing fire then intense uphill hill head runs as the fire crosses the north to south aligned drainages. The fire is burning laterally towards Whitewater and will continue this movement through the shift. If the fire crosses into Whitewater, expect wind driven head fire down the drainage.

Branch VII: No forward progression expected along the south side of the Branch.

AIR OPERATIONS: Smoke and fog will limit air operations until the inversion mixes out around 0900hrs.

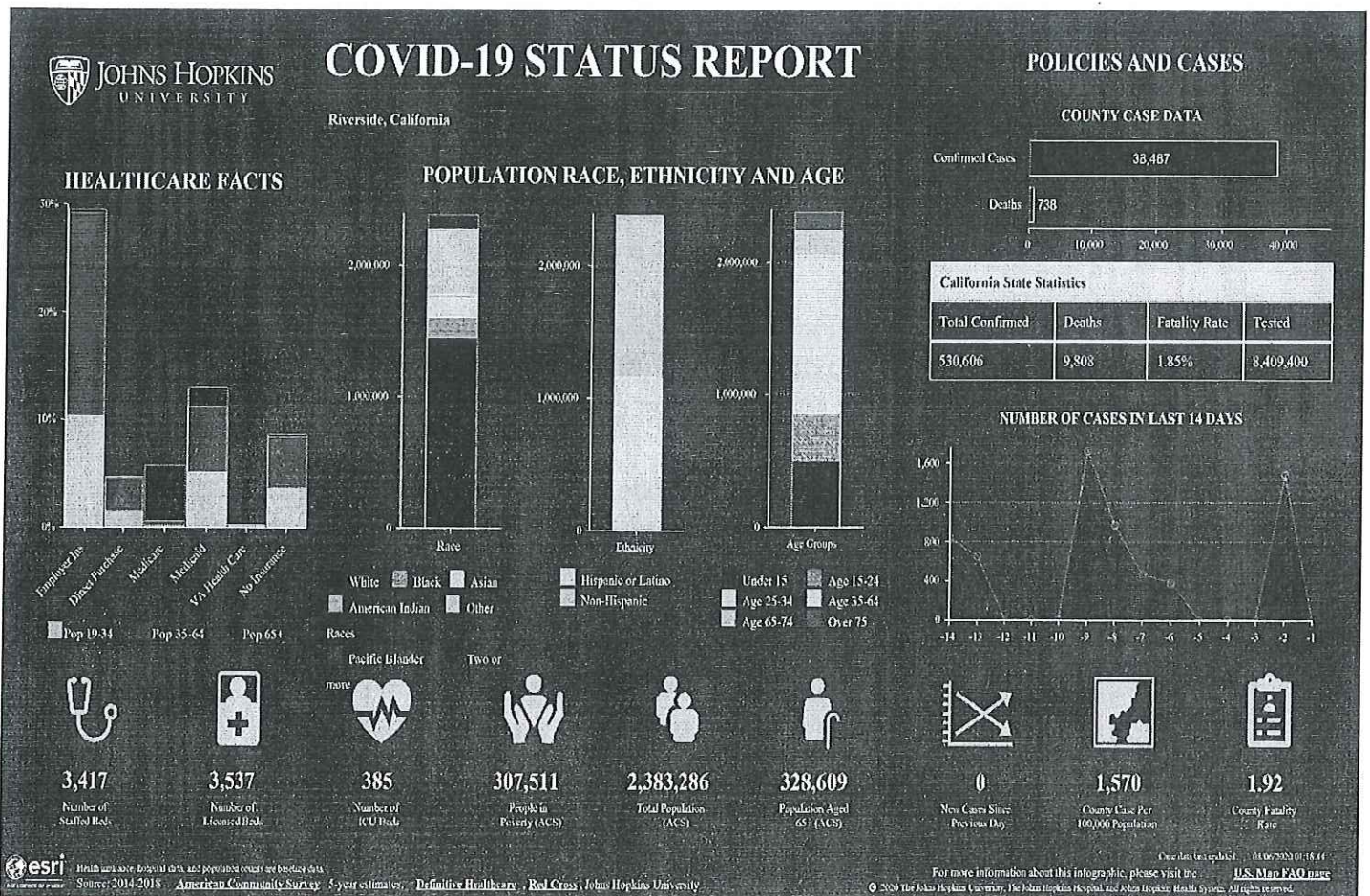
