MAP 03	If fire aggressively reaches MAP 3, strongly consider evacuation of Zone 3 from Oak Grove Bridge to Hwy 198.
MAP 04	If fire aggressively crosses the east fork of the Kaweah River and Mineral King Rd, strongly consider evacuation warning for Zones 4 and 5.
MAP 05	If fire aggressively crosses MAP 5, strongly consider evacuation order for Zones 3, 4, and 5.
MAP 06	If fire aggressively crosses MAP 6, suggest evacuation order for Zone 6.
MAP 07	If fire aggressively crosses MAP 7, suggest evacuation order for Zone 7.
MAP 08	If fire becomes established at Sick Rock, Zone 8 will take effect. (If fire crosses MAP 8 an evacuation for Zone 8 is suggested)
MAP 11	Place Kings Canyon National Park, Wilsonia, Grant Grove on Order.
MAP 12	If fire reaches MAP 12, suggest evacuation order for upper area of Zone 5 (North Fork).
MAP 13	If fire aggressively crosses North Fork River at MAP 13, suggest evacuation order for Eshom and Hartland communities.
MAP 14	Established fire at MAP 14 initiates Order for Hartland/Eshom Valley, Warning for Badger and Hogback Dr to County Line. Dispatch Structure Group Supervisor, TCFD, TCSO A-Reps, and Structure Defense Taskforce.
MAP 15	Dispatch structure defense taskforce Type II A crew and structure group supervisor include TCFD and TCSO A-Reps.
MAP 16	Order for Hogback and Community of Badger, Order four (4) strike teams of Engines Type II, III, or VI, Notify TCFD and TCSO A-Reps.
MAP 31	If fire crosses Panther Creek consider firing off from Crescent Meadow to Morrow Rock.
MAP 32	If fire crosses Silliman Creek consider taking direct/indirect strategies to limit growth further to the south and impacting Lodgepole. Take into consideration resource availability, current and expected fire behavior and time of year.
MAP 33	If fire crosses North Fork River, consider firing to keep fire south of Generals Highway and minimize impacts to Lost Grove.
MAP 34	Consider initiate firing to protect Redwood Mountain Grove.
MAP 35	If firing operation is initiated, place Wilsonia on Warning, Place Weston Meadows on Order.
MAP 36	If fire is established across primary line, place Wilsonia on Order.
MAP 37	If fire is anticipated to cross the MAP and move north or west towards Grant Grove Village, Operations will develop & activate a protection plan.
MAP 38	If fire is anticipated to cross Ten Mile Road and spread towards the community of Hume Lake, Operations will work with Cal Fire to develop a protection plan.
MAP 39	If fire is anticipated to cross Sentinel Ridge into Cedar Grove area & Hwy 180 corridor, Operations will work with local unit to develop & activate a protection plan.
MAP 40	If fire is anticipated to move east across the Middle Fork Kaweah River and Cliff Creek towards Lower Redwood Meadows Cabin & Bearpaw Ranger Station, Operations will develop and implement Protection Plan.
