## **FIRE BEHAVIOR FORECAST**

### **GENERAL FIRE BEHAVIOR:**

Expect the fire to become active earlier in the day by 1000hrs. Expect to see torching and continuous runs once the RH drops to 25%. Spot fires from roll outs will continue to challenge containment. The main fire progression will be to the Northeast where the fire has become established in the Alamar Canyon. In our Branch's the fire progression will be mainly by backing fire with short intense runs into the interior where wind, slope and fuels align. The fire will remain active through the night above 2500ft. Watch for dry down canyon winds during the night.

### **SPECIFIC:**

#### **Branch V**

- No forward fire progression expected. Watch for hold over heat on steep slopes.

#### **Branch VII**

- Expect backing fire with intense uphill runs back towards the interior, below Little Pine Mt.
- Spot fires from roll outs will continue to be a problem.
- The fire will back to the south in the Dick Smith, fire progression will slow in the Ogivly burn scar. There remains a potential for a strong down canyon push during the night.
- Rates of spread will exceed 100cph, with flame lengths 30-60-ft. in the brush.
- Interior islands will continue.

#### **Branch IX**

- The fire is not expected to impact the Branch during this forecast period.

**Air Operations:** Poor visibility earlier, then clearing by 0900hrs.

**FIVE HAZARDOUS ATTITUDES (This applies to all of us, not just pilots!)**

Flight out of Balance  
(two in a series of five)

**2 Impulsivity**

Some pilots feel the need to do something-anything-immediately when confronted with a choice of action. "I must act now - there's no time," they say to themselves. What makes this attitude hazardous is that these pilots usually do the first thing that enters their heads; in other words, they don't think. They don't take the time to select the best alternative.

Decisiveness is a positive attribute in a pilot, but making a decision in the absence of facts is a dangerous habit. "Plan your flight, then fly your plan," the military teaches its pilots. To fly safely, you must always have alternative courses of action in mind should something to wrong right *now*. (Sometimes this is mandated, as in alternate airport requirements under instrument flight rules.) Among other benefits, this reduces overall pilot workload.

Regardless of the swiftness of the onset of an unusual situation, it behooves the smart pilot to take a moment to analyze the situation, carefully consider the alternatives, and then make a decision based on the best possible course of action under the circumstances. It need not take more than a moment if the pilot has the right decision making attitude.

Antidote: When tempted to respond without thinking through a problem, remember "Not so fast. Think first."

**POISON OAK:** Poison Oak has become an issue with the crews coming off the line. The Los Padres has been known for their abundance and robust Poison Oak. Shower often when you can, see the laundry service often, and visit Medical Unit sooner than later for lotions and potions. Don't wait until the condition becomes severe to obtain help.

**CUMULATIVE FATIGUE:** A number of personnel are on their second or third tour of duty here on the Zaca. We need to continue to monitor their health and welfare. Keep hydrating and pace yourself by your distance. Adhere to the 2:1 work ratio. Fatigue can effect your decision making process.

**FIRE BEHAVIOR/WEATHER:** We are one again transitioning into a hotter and dryer weather pattern. These are the conditions which significantly contributed to the past large spread of this fire. Expect fire behavior to be very active and plan accordingly. Constantly observe weather and burning conditions and always have a contingency plan for any situation.

**INCIDENT TRANSPORTATION:** **Highway 154 is open.** Exercise care when entering and exiting highway. Remember the speed is 54 mph. Expect periods of heavy weekend traffic. Incident travel routes and travel distances can be long, and local residents continue to share the roads. Be alert for traffic, drive with your lights on, keep your speed down, and anticipate other drivers' actions. The camp speed limit is 5 mph.

**A firefighter with good situational awareness is a safe firefighter.**

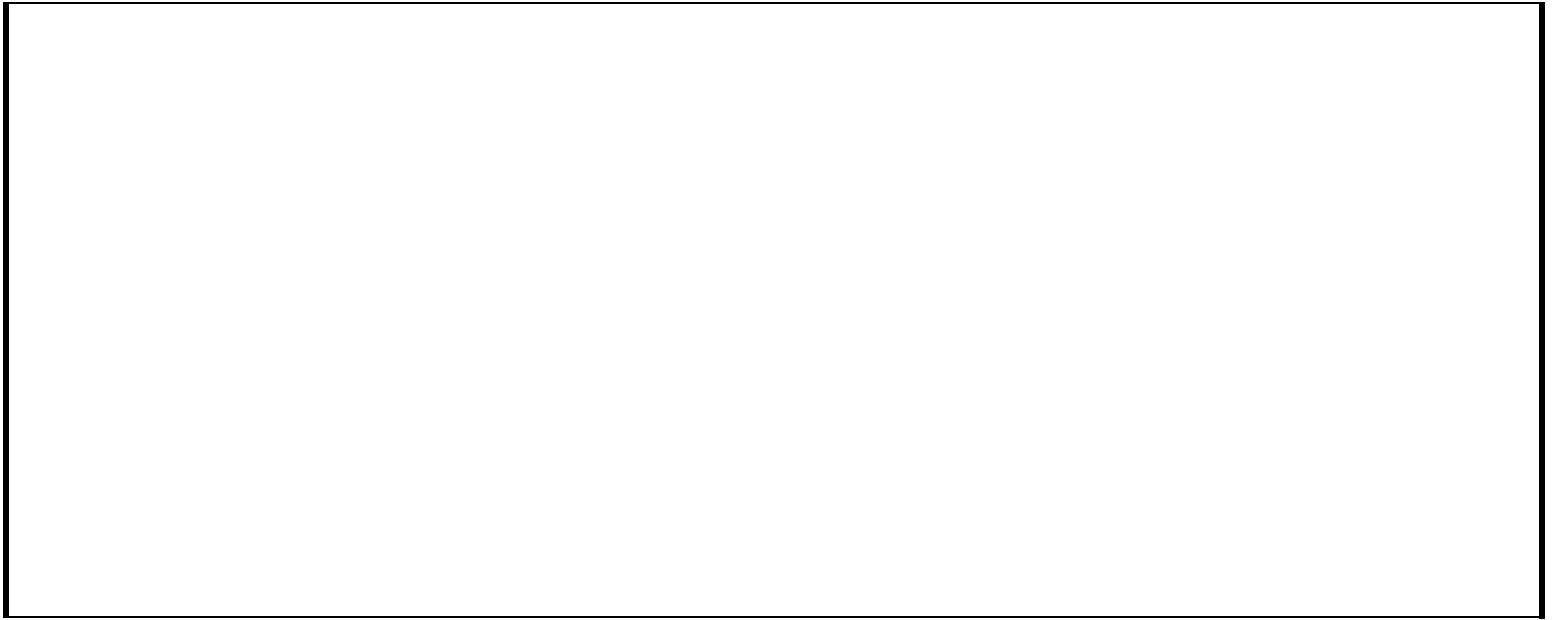
