Weather

Sunny

Temps around 95. RH:15%. Eye Level Wind: upslope up valley Westerly 6-10 mph with increasing gusts throughout the day reaching up to 15 mph .

Fire Behavior:

General:

The fire has been in-active near control lines. Hard work by crews and excellent mop up standards have maintained the current fire perimeter. Several deep interior islands continue to produce smokes in heavy down fuels and snags. Poor night recoveries have kept these smokes alive.

Live fuel moisture = 40%- 50%. **PBI**= 90%

Burn Index = 154 (OZENA). **Fire Danger Index**= *Extreme*

Burn Index = 87 (LOS PRIETOS) **Fire Danger Index**= *Very High*

Specific:

Interior Islands will continue to produce smoke in heavy fuels. With the Extreme Fire Danger Index today, an isolated headfire run may develop by early afternoon. Flame lengths of 30-50 feet can be anticipated. Fine fuels will be very receptive to sparks from mechanical heat sources.

Initial Attack (SITUATIONAL AWARENESS)

Head fire will not be conducive to direct attack. Safe engagement practices must be identified on the observed and predicted fire behavior. Any new starts will have a very high potential for large fire development.

Air Operations:

Regional activity may limit aircraft use.

Safety:

- **Observe the fire behavior for fire suppression engagement**
- **A new start may develop more abrupt than anticipated**
- **Identify a solid anchor point and safety zones.**
- **Situational Awareness needs to be a top priority= Safety**

WEATHER DISCUSSION:

The current trough of low pressure will keep the area cool for one more day however a much drier airmass is beginning to filter over the fire area thus rh's will be lower despite the cooler temperatures. Afternoon and evening winds will tend to be a little gustier for the next couple days as slightly stronger instability allows an increase in low level mixing.

COMMUNICATIONS UNIT (Richard Gonzales and Brent Stronge)

The Communications Unit Leader (COML) transitioned with the "Live Oaks" Zone COML on August 29, 2007. Equipment and personnel were in place and operating fine. An additional COMT and INCM were ordered to replace "Timing-Out" personnel.

On September 3, 2007, we transitioned with the "Richardson Zone" and assumed their equipment and personnel. Within both Zones, we had 9 Command Repeaters, 2 Aircraft Links and 2 Logistic Repeaters operating. Little to no adjustment was necessary during both transitions. Personnel and equipment requirements were met appropriately.
