RH will drop into the mid teens each afternoon. An inversion developing each night will keep ridgetops warmer and drier with poor overnight recoveries in the mid 30% range. Temperatures will remain 10-18 degrees above normal.</b></p> <p><b>A rise in temperature and a drop in relative humidity combined with record low fuel moisture values have the potential to increase fire activity.</b></p>

12 hours:	<p><b>Low to moderate fire behavior near the DIV B/C break in the timber stringers. Pockets of isolated heat are present throughout the southern half of the fire's footprint. The high afternoon temps and low relative humidity will cause single/group tree torching and short runs in interior pockets of grass and sage.</b></p>
24 hours:	<p><b>Same As Above</b></p>
48 hours:	<p><b>High pressure will continue to dominate over the area causing low daytime RH and poor overnight recoveries. Winds will also remain gusty on ridge tops.</b></p>
72 hours:	<p><b>An inversion each night will keep ridgetops warmer and drier with poor overnight recoveries. Poor recoveries will be followed by warm, dry afternoons that have the potential to support continued burning of available fuels.</b></p>
