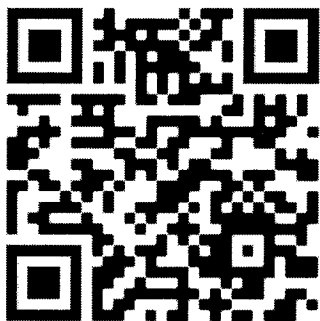

3. Objective(s):

Management Objectives

- Provide for firefighter and public safety through utilization of risk-informed strategies and tactics that yield the highest probability of success.
- Use available resources to contain fire spread utilizing direct, indirect, and natural barriers
- Minimize fire impacts to inholdings, infrastructure, natural and cultural resources, critical wildlife habitat, and riparian zones.
- Follow all COVID-19 guidelines specified by the Leaders Intent and Delegation of Authority, utilizing NWCG standards in operations. Implement measures to reduce exposure and transmission among fire personnel and the public.
- Ensure prompt and accurate communication that fosters discussion and encourages interaction with hosting agencies and partners.
- Focus public information actions to enhance relationships with landowners, cooperators and the public.
- All suppression damage will be identified with repair requirements.

Control Objectives

- Protect identified values at risk from unwanted fire impacts.
- Provide for structure protection at the Rock Creek Resort, Rock Creek Guard Station, Central Utah Water facilities, Central Utah Water compound, Upper Stillwater Campground, and Upper Stillwater Dam.
- Provide for structure protection for all structures in Lake Fork and Yellowstone drainages.
- Keep fire withing existing control lines from Yellowpine Campground to Petty Mountain.

General Situational Awareness:

- Steep and rugged terrain, critically dry and receptive fuel beds, active area for fire history and drought stressed trees.
- In the COVID-19 environment, high density populations or large groups are particularly at risk. To help protect yourself, your family and to ensure all employees return home safely, make sure to practice social distancing.
- Enhanced hygiene (especially handwashing), PPE & monitoring practices help limit the infection rate of first responders.



*****FIRE WEATHER WATCH IN EFFECT FOR SATURDAY AFTERNOON*****

WEATHER DISCUSSION: Another weak disturbance moved through overnight bringing with it some high clouds that will gradually thin and dissipate through today. More importantly, the RH has finally become respectable with recovery over 30% and even 40% in some drainages. Terrain driven winds this morning will become upslope at 6-10 mph with gusts in the teens and southwest flow at 6-10 mph with gusts near 18 mph on the ridges this afternoon.

WEATHER FORECAST FOR TODAY:

WEATHER: Mostly cloudy (60% cloud cover) this morning becoming partly cloudy (30% cloud cover) this afternoon. Areas of smoke in the drainages will dissipate between 1030 and 1200.
MAX TEMPERATURES (10kft): 57-61°F **MIN HUMIDITY (10kft):** 18-23% **HAINES:** 5 Moderate

20 FT WINDS:

RIDGETOP - Granddaddy Basin/Lake Fork Mountain - WNW 3-5 mph with gusts to 7 mph until 1100, SW at 6-10 mph with gusts to 18 mph in the afternoon.

SLOPE/VALLEY - West Fork Rock Creek - NW drainage winds at 3-6 mph with gusts to 10 mph until 1100 MDT, shifting to SSE at 6-9 mph with gusts to 16 mph. Upper Hells Canyon – NW drainage winds at 2-5 mph with gusts to 8 mph, shifting to SSE at 5-8 mph after 1100 MDT with gusts to 16 mph in the afternoon.

Inversion: Weak inversion due to cloud cover. Breaking between 1030 and 1130. **LAL:** 1

OUTLOOK FOR TONIGHT:

WEATHER: Mostly clear. Areas of dense smoke in Stillwater Res., Moon Lake, and light smoke in Hells Canyon.
MIN TEMPERATURES (10kft): 38-44°F **MAX HUMIDITY (10kft):** 44-50% **HAINES:** 4 Moderate

20 FT WINDS:

RIDGETOP - SW wind 6-9 mph with gusts near 15 mph in the evening then NW at 3-5 mph with gusts to 10 mph.

SLOPE/VALLEY - West Fork Rock Creek and Hells Canyon – Becoming down slope 3-6 mph with gusts to 8 mph in upper Hells Canyon and 4-7 mph with gusts to 12 mph in West Fork after 1900.

INVERSION: Thermal belt between 9000 ft. and 10,000 ft. **LAL:** 1

OUTLOOK FOR SATURDAY:

WEATHER: Moderately windy. Partly cloudy (30% cloud cover in the afternoon).
MAX TEMPERATURES (10kft): 55-58°F **MIN HUMIDITY (10kft):** 18-23% **HAINES:** 5 Moderate

20 FT WINDS:

RIDGETOP - SW wind 6-10 mph with gusts to 15 mph until 1100, then southerly at 10-15 mph with gusts 25-30 mph in the afternoon.

SLOPE/VALLEY - West Fork Rock Creek and Hells Canyon - Down drainage winds at 3-6 mph with gusts to 11 mph, then upslope at 7-11 mph with gusts to 24 mph in the afternoon.

INVERSION: Breaking between 1000 and 1030.

EXTENDED FORECAST: The strength of Sunday trough has weakened some but there will be a cold frontal passage Sunday morning along with gusty northwest winds, widespread snow above about 7500 ft., and temperatures 25-30 degrees colder than Saturday. Snow accumulations of 2-4 inches are expected over the Granddaddy Basin with 1 to 3 inches in the Stillwater Reservoir area and Lake Fork Mountain. Less than an inch of snow is expected down by Yellowstone spike camp.

Temps at ICP will be in the lower 50s Sunday with lows in the 20s Sunday night. Prepare accordingly!

INPUTS

WEATHER SUMMARY: ***See attached Fire Weather Forecast***

Discussion: Weak disturbance moved through overnight bringing some high clouds that will gradually dissipate today.

Weather: Mostly cloudy (60% cloud cover) this morning becoming partly cloudy (30% cloud cover) this afternoon.

Max Temp: 57-61°

Min RH: 18-23%

Winds (20 foot):

Ridgetop: WNW 3-5 mph gusts to 7 until 1100, then SW 6-10 mph gusts to 18 in the afternoon.

Slope/Valley: West Fk. Rock Creek NW drainage wind 3-6 mph gusts to 10 until 1100, then SSE 6-9 mph gusts 16.
Upper Hells Canyon NW drainage wind 2-5 mph gusts to 8, then SSE 5-8 gusts to 16 after 1100.

FIRE BEHAVIOR

GENERAL

The fire is burning primarily through mixed conifer stands with a shrub understory and timber/broadleaf stands with a litter understory. Many of these stands have an extremely high mortality rate with a 50% or more standing snag component.

Energy Release Component for the Ashley FDRA for 10/08 is 92, a record value for the date, and above the 97th percentile.

SPECIFIC FIRE BEHAVIOR

Mixed conifer stands with shrub understory: potential head rate of spread 10-20 chains per hour with flame length 6-10 feet. Expect single and group tree torching; occasional short- to moderate-duration crown runs are possible during the afternoon but confined primarily to the interior. Maximum spotting distance ¼-½ mile, Probability of Ignition 70%.

Nighttime: backing/flanking spread to 2-5 chains per hour. Expect torching and short-range spotting due to extremely dry conditions. Probability of Ignition 30-40%.

Timber/Broadleaf litter stands: rate of spread 4-6 chains per hour, flame length 2-3 feet.

Critical areas of concern:

Stillwater Reservoir area: fire will continue to spread toward the reservoir and dam and also westerly in the Granddaddy Basin.

Hells Canyon area: potential for spotting and becoming established on the east side of Hells Canyon.

SAFETY

Relative humidity is trending upward but record dry conditions still exist and ERC values are at record levels. Don't become complacent. Maintain situational awareness with regards to subtle changes in weather and fire behavior during the shift.


