Medical Incident Report

Ex: "Communications, Div. Alpha. Stand-by for Emergency Traffic."

- Cheatgrass and several other weed species are present in the area. Please wash vehicles after assignment. Car washes are available locally.
- Please do not remove or disturb artifacts and/or cultural sites. GPS and report.
- Keep Resource Advisors or Operations informed of any cows seen on the forest.
- ATV/UTVs are acceptable on trails and roads on BIA administered lands.
- Utilize designated water draft sites indicated with a W inside a circle on the map. Trash pumps are available at the sites.
- South Fork, Rock Creek and Hells Canyon Creek contain pure populations of native cutthroat. Please avoid introducing water from other sources into these creeks. Bucket work taking place in these drainages should avoid dropping directly into creek (at least 150' away).

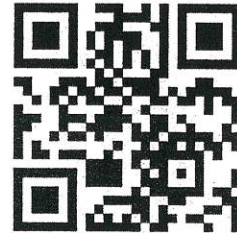

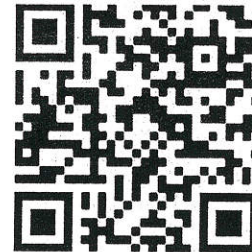
