

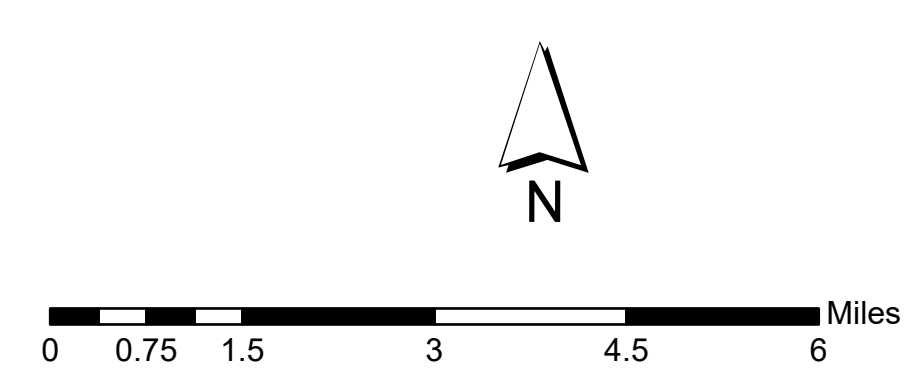
**MAP 5**  
 Activated: 07/10/2021  
 Conditions: If fire is anticipated to reach MAP 5 (Garden Creek) within 24hrs.  
 Action: Pending on current fire behavior and anticipated fire weather forecast, consider point protection of values at risk along Main Salmon River from Panther Creek to Middle Fork Complex.  
 Resources: T2 and T1 crews, engines, River Shuttles (transport across river), LEO, liaison for River & local landowners PIO & trapline.

**MAP 7**  
 Activated: 07/15/2021  
 Condition: If Fire becomes established beyond MAP 7  
 Actions: Re-Assess course of action. Consider initiation of structure assessments along the Salmon River Corridor and east of Panther Creek. Begin notification to Rangeland Management Specialist (Kyle Nelson) and Livestock permittees on the Williams Basin Napias Allotment (Dale Edwards). Consider notification of Diamond Moose grazing allotment Permittees.

**MAP 8**  
 Activated: 07/16/2021  
 Conditions: if fire reaches MAP 8  
 Actions: Initiate evacuations and prepare for firing operations.

**MAP 9**  
 Activated: 07/15/2021  
 Conditions: If fire reaches MAP 9  
 Actions: Notify backcountry hikers and campers. Consider plan implementation for back country evacuations. Ensure intrusion authorizations.
