Starting perimeters obtained from NIFS features service, pulled at around @2000 MDT September 15. No incident contact; posted products to NIFS and FTP only.

No change in heat perimeter acreage. There is a new scattered heat polygon in the northwest section of Heat Perimeter: southeast of Indian Point. Scattered heat still appears northeast of Deer Lake, although it is decreasing since the last flight on 20210911. There are also a few isolated heat signatures on the north near Gant Ridge (East of Indian Point) and Deer Lake.
