SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
PLEASANT GROVE RANGER DISTRICT

ROCK CANYON CAMPING AND CAMPFIRE CLOSURE

PROHIBITIONS:

Pursuant to 36 CFR 261.50 (a) and (b), **the following acts are prohibited** in the area as described in this order; all lands affected are located on the Pleasant Grove Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect until further notice.

1. **Camping within the Rock Canyon drainage and adjacent areas as described below and shown on attached map. [36 CFR 261.58(e)]**
2. **Building, maintaining, attending or using a campfire along the Rock Canyon Trail and drainage as described below and shown on attached map. [36 CFR 261.52(a)]**

EXEMPTIONS: Pursuant to 36 CFR 261.50 (e), the following persons are exempt from this Order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

AREA DESCRIBED:

Rock Canyon Trail located on the Pleasant Grove Ranger District, on the Uinta-Wasatch-Cache National Forest. The area includes all of the Rock Canyon drainage ½ mile east of the Rock Canyon Trailhead gate, and ¼ mile on the south side and ¼ mile on the north side of the drainage, excluding the private land as shown on the enclosed map, all within Township 6 North, Range 3 East, all of the southeast ¼ section of Section 29, Salt Lake Based Meridian.


PURPOSE:

To prevent resource damage from leaving numerous campfire and camping locations which leaves the areas compacted and void of vegetation and to protect the critical watershed along the Wasatch front.

IMPLEMENTATIONS:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the areas affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].
