

WEATHER DISCUSSION: Today will be sunny and cooler with much lighter ridgetop winds. The winds will be from an easterly direction today through tonight. A series of approaching weather systems will bring a chance of afternoon and evening showers and isolated thunderstorms Wednesday through Thursday. There is a better chance of showers Thursday, although the chance for wetting rains is relatively low as the showers are expected to be light.

FOR WOODS CREEK and BALSINGER FIRES:

WEATHER: Sunny and cooler with less wind.

TEMPERATURES: High 56 to 59 ridges (around 7,500 ft) to 63 to 67. Down 7-9 degrees.

HUMIDITY: Minimum around 30%. Up 4 to 7%.

COLD WEATHER PROCEDURES FOR ENGINES AND PUMPS

FREEZING TEMPERATURES MAY OCCUR ABOVE 8,000 FT ELEVATION

Follow these steps to prevent damage to the pump during cold weather and freezing events:

- 1. Remove discharge hose, suction hose, and priming cap.
- 2. Drain the pump by tilting the pump <u>several times</u> to remove as much water as possible from the pump head.
- 3. After the water has been drained, add 4-8 oz of RV Anti-Freeze to each pump head.
- 4. Leave discharge and suction hose disconnected until equipment is needed again.


