



MAP 4 N. Yaak Zone

Condition
MAP Description: Area where Eastside Road crosses Kibrennan Creek.
Intent: Trigger local coordination and communication with partners and entities for structure protection and evacuation planning.
Values at Risk: Private property and residences.
Trigger Condition: Fire progresses north of Yaak Mountain into private inholdings (North Yaak Zone). This area is directly adjacent to the primary containment line.
Probability: High

Actions
Notifications: Kootenai National Forest Agency Administrators and Fire Staff, Lincoln County Sheriff (Darren Short), Lincoln County Emergency Manager (Brent Teske), DNRC, Stimson Lumber, and/or private landowners.
Recommended Management Action: Execute reassessment strategy, pre-evacuation or evacuation to protect life, property, and other values at risk.
Mitigation Actions:
• Hazard fuels mitigation being completed on USFS land surrounding the private property.
• Point protection and/or coordinate with Emergency Manager and County Sheriff to implement structure protection and/or evacuation plans.

Resources
Additional resources required will be determined by operational personnel after consideration of current fire behavior and availability of resources at the time of MAP activation.

MAP 3 Yaak River Breach

Condition
MAP Description: Area west of Eastside Road and Yaak River.
Intent: Trigger local coordination and communication with partners and entities for structure protection and evacuation planning.
Values at Risk: Private timber land, private property and residences.
Trigger Condition: Fire establishes west of Eastside Road and Yaak River and is expected to spread activity to the west.
Probability: Low

Actions
Notifications: Kootenai National Forest Agency Administrators and Fire Staff, Lincoln County Sheriff (Darren Short), Lincoln County Emergency Manager (Brent Teske), and/or private landowners.
Recommended Management Action: Execute reassessment strategy, pre-evacuation or evacuation to protect life, property, and other values at risk.
Mitigation Actions: Activate reassessment measures and/or coordinate with Emergency Manager and County Sheriff to implement structure protection and/or evacuation plans.

Resources
Additional resources required will be determined by operational personnel after consideration of current fire behavior and availability of resources at the time of MAP activation.

MAP 2 West Yaak Zone

Condition
MAP Description: From the Eastside Road/Kibrennan Road intersection north to the Yaak River. A buffer zone just west of the Eastside Road.
Intent: Trigger local coordination and communication with partners and entities for structure protection and evacuation planning.
Values at Risk: Scattered private residences and private lands along the Highway 2 corridor. Powerlines.
Trigger Condition: Fire is projected to or has crossed west of the Eastside Road and is expected to continue sustained growth to the west.
Probability: Low

Actions
Notifications: Kootenai National Forest Agency Administrators and Fire Staff, Lincoln County Sheriff (Darren Short), Lincoln County Emergency Manager (Brent Teske), and/or private landowners.
Recommended Management Action: Execute reassessment strategy, pre-evacuation or evacuation to protect life, property, and other values at risk.
Mitigation Actions: Activate reassessment measures and/or coordinate with Emergency Manager and County Sheriff to implement structure protection and/or evacuation plans.

Resources
Additional resources required will be determined by operational personnel after consideration of current fire behavior and availability of resources at the time of MAP activation.

MAP 6 Yaak / Seventeen Mile

Condition
MAP Description: An area from the confluence of the Yaak River and Arbo Creek north to Seventeen Mile Creek then to the south east up Seventeen Mile Ck and including north slopes of Saddle Mt.
Intent: Initiate actions for protecting private property and structures in Seventeen Mile Creek area.
Values at Risk: National Forest resources and infrastructure; private land and structures in the Seventeen Mile Creek drainage.
Trigger Condition: Fire gets established in areas east and northeast of Saddle Mt and/or moving NE along the Yaak River and is expected to continue sustained growth in that direction.
Probability: High

Actions
Notifications: Kootenai National Forest Agency Administrators and Fire Staff, Lincoln County Sheriff (Darren Short), Lincoln County Emergency Manager (Brent Teske), DNRC, and/or private landowners.
Recommended Management Action: Execute reassessment strategy, pre-evacuation or evacuation to protect life, property, and other values at risk.
Mitigation Actions:
• Hazard fuels mitigation being completed on USFS land surrounding the private property.
• Point protection and/or coordinate with Emergency Manager and County Sheriff to implement structure protection and/or evacuation plans.
• Ensure area closures are in place to provide for public safety.

Resources
Additional resources required will be determined by operational personnel after consideration of current fire behavior and availability of resources at the time of MAP activation.

MAP 7 Skyline Mt to O'Brien Creek

Condition
MAP Description: An area between N. Fork O'Brien and O'Brien Creeks and north east past Skyline Mt to the Hemlock Creek Area.
Intent: Indicate a major change in the fire situation that would require reassessment and potential decision update to acknowledge potential for significant spread to the east.
Values at Risk: National Forest resources and infrastructure; Turner Mt Ski Area.
Trigger Condition: Fire gets established in areas east and southeast of N. Fork O'Brien Creek and is expected to continue sustained growth in that direction.
Probability: Moderate

Actions
Notifications: Kootenai National Forest Agency Administrators and Fire Staff.
Recommended Management Action: Adjust planning area, reassess strategies, and develop new MAPs as needed.
Mitigation Actions:
• Develop contingency actions in the O'Brien Creek drainage and assess the 752 Road for containment opportunities.
• Conduct hazard fuel reductions activities along roadways and/or around values to provide protection as needed.

Additional resources required will be determined by operational personnel after consideration of current fire behavior and availability of resources at the time of MAP activation.

MAP 1 Rabbit Creek Zone

Condition
MAP Description: Area south of Kibrennan Lake Road that ignores the road corridor.
Intent: Trigger local coordination and communication with partners and entities for structure protection and evacuation planning.
Values at Risk: Private timber land, private property and residences within the Rabbit Creek structure protection zone; powerlines; infrastructure.
Trigger Condition: Fire has crossed or is projected to cross south of Kibrennan Lake Road within 24 hours and is expected to continue sustained growth to the south.
Probability: Moderate

Actions
Notifications: Kootenai National Forest Agency Administrators and Fire Staff, Lincoln County Sheriff (Darren Short), Lincoln County Emergency Manager (Brent Teske), DNRC, Stimson Lumber, and/or private landowners.
Recommended Management Action: Execute reassessment strategy, pre-evacuation or evacuation to protect life, property, and other values at risk.
Mitigation Actions: Activate reassessment measures and/or coordinate with Emergency Manager and County Sheriff to implement structure protection and/or evacuation plans.
