

MAP 1 Mt Hefty Comm Site
 Values at Risk: Border Patrol Communication Site
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting. The forecast predicts a high-pressure ridge breaking down with strong SW, W, or NW winds.
 Actions: Based on predicted weather and fire behavior, elevate preparation for point protection and defensive actions. Determine aviation and ground resource availability. Develop structure protection plans and logistical support in coordination with the border patrol.

MAP 2 Tuchuck
 Values at Risk: Tuchuck Campground
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting. Forecast predicts a high-pressure ridge breaking down with strong W and N winds.
 Actions: Based on predicted weather and fire behavior, elevate preparation for point protection and defensive actions. Determine aviation and ground resources availability and assess allocation strategies. Coordinate a structure protection plan, resources needed, and logistical support. (A contractor is anticipated to begin working on the Trail Creek 114 Road on 8/22/22. The road will be undrivable from the East when that work begins).

MAP 3 Thoma Lookout
 Values at Risk: Thoma Lookout
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting. Forecast predicts a high-pressure ridge that has been established breaking down with strong W or N winds.
 Actions: Consider evacuating the lookout. Determine aviation and ground resource availability and assess strategies. Coordinate a structure protection plan, resources needed, and logistical support.

MAP 4 Thoma Whitebark
 Values at Risk: Thoma Whitebark Stand
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting. If weather and fire behavior opportunities become available implement a pre-developed prescription for the whitebark stand.
 Actions: Consider aerial ignitions with rotor wing (day operations) or the UAS platform (day/night). This would be to minimize high severity fire impacts to the stand. Attain a prescription for low-intensity fire in whitebark and develop a plan for implementation.

MAP 5 Weasel Cabin
 Values at Risk: Weasel Cabin
 Trigger Condition: Fire becomes active and enters the MAP area.
 Actions: Turn on the sprinkler system around the cabin. Consider the need for ignitions to protect the cabin if safe egress is available. The fire is currently creating a solid black perimeter around the cabin.

MAP 6 Foundation Whitebark
 Values at Risk: Foundation Whitebark Pine Stand
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting.
 Actions: To minimize high severity fire impacts to the stand consider ignitions at the top of the stand to initiate backing fire. Consider aerial ignition with UAS (day/night) or rotor wing. Develop an ignition plan and allocate a burn boss to coordinate the implementation of a predetermined whitebark stand prescription if possible.

MAP 7 Grave SnoTel
 Values at Risk: Grave Creek SnoTel
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting.
 Actions: Based on predicted weather and fire behavior, elevate preparation for point protection and defensive actions. Determine ground resource needs and availability. Develop structure protection plan and logistical support. Consider having a cache of structure protection wrap and sprinkler kits with pumps and hose available. (These actions apply to MAP's 8, 10, 12, & 14.)

MAP 8 Blue Sky
 Values at Risk: Blue Sky Trailhead
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting.
 Actions: Same as MAP 7

MAP 8 Blue Sky
 Values at Risk: Blue Sky Trailhead
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting.
 Actions: Same as MAP 7

MAP 9 Wam Lookout
 Values at Risk: Mt Wam Lookout
 Trigger Condition: Fire crosses the MAP through surface fire spread or long-range spotting.
 Actions: The lookout has been wrapped as of 08/05/22. Consider aerial ignition with UAS (day/night) or rotor to initiate backing fire down the slope. Ignition activities would be to reduce the potential for extreme fire behavior moving aggressively upslope and impacting the lookout.

MAP 10 Stahl SnoTel and MAP 10a Clarence and Stahl SnoTel
 Values at Risk: Stahl SnoTel and Clarence Campground
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting.
 Actions: Same as MAP 7

MAP 11 Stahl Lookout
 Values at Risk: Stahl Lookout
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting.
 Actions: Based on predicted weather and fire behavior, elevate preparation for point protection and defensive actions. Determine aviation and personnel availability. Develop structure protection plans and logistical support. Consider having a cache of structure protection wrap available to wrap the lookout. Consider aerial ignition planning with UAS (day/night) or rotor wing. The intent would be to initiate backing fire moving down the slope to reduce the potential for extreme fire behavior moving aggressively upslope and impacting the lookout.

MAP 12 Ten Lakes
 Values at Risk: Ten Lakes Campgrounds and Infrastructure
 Trigger Condition: Fire crosses or is anticipated to cross the MAP through surface fire spread or long-range spotting.
 Actions: Same as MAP 7

MAP 13 Wolverine
 Values at Risk: Wolverine Cabin and Bridges
 Trigger Condition: Fire is crosses or anticipated to cross the MAP through surface fire spread or long-range spotting.
 Actions: Based on predicted weather and fire behavior, elevate preparation for point protection and defensive actions. Determine aviation and ground resource availability. Develop structure protection plans and logistical support. Consider ignitions to reduce the potential for extreme fire behavior impacting the cabin. Egress considerations will need to be reviewed. Egress may be compromised due to extended hiking times to the cabin and back to the Wolverine trailhead.

MAP 14 Clarence - Rich
 Values at Risk: Clarence - Rich Trailhead
 Trigger Condition: Fire is anticipated to cross the MAP through surface fire spread or long-range spotting.
 Actions: Same as MAP 7
