#1	If fire reaches this point.	Develop a structure protection plan for McGuire Mt. Lookout. Consider wrapping structure. Notify renters of situation.	
#2	If fire crosses Pinkham Cr.	Re-evaluate trail closures between Sutton Mt./Lydia Mt./Cooks Run (Trail 800).	
#3	If fire reaches this line.	Begin pre-evacuations for Meadow Cr.	Lincoln County Sheriff Dept., Lincoln County Emergency Services., LEOs
#4	If fire reaches this line.	Pre-evacuations for Swamp Creek area.	Lincoln County Sheriff Dept., Lincoln County Emergency Services., LEO's
#5	If fire is expected to cross the 5381 Road with a rate of spread that the Edna Creek homes are threatened.	Coordinate Stage "Go" with County Sheriff to evacuate all residences	Lincoln County Sheriff Dept., Lincoln County Emergency Services., USFS LEO's and/or Incident personnel or TFS Fire Dept.
#6	Fire is expected to cross the 433 and southern 1900 roads with a rate of spread that expected future movement would continue to the north.	With the County Sheriff initiate Stage "Set" for the Lower Pinkham Creek residences and the Upper Meadow Creek residences.	County Sheriff, Border Patrol, USFS LEOs and Incident personnel.
