Overview:

Today we split into our three teams, Quartzville, Mary’s Peak and North Santiam to focus on reconnaissance of the areas for strategic material placement, meeting partners and agency representatives and material distribution. Driving safety is a top priority.

Product Delivery:

- **North Santiam Corridor:**
 - Posted over 15 “No Fires” signs at strategic locations within the BLM Fisherman’s Bend Recreation Site.
 - Distributed “Keep Oregon Green/Prevent Wildfires” placemats to the Sierra Restaurant in Gates.
 - Distributed two Banner Bug displays, and various communication materials to the Detroit Ranger Station.

- **Mary’s Peak:**
 - Delivered materials to the William Finley National Wildlife Refuge Office for strategic placement.
 - Posted Eclipse graphic signs at Mary’s Peak and Connor’s Camp bulletin boards.

- **Quartzville Corridor:**
 - Emailed four approved “Smoke Management” images and one “Drone No Fly” image to Willamette NF and Siuslaw Public Affairs Officers and NW Oregon BLM District Public Affairs Officer for social media use.
 - Placed Banner Bug display at Sweet Home Ranger Station.

- **North Santiam Corridor:**

- Coordinated with White Water Incident PIOs stationed at Detroit Ranger Station on Eclipse messaging and materials.
- Coordinated with Acting Detroit District Ranger to integrate Prevention and Education Team efforts into the District Eclipse IAP.
- Briefed PNW Deputy Regional Forester Becki Heath on NW Oregon Fire Prevention and Education Team Strategy.

- **Mary's Peak:**

- Participated in the Siuslaw NF final Eclipse planning meeting.
