

Incident: CARPENTER ROAD

Fire behavior continues in a cyclical pattern resulting in torching, crowning, uphill runs with 1/4 - 1/2 mile spotting. Terrain driven winds have resulted in fire whirls & dust devils. Fire continues to burn actively throughout the night in a thermal belt with torching, crowning, uphill runs, rapid rates of spread. Extreme fire behavior observed during the afternoon hours with moderate spotting distances.

36. Projected Incident Activity, Potential, Movement, Escalation, or Spread and influencing factors during the next operational period and in 12-, 24-, 48-, and 72-hour time frames:

12 hours: **Spread to the NE continues due to spotting and extreme fire behavior. Spread to the south and east at the south end will again occur with slow recovery overnight.**

24 hours: **Increased spreading to north and east due to expected weather event and alignment due to topography. High value timber resources will continue to be lost. Infrastructure threatened includes power lines, threatened and endangered species, archeological, historical, cultural and recreational values. It is anticipated the fire will to spread to the east / southeast after the passage of an frontal system. Lack of resources continue to influence outlying operational periods.**

The Full Suppression strategic objectives are being developed currently as part of an All Hazard Strategy and containment plan for the NE side of the fire, as well as an All Hazard Map with management action points and contingencies.

150 structures located north and NE of the fire continue to be threatened without critical resources. Fire is continuing to back towards 250 structures near McCoy Lake. Minimal structure protection resources available.

Due to national fire PL-5, resources identified above are in short supply, coupled with the anticipated weather 24 hours and beyond can result in significant fire spread threatening 400 structures.
