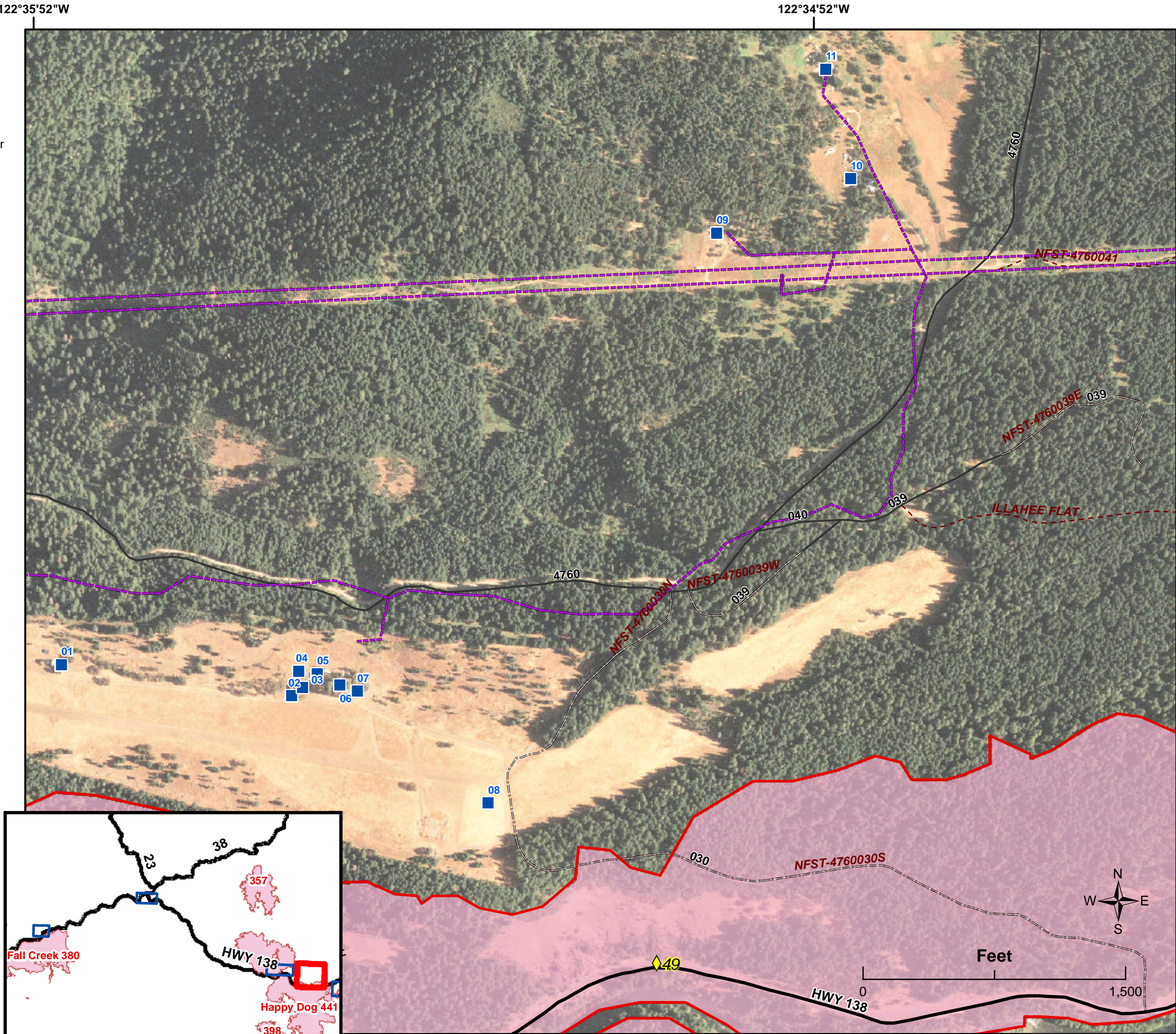
Number	Notes
1	Resources would either have to complete prep work and leave before fire impacts area or stay in safety zone. Access road very steep and narrow, only smaller vehicles (type 6) should attempt access. Clear grass and brush away from structures plumb with sprinklers, leave area prior to fire arrival.

3	Patroll area, suppress spot fire, if structure becomes involved protect adjacent structures
4	Remove needle accumulations from gutters of structure, clear ground and overhanging fuels away
