DISCUSSION... An upper ridge pattern will develop on Tuesday which will result in warmer temperatures and RH's a little lower. Then a dry cold front will move across the area on Wednesday which will bring back cooler temperatures and higher RH's with also increasing winds late Wednesday and Wednesday evening. After that a west to northwest flow will persist through Friday with even cooler temperatures. By the weekend an atmospheric river will set up and possibly bring wetting rains to the area beginning Friday night into the weekend, along with cooler temperatures and high RH's. Conditions during the weekend will become mostly wet and raw.


